Report of the Second Committee (Part I)*

I. INTRODUCTION

1. At its 3rd plenary meeting, on 23 September 1994, the General Assembly, on the recommendation of the General Committee, decided to include in its agenda the item entitled:

"Environment and sustainable development:

- (a) Implementation of decisions and recommendations of the United Nations Conference on Environment and Development;
- (b) Protection of global climate for present and future generations of mankind;
- (c) Sustainable use and conservation of the marine living resources of the high seas: United Nations Conference on Straddling Fish Stocks and Highly Migratory Fish Stocks;
- (d) Elaboration of an international convention to combat desertification in those countries experiencing serious drought and/or desertification, particularly in Africa;

(e) Global Conference on the Sustainable Development of Small Island Developing States"

and to allocate it to the Second Committee.

- 2. At its 30th plenary meeting, on 13 October, following a request by the Chairman of the Second Committee (see A/49/483 and A/49/494), the General Assembly decided that, while action on sub-items (d) and (e) would be taken in the Second Committee, the debate on those sub-items would be held directly in plenary meeting.
- 3. The Second Committee held a general discussion on the item at its 13th to 16th meetings, from 19 to 21 October 1994. An account of the Committee's discussion of the item is contained in the relevant summary records (A/C.2/49/SR.13-16). Attention is also drawn to the general debate held by the Committee at its 3rd to 8th meetings, on 7 and from 11 to 13 October (see A/C.2/49/SR.3-8). An account of the Committee's further consideration of the item will be given in addenda to the present report.
