PROGRAMME BUDGET FOR THE BIENNIUM 1994-1995

<u>Contingency fund: consolidated statement of programme</u> budget implications and revised estimates

Report of the Secretary-General

- 1. The consolidated statement of programme budget implications and revised estimates falling under the guidelines for the contingency fund contained in the annex to resolution 42/211 of 21 December 1987 is herewith submitted. It amounts to \$14,681,300, as detailed in the annex to the present report. The amounts contained in respect of each item correspond to those previously recommended by the Fifth Committee upon its consideration of individual statements and proposals for revised estimates.
- 2. The balance of the contingency fund for the biennium 1994-1995, as indicated in resolution 48/230 of 23 December 1993, is \$16,044,100. The consolidated amount of \$14,681,300 is within the available balance of the contingency fund. The Fifth Committee, in accordance with paragraph 5 of the annex to resolution 42/211 can proceed to recommend to the Assembly the appropriation of the required amounts under the relevant sections of the programme budget, as follows:
