OF ARGENTINA TO THE UNITED NATIONS ADDRESSED TO THE

Decree of 12 July 1993 on sanctions against Haiti

In view of the fact that the Argentine Republic is an original Member of the United Nations, and

Considering:

That before the interruption of the democratic regime in the Republic of Haiti, the National Executive Power approved, by Decree No. 2186 of 21 October 1991, resolutions MRE/RES.1/91 and MRE/RES.2/91 of 3 and 8 October 1991 respectively, adopted within the ambit of the Organization of American States;

That it is a fundamental purpose of the United Nations to maintain international peace and security and to take the effective collective measures necessary for the prevention and removal of threats to the peace;

That the Security Council is the organ competent to decide what measures are appropriate for that purpose, in accordance with Chapter VII of the Charter of the United Nations;

That the Members of the United Nations must accept and carry out the decisions of the Security Council, assisting it in the actions it undertakes in accordance with the Charter;

That in the exercise of such powers the Security Council adopted resolution 841 (1993) of 16 June 1993, recognizing the urgent need for an early, comprehensive and peaceful settlement of the crisis in the Republic of Haiti in accordance with the provisions of the Charter and international law;

That the present measure is enacted in exercise of the powers derived from article 86, paragraphs 1 and 2, of the National Constitution;

Therefore,

THE PRESIDENT OF THE ARGENTINE NATION
DECREES:

Article 1. Resolution 841 (1993), adopted by the Security Council of the United Nations on 16 June 1993 and annexed to this Decree, is hereby approved.

Article 2. The National Executive Power and the divisions and public agencies of the State, the provinces and the municipalities shall adopt within their respective jurisdictions such measures as are required to implement the decisions contained in the resolution approved in the preceding article.

Article 3. This Decree shall be promulgated, published, transmitted to the National Department of the Registro Oficial and placed in the archives.
