- 16.1 The terms of reference of the Economic and Social Commission for Asia and the Pacific (ESCAP) were established by Economic and Social Council resolution 37 (IV) and subsequent amendments. ESCAP headquarters is located at Bangkok and the ESCAP Pacific Operations Centre (EPOC) is located in Vanuatu.
- The changing circumstances and priorities of the region and, in particular, the process of transition of several centrally planned economies in the region to a market economy, including the newly independent Central Asian republics, some of which have become members of the Commission, have presented ESCAP with new responsibilities. At the same time, the presence in the region of countries at varying stages of development, including some which have experienced a rapid growth momentum in recent years, has reaffirmed the need to strengthen regional cooperation. The challenges of the changing socio-economic and political environment have required ESCAP to place greater emphasis on providing new policy options and appropriate national, subregional and regional strategies. ESCAP's activities during the 1994-1995

biennium will focus on data collection, research and analysis for the purpose of providing a more informed understanding of the problems and emerging issues facing the countries in the region and of enhancing regional economic cooperation.

- The proposed programme budget is derived from programme 31 of the medium-term plan for the period 1992-1997, as revised (A/47/6/Rev.1), which has been reorganized to reflect the thematic approach recommended by the Commission. The Commission considered that a thematic approach, with the resulting streamlining of its subsidiary bodies, would emphasize regional economic cooperation and the interdisciplinary nature of the economic and social issues being addressed and would provide ESCAP with a more comprehensive and coordinated approach in the timely implementation of its activities, as well as facilitate a more effective use of resources.
- 16.4 In implementing its programme of work, ESCAP will continue to coordinate and cooperate with relevant entities of the United Nations system; joint activities will continue, as well as collaboration with intergovernmental and non-governmental organizations.
- 16.5 The estimated percentage distribution of the total resources of ESCAP in 1994-1995 would be as follows:

The Commission, which meets annually, provides overall direction to the work of the secretariat. Its subsidiary bodies are: the Committee on Regional Economic Cooperation (annual); the Committee on Environment and Sustainable Development (annual); the Committee on Poverty Alleviation through Economic Growth and Social Development (annual); the Committee on Statistics (biennial); the Committee on Transport and Communications (annual); the Special Body on Least Developed and Land-locked Developing Countries (biennial); and the Special Body on Pacific Island Developing Countries (annual). The Commission reports to the Economic and Social Council. In addition, an Advisory Committee of Permanent Representatives and Other Representatives Designated by Members of the Committee, which meets on a monthly basis, provides a consultative link between the secretariat of ESCAP and the members and associate members of the Commission. ESCAP provides substantive and technical services to the Commission and its subsidiary bodies, and to other intergovernmental bodies and ministerial meetings.

Resource requirements (at current rates)

Staff costs

16.8 The estimated requirements for temporary assistance for meetings amount to \$328,100 which includes an increase of \$140,200 to provide for interpretation and translation services, for meetings of the Commission and its subsidiary bodies, as well as for other regional meetings, including those related to global conferences. The resource growth is proposed taking into account past experience and projected requirements for conference servicing.

Contractual services

16.9 The estimated requirements for contractual editing, language typists and clerks required for documentation presented to the intergovernmental bodies would amount to \$77,400.

General operating expenses

16.10 An amount of \$17,800 is requested for short-term rental of furniture and equipment during the holding of the Commission sessions and its subsidiary bodies, and for communications, hospitality, and miscellaneous services related to those meetings. This reflects a decrease of \$33,800 which will be applied to expenditures under programme support.

Supplies and materials

16.11 The amount of \$24,100 is requested for supplies and materials required for the holding of the Commission sessions and meetings of the intergovernmental bodies.

16.12 The Office of the Executive Secretary provides overall direction, supervision and management of ESCAP with a view to promoting economic and social development and regional cooperation among the members and associate members of the Commission through the implementation of its legislative mandates and its approved work programme.

Resource requirements (at current rates)

Staff costs

Twelve posts (2 D-1, 1 P-5, 1 P-4, 2 P-3, 2 P-2 and 4 local level) are proposed for redeployment as follows: one D-1 to subprogramme 6 (Least developed, land-locked and island developing countries); one P-5 to subprogramme 1 (Regional economic cooperation) for activities related to development issues and policies; and 1 D-1, 1 P-5, 1 P-4, 2 P-3, 1 P-2 and 4 local level staff to programme support for programme coordination and monitoring.

Consultants and experts

16.14 An amount of \$25,600 is estimated for expertise in the overview of new and emerging issues being addressed by the Commission.

Travel on official business

16.15 The estimated requirements would amount to \$145,900 for attendance by the Executive Secretary and his staff at meetings within and outside the region, for consultations with Governments, intergovernmental and non-governmental organizations and for coordination with other United Nations entities. These requirements reflect a decrease of \$48,400 redeployed as appropriate to those subprogrammes receiving the redeployed posts.

Programme of work 1

- 16.16 Programme 31 (Regional cooperation for development in Asia and the Pacific), of the medium-term plan for the period 1992-1997 as revised (A/47/6), adopted by the General Assembly in its resolution 47/214, provides the framework for the activities to be undertaken by ESCAP during the biennium 1994-1995. Those activities are described under six subprogrammes, and while subprogrammes 1 to 3 are entirely new, reflecting the thematic approach adopted by the Commission, subprogrammes 4 to 6 are, with some revisions, the continuation of existing subprogrammes.
- 16.17 The programme of work has been reoriented to meet the thematic approach recommended by the Commission, with an emphasis on regional economic cooperation and the interdisciplinary nature of the economic and social issues. In view of the drastic political and economic changes in the region, the activities requiring the most urgent attention are those of data collection, research and analysis for the purpose of providing a more informed understanding of the problems facing the countries in the region. It is also in these areas of work that assistance has been most requested by countries with disadvantaged economies as well as by those with centrally planned economies in the process of transition to a market economy.
- 16.18 The programme performance report for the biennium 1990-1991 showed that ESCAP implemented 76 per cent of all outputs as programmed plus reformulations plus outputs added by legislation; the rate of implementation of high priority outputs as programmed, plus reformulations plus outputs added by legislation, was 80 per cent.

Resource requirements (at current rates)

Staff costs

16.19 It is proposed to redeploy to the substantive activities covered in the ESCAP programme of work one D-1 and one P-5 from Executive direction and management and one D-1 and one P-2 from programme support; it is also proposed

to redeploy from substantive activities two P-3s to programme support. Together with one temporary post at the P-3 level, the total number of posts for the implementation of the ESCAP programme of work would be 114 Professional and 85 local level staff under the regular budget.

Consultants and experts

16.20 The estimated requirements for consultants (\$272,900) and experts (\$248,700) would amount to \$521,600. This includes increases of: \$40,000 for ad hoc expert groups activities related to international trade and development finance (within subprogramme 1), human resources development (within subprogramme 3) and transport and communications (subprogramme 4) for which there was no provision made for ad hoc expert groups during the 1992-1993 biennium; non-recurrent amounts of \$10,000 for consultants to provide expertise in the preparatory work for the World Conference on Women; and \$40,000 for two ad hoc expert group meetings related to that Conference are proposed. After deducting the non-recurrent amount of \$7,400 for activities related to the World Conference on Women carried out in 1992-1993, the net increase in requirements for consultants and experts would amount to \$82,600.

Travel on official business

16.21 The estimated requirements for travel on official business would amount to \$504,300 for data collection, consultations and participation in meetings within and outside the region. These requirements include increases of: \$45,000 in light of the vast area covered by the increased membership and the need to attend meetings of the newly established Commission on Sustainable Development; a non-recurrent provision of \$50,000 for travel to the six major conferences and their preparatory committees, as appropriate (population, small island developing States, social development, Habitat, women and crime prevention); and \$25,000 redeployed from Executive direction and management to subprogramme 6 (Least developed, land-locked and island developing countries).

Contractual services

16.22 The estimated requirements for contractual services relate to external printing and binding costs and would amount to \$266,500.

Subprogramme 1. Regional economic cooperation

This subprogramme comprises those activities that had previously been carried out in 1992-1993 under subprogramme 2 (Development issues and policies), subprogramme 7 (Industrial and technological development) and subprogramme 8 (International trade and development finance). The proposed activities for 1994-1995 will focus on the ongoing structural changes and policy reforms in the economies which are likely to further strengthen trade, investment and technology linkages in the region. The immediate goals of the activities are to develop an appropriate policy environment and to create and strengthen institutional capacities and skills at the regional, subregional and national levels, and to enable countries to exploit more fully the increasing opportunities for intraregional trade and investment. The work programme includes a convergent and concerted set of research and operational activities which will address key issues, such as macroeconomic policies, economic restructuring, market access and trade promotion, trade in services, technology development and transfer, investment flows, joint ventures and development finance, and cooperation among subregional groups.

16.24 The work will be carried out under the guidance of the Committee for Regional Economic Cooperation, which meets annually, as well as its Steering Group. ESCAP will also provide substantive services to a number of intergovernmental meetings convened to consider commodities cooperative arrangements in silk, jute, tropical timber and coffee as well as to the Intergovernmental Meeting on the Development of a Regional Investment Information and Promotion Service for Asia and the Pacific (RIIPS) in 1994.

Activities:

16.25 The redeployment of one P-5 from Executive direction and management and one P-2 from Programme support to this subprogramme is proposed for activities related to development issues and policies and international trade and development finance, respectively; one P-3 is proposed for redeployment from this subprogramme to subprogramme 4 (Transport and communications); and one P-4 post is proposed for redeployment to Programme support, respectively. for activities related to programme coordination and monitoring and management of technical cooperation.

Consultants and experts

16.26 The estimated requirements would amount to \$181,100 for consultants (\$107,600) and five ad hoc expert groups mentioned above (\$73,500). The proposed increase of \$15,000 relates to resources required for the convening of the ad hoc expert group on inter-subregional cooperation in trade and investment.

Travel on official business

16.27 The estimated requirements for travel in the amount of \$131,000, including an increase of \$8,000, relate to travel of staff for fact-finding missions, data collection, consultations with Government officials, participation in national, regional and international and internace meetings, including the Committee for Development Planning and the ACC Task Force on Long-term Development Objectives.

Contractual services

16.28 The estimated requirements in the amount of \$98,200 under contractual services relate to external printing and binding of publications.

Subprogramme 2. Environment and sustainable development

16.29 This subprogramme comprises the activities that had previously been carried out in 1992-1993 under subprogramme 3 (Energy), subprogramme 4 (Environment) and subprogramme 9 (Natural resources). The immediate purpose of the programmed activities is to mitigate environmental problems and promote sustainable development by integrating environmental considerations into the economic development planning process and development activities. The focus of ESCAP's work in this subprogramme will be on the development of policies and management practices and guidelines to avoid economic and physical depletion and degradation of resources, as well as to limit demand for fossil fuels. ESCAP will also promote information technologies, particularly remote sensing and geographic information systems in the area of natural resources management and environment monitoring.

16.30 The work will be carried out under the guidance of the Committee on Environment and Sustainable Development, which meets annually. ESCAP will also provide substantive services to a number of ministerial-level meetings to be convened to consider environment and development and the regional space applications programme.

Activities:

Subprogramme 3. Poverty alleviation through economic growth and social development

- 16.34 This subprogramme comprises those activities that had previously been carried out in 1992-1993 under subprogramme 1 (Agricultural and rural development), subprogramme 5 (Human resources development), subprogramme 6 (Human settlements), subprogramme 10 (Population), subprogramme 11 (Social development) and subprogramme 15 (Women in development). Particular attention will be directed during the 1994-1995 biennium towards promotion of cooperation between Governments, non-governmental organizations and the private sector in dealing with the following key issues: (a) fulfilment of basic needs; (b) provision of essential services, including health care, family welfare services, education, water supply and sanitation and housing; (c) employment generation; (d) technological progress and the minimization of adverse effects of technology on the poor; and (e) interrelationships between poverty and the environment.
- 16.35 The work will be carried out under the guidance of the Committee on Poverty Alleviation through Economic Growth and Social Development. ESCAP will also provide substantive services to a number of intergovernmental and ministerial meetings to be convened to discuss poverty alleviation issues, including the Regional Ministerial Conference in Preparation for the World Summit for Social Development.

16.36 It is proposed to redeploy to this subprogramme one P-4 from programme support and one P-4 from subprogramme 4 (Transport and communications); it is also proposed to redeploy from this subprogramme one P-3 to subprogramme 4 and one P-3 to programme support.

Consultants and experts

16.37 The estimated requirements would amount to \$168,700 for consultants (\$59,100) and ad hoc expert groups (\$109,600), which includes an increase of \$62,000 comprising a non-recurrent provision \$50,000 (\$40,000 for two ad hoc expert groups and \$10,000 for consultants) for activities related to the Fourth World Conference on Women and a provision of \$12,000 for the ad hoc expert group on review and revision of the Jakarta Plan of Action on Human Resources Development. The net growth of \$54,600 reflects a decrease of \$7,400 which was a non-recurrent provision in 1992-1993 for preparatory activities related to the Fourth World Conference.

Travel of staff on official business

16.38 The estimated requirements for travel in the amount of \$152,100, including an increase of \$54,400, relate to travel of staff for fact-finding missions, data collection, consultations with Government officials, participation in national, regional and international and inter-agency meetings, including the Commission for Social Development, the Commission on the Status of Women, and the Population Commission. The increase includes a non-recurrent amount of \$40,000 for travel of staff to the World Summit on Social Development, the Fourth World Conference on Women, the Ninth Congress on Crime Prevention and the Treatment of Offenders and the preparatory meetings of the United Nations Conference on Human Settlements (Habitat II).

Contractual services

16.39 The estimated requirements in the amount of \$36,000, which includes an increase of \$3,200, relate to external printing and binding of the publications and information materials.

Subprogramme 4. Transport and communications

16.40 The activities for the 1994-1995 biennium are designed to: (a) identify the problems of transport, communications and tourism in the region and work out feasible solutions; (b) coordinate transport, communications and tourism-related activities undertaken in the region by international and intergovernmental organizations; (c) strengthen interregional cooperation, in particular with the ESCWA region; and (d) provide technical assistance to developing member and associate member Governments at subregional and regional levels in the areas identified as high priorities by the Commission and the Meeting of Ministers Responsible for Transport and Communications, which are reflected in the new regional action programme for phase II (1992-1996) of the Transport and Communications Decade for Asia and the Pacific.

16.41 The work will be carried out under the guidance of the Committee on Transport and Communications, which meets biennially. ESCAP will also provide substantive services to a number of intergovernmental and ministerial meetings.

16.44 The estimated requirements for travel in the amount of \$53,800, including an increase of \$7,400, relate to travel of staff for fact-finding missions, data collection, consultations with Government officials, participation in national, regional and inter-agency meetings, including coordination with ESCWA for Phase II of the Transport and Communications Decade for Asia and the Pacific.

Contractual services

16.45 The estimated requirements in the amount of \$5,200 relate to external printing and binding of the publications and information materials.

Subprogramme 5. Statistics

16.46 The activities for the 1994-1995 biennium will focus on assisting member countries and groups of countries in developing and improving their capability to identify, collect, process, analyse and utilize the data needed for the formulation, monitoring and evaluation of development plans and policies. This subprogramme will also aim to improve the availability of data at the regional and national levels, through the gathering from member countries of demographic, social, economic and other statistics, and through their maintenance in a form suitable for retrieval and dissemination through various means. The subprogramme will foster the utilization of modern information technology in the public sector in order to strengthen the ability at both central and subnational levels to plan and manage economic and social development. In the implementation of the subprogramme, due consideration will be given to the priorities given by the work programmes on regional economic cooperation, environment and sustainable development, and poverty alleviation through economic growth and social development.

16.47 The work will be carried out under the guidance of the Committee on Statistics, which meets biennially, as well as under the guidance of the other subsidiary bodies of the Commission, as relevant. ESCAP also provides substantive services to other intergovernmental meetings convened to consider statistical questions.

Activities:

- 16.48 The redeployment of one D-1 from the Technical Cooperation Division under programme support to this subprogramme is proposed to strengthen the statistics subprogramme, in light of the additional responsibilities and activities related to statistical information and data needed in response to the thematic approach recommended by the Commission and in light of the increased membership of ESCAP. It is also proposed to redeploy from this subprogramme one P-5 post to programme support for the Data-processing Section.
- 16.49 Given the expanded statistical programme, including activities related to the new Member States, it is proposed to reclassify one P-4 to the P-5 level for statistical development, particularly to address new issues and develop indicators

for sustainable development, poverty alleviation and quality of life. It is also proposed to reclassify one P-3 to the P-4 level for the expansion of statistical information services related to the collection of data and information.

Travel on official business

16.50 The estimated requirements for travel in the amount of \$33,300, including an increase of \$3,600, relate to travel of staff for data collection, consultations with Government officials, participation in national, regional and inter-agency meetings, including the Statistical Commission and the ACC SubCommittee on Statistics.

Contractual services

16.51 The estimated requirements of \$54,600 relate to external printing and binding of publications and information materials.

Subprogramme 6. Least developed, land-locked and island developing countries

- 16.52 The activities of the Economic and Social Commission for Asia and the Pacific under this subprogramme will focus during the 1994-1995 biennium on assisting the least developed, land-locked and island developing countries to forge closer cooperative relationships among themselves and with the rest of the ESCAP region. The activities are closely linked to those carried out under the other subprogrammes.

16.56 The Division of Administration provides programme support and comprises programme coordination and monitoring, management of technical cooperation, information services, conference and library services, and administration and common services.

Activities:

- 1. Programme coordination and monitoring and management of technical cooperation activities
- (a) Functions previously performed by the Programme Coordination and Monitoring Office under Executive Direction and Management and the management of technical cooperation activities, previously the responsibility of the Technical Cooperation Division, have been amalgamated into a single administrative entity. The combined activities will include overall coordination of programme planning, budgeting, monitoring and evaluation, services to the Commission and other meetings, collaboration with other entities and organizations of the United Nations system and appropriate outside institutions, mobilization of extrabudgetary resources and management of technical cooperation activities;
- (b) Parliamentary documentation: annual report to the Commission on technical cooperation activities and on economic and technical cooperation among developing countries; biennial report to the High-Level Committee on the Review of Technical Cooperation among Developing Countries (TCDC);
 - (c) Recurrent publication: Directory of TCDC National Focal Points (annual).
 - 2. Information services

Activities include full coverage of the work of the Commission by preparing press releases, summaries of proceedings and debates; special brochures, booklets, wall charts, information kits, films, videotapes; briefings, exhibitions.

3. Conference and library services

Activities will continue to include the provision of conference services to meetings of the policy-making organs of ESCAP (the annual sessions of the Commission and its subsidiary bodies) and other intergovernmental meetings held under the auspices of ESCAP; translation and printing of documents and publications; and library services.

4. Administration and common services

16.57 The Division of Administration provides services in connection with human resources management, financial administration and resource planning, and use of common services to support the implementation of the work programme. Activities will include: (a) recruitment, placement, career development, staff training, staff administration, staff counselling and medical services; (b) financial management, control and treasury services; (c) general services, including security and safety, communications, procurement, transportation, etc.; and (d) electronic data-processing services.

Resource requirements (at current rates)

Staff costs

- 16.58 An amount of \$22,790,700 is required for the established posts as well as for the following requirements:
- (a) General temporary assistance (\$232,700) for peak-time workload conditions and for the replacement of staff on sick leave and maternity leave, and so forth;
 - (b) Overtime (\$201,600), representing additional hours of work required during the biennium for ESCAP as a whole.
- 16.59 The establishment of 10 local level posts for operating the conference complex is proposed.
- 16.60 The following redeployments from Programme Support to the substantive areas are proposed: 1 D-1 from the Technical Cooperation Division to subprogramme 5 (Statistics); 1 P-4 to subprogramme 3 (Poverty alleviation through economic growth and social development) specifically for population activities; and 1 P-2 to subprogramme 1 (Regional economic cooperation) specifically for activities related to international trade and development finance.
- 16.61 The following redeployments to Programme Support are proposed: 10 posts (1 D-1, 1 P-4, 2 P-3, 1 P-2 and 4 local level) from Executive direction and management and one P-4 post from subprogramme 1 (Regional economic cooperation), specifically for activities related to programme coordination and monitoring; 1 P-2 post from Executive direction and management to administration and common services; 1 P-5 post from subprogramme 5 (Statistics) to the Dataprocessing Section; 1 P-3 post from subprogramme 3 (Poverty alleviation through economic growth and social development) to the Budget and Finance Section.
- 16.62 It is also proposed to transfer three Field Service posts from the Field Operations Division under section 25A to ESCAP in connection with the implementation of the new global satellite communications network. One post would be for a Senior technician for the Telecommunications Operations; and the other two posts would be utilized for two technicians, one each for the Satellite and the Switching Units of the Telecommunications Operations.

Travel on official business

- 16.63 An amount of \$60,500 is required for the travel of staff for consultations on programme coordination, administrative, financial and personnel matters, within and outside the region.
- 16.64 The increase of \$23,800 reflects the redeployment of resources for travel as a result of the redeployment of posts from Executive Direction and Management to programme support.

Contractual services

16.65 An amount of \$151,300, which reflects decreases of \$46,500 and a non-recurrent provision in 1992-1993 of \$312,600 for data-processing services, is required for translation and editing of documentation and publications and for data-processing services.

General operating expenses

16.66 An amount of \$3,887,000, which includes an increase of \$185,200 primarily related to increased costs for the conference complex, is required for rental and maintainance of premises and of furniture and equipment, communications, utilities, insurance, bank charges and other miscellaneous charges, including those for the Vanuatu Office.

Supplies and materials

16.67 An amount of \$613,700, which includes an increase of \$7,800, is required for the purchase of office supplies, internal reproduction supplies, data-processing supplies and library books; it is offset by a decrease under policy-making organs.

Furniture and equipment

An amount of \$1,115,300, which includes an increase of \$180,000 primarily for security communications and safety equipment required by the United Nations Security Plan for Bangkok and conference-servicing equipment, is required for replacement of existing furniture and equipment as part of the replacement schedule. A non-recurrent amount of \$185,300 is required for the establishment of the local area network (LAN) as part of office automation. The net decrease of \$190,700 reflects the deduction of the non-recurrent amount of \$556,000 provided in 1992-1993 for computer equipment.
