SUSTAINABLE DEVELOPMENT AND INTERNATIONAL ECONOMIC COOPERATION: UNITED NATIONS CONFERENCE ON HUMAN SETTLEMENTS (HABITAT II)

Report of the Second Committee (Part VIII)*

I. INTRODUCTION

1. The Second Committee held a substantive debate on item 88 (see A/49/728, para. 2). Action to be taken on sub-item (g) was considered at the 29th and 33rd meetings, on 23 November and 9 December 1994. An account of the Committee's consideration of the sub-item is contained in the relevant summary records (A/C.2/49/SR.29 and 33).

II. CONSIDERATION OF PROPOSALS

A. Draft resolutions A/C.2/49/L.27 and L.61

2. At the 29th meeting, on 23 November, the representative of <u>Algeria</u>, on behalf of the States Members of the United Nations that are members of the Group of 77, <u>China</u> and <u>Turkey</u>, introduced a draft resolution entitled "United Nations Conference on Human Settlements (Habitat II)" (A/C.2/49/L.27), which read as follows:

"United Nations Conference on Human Settlements (Habitat II)

"The General Assembly,

"Recalling its resolution 47/180 of 22 December 1992, by which it decided to convene the United Nations Conference on Human Settlements (Habitat II) from 3 to 14 June 1996, and to establish both a preparatory committee and an ad hoc secretariat for the Conference,

"Reiterating its gratitude to the Government of Turkey for offering to act as host to the Conference, which is to be held at Istanbul,

"Reaffirming the importance of the principles contained in the Rio Declaration on Environment and Development, $\underline{1}/$ and the objectives, basis for action, activities and means of implementation of those activities, set out in chapter 7, entitled 'Promoting sustainable human settlements development', of Agenda 21, $\underline{2}/$

"Noting with interest the progress made so far in the preparations for the United Nations Conference on Human Settlements (Habitat II), as described in the reports of the Preparatory Committee for the Conference on its organizational session $\underline{3}/$ and its first session, $\underline{4}/$ as well as in the report of the Secretary-General on the progress of work of the Preparatory Committee and the ad hoc secretariat for the Conference, $\underline{5}/$

"Noting with concern that the resources currently available to the secretariat for the Conference, through voluntary contributions, among other sources, including maximum redeployment of resources from the United Nations Centre for Human Settlements (Habitat), remain insufficient to support the preparatory process for the Conference on the scale envisaged by the General Assembly in resolution 47/180, in particular with respect to the ability of the secretariat to provide assistance to developing countries and other States requiring such assistance in their national preparatory efforts for the Conference,

- "1. <u>Takes note</u> of the reports of the Preparatory Committee for the United Nations Conference on Human Settlements (Habitat II) on its organizational session, held at United Nations Headquarters from 3 to 5 March 1993 $\underline{3}$ / and its first substantive session, held at the United Nations Office at Geneva from 11 to 22 April 1994, $\underline{4}$ / and endorses the decisions contained therein;
- "2. Takes note with appreciation of the report of the Secretary-General concerning progress in the preparations for the Conference; 5/
- "3. Approves the recommendation contained in decision I/1 of the Preparatory Committee that a third substantive session of the Preparatory Committee, of relatively short duration, be held at United Nations Headquarters early in 1996 to complete the preparatory work for the Conference; 6/
- "4. Welcomes the recommendations made by the Preparatory Committee in its decision I/2 on preparations at the country, regional and global levels, on the draft statement of principles and commitments and on the draft global plan of action, which is to be structured around the two main themes of the Conference: 'Adequate shelter for all' and 'Sustainable human settlements development in an urbanizing world'; $\underline{6}/$
- "5. Endorses the call by the Secretary-General of the United Nations to give the Conference the dimensions of a 'summit', and reaffirms its decision that the Conference should be held at the highest possible level of participation; $\underline{7}/$
- "6. Recommends that the global plan of action of the United Nations Conference on Human Settlements (Habitat II) take into account the outcome of the Global Conference on the Sustainable Development of Small Island Developing States, the International Conference on Population and Development, the World Summit for Social Development and the Fourth World Conference on Women: Action for Equality, Development and Peace, at the human settlement level, and therefore invites all organs, organizations, agencies and programmes of the United Nations system to cooperate fully with the secretariat of the Conference for that purpose;
- "7. Recommends also that the inclusion of sustainable human settlements issues, as contained in chapter 7 of Agenda 21, be given appropriate attention within the context of an agenda for development, which is being prepared pursuant to General Assembly resolutions 47/181 of 22 December 1992 and 48/166 of 21 December 1993, and reaffirms that human beings should be at the centre of all concerns for sustainable development;

- "8. Expresses its sincere appreciation to those States and organizations that have made or pledged financial or other contributions in support of the preparatory activities for the Conference, and requests the Secretary-General of the Conference to continue to make every effort to raise the extrabudgetary resources required for Conference activities and preparations;
- "9. Renews its appeal to all Governments, especially those of the developed countries and others in a position to do so, and to international and regional financial institutions, to contribute substantially to the voluntary funds established by the General Assembly in resolution 47/180 for the purpose of financing preparatory activities for the Conference and of supporting developing countries, in particular the least developed among them, in participating fully and effectively in the Conference and its preparatory process;
- "10. <u>Requests</u> that adequate financial resources be made available from the regular budget of the United Nations, to both strengthen the ad hoc secretariat for the Conference and enhance its effectiveness, and also to permit the launching of a full-scale preparatory process, especially at the country level, that would ensure the success of the Conference as an event having a global impact;
- "11. <u>Invites</u> all organs, organizations, agencies and programmes of the United Nations system, as well as other relevant intergovernmental organizations, to contribute fully to the preparations for the Conference;
- "12. <u>Also invites</u> interested non-governmental organizations, particularly those from developing countries, to participate in, and contribute to the Conference and its preparatory process, taking into account procedures followed at recent United Nations conferences;
- "13. <u>Calls upon</u> the above-mentioned organizations to contribute fully to increasing world awareness of the problems and potential of human settlements as important inputs to social progress and economic growth, and world leaders to commit themselves to making cities, towns and villages healthy, safe, just and sustainable;
- "14. Requests the regional commissions to include in their programme activities for 1995 an item on the preparations for the Conference, with particular emphasis on preparations for the Conference in their respective regions, and to submit a report on those preparations to the General Assembly at its fiftieth session;
- "15. <u>Calls upon</u> all States to ensure the broad-based participation of local authorities and other relevant actors in the national, regional and international preparatory process and to encourage a wide exchange of information and experience in this respect, in particular on the programmes of work and activities of national committees;
- "16. Requests the Secretary-General to establish a special task force composed of heads of the secretariats of all relevant organs and

organizations of the United Nations system, taking into account the experience gained from previous relevant United Nations conferences;

- "17. <u>Calls upon</u> the organs and organizations of the United Nations system to provide financial resources to interested developing countries, at their request, for the preparation of their national reports, which are to be presented, where necessary by audio-visual means, at the Conference;
- "18. <u>Requests</u> the Secretary-General of the United Nations, in consultation with the Secretary-General of the Conference, to report to the General Assembly at its fiftieth session on the progress made in the preparations for the Conference, including the implementation of the present resolution;
- "19. $\underline{\text{Decides}}$ to include in the provisional agenda of its fiftieth session an item entitled 'United Nations Conference on Human Settlements (Habitat II)'."
- 3. At its 33rd meeting, on 9 December, the Committee had before it a draft resolution (A/C.2/49/L.61), submitted by the Vice-Chairman of the Committee, Mr. Raiko Raichev (Bulgaria), on the basis of informal consultations held on draft resolution A/C.2/49/L.27, which was orally revised as follows: in the last line of operative paragraph 14, the words "in their countries" were inserted after the words "towns and villages".
- 4. A statement of the programme budget implications of draft resolution A/C.2/49/L.27, which also pertains to A/C.2/49/L.61, submitted by the Secretary-General in accordance with rule 153 of the rules of procedure of the General Assembly, was contained in document A/C.2/49/L.56.
- 5. Before the adoption of the draft resolution, statements were made by the representatives of Algeria, on behalf of States Members of the United Nations that are members of the Group of 77 and China, Belarus, Poland and Greece (see A/C.2/49/SR.33).
- 6. At its 33rd meeting, on 9 December, the Committee adopted draft resolution A/C.2/49.L.61, as orally revised, without a vote (see para. 10, draft resolution).
- 7. After the adoption of the draft resolution, a statement was made by the representative of Turkey (see A/C.2/49/SR.33).
- 8. In the light of the adoption of draft resolution A/C.2/49/L.61, draft resolution A/C.2/49/L.27 was withdrawn by its sponsors.

B. <u>Draft decision</u>

9. At its 33rd meeting, on 9 December, the Committee decided to take note of the report of the Secretary-General submitted under agenda item 88 (g) (see para. 11, draft resolution).

Reaffirming the importance for Habitat II, inter alia, of the principles contained in the Rio Declaration on Environment and Development, $\underline{8}/$ and the objectives, basis for action, activities and means of implementation of those activities, set out in chapter 7, entitled "Promoting sustainable human settlements development", and in relevant provisions of chapter 28 of Agenda 21, entitled "Local authorities' initiatives in support of Agenda 21", $\underline{9}/$

<u>Noting with interest</u> the progress made so far in the preparations for the United Nations Conference on Human Settlements (Habitat II), as described in the reports of the Preparatory Committee for the Conference on its organizational session $\underline{10}/$ and its first session, $\underline{11}/$ as well as in the report of the Secretary-General on the progress of work of the Preparatory Committee and the ad hoc secretariat for the Conference, $\underline{12}/$

- 7. Requests the Secretary-General to ensure that all relevant organs, organizations, agencies and programmes intensify their efforts and cooperate closely to prepare for the Conference;
- 8. Recommends that the inclusion of sustainable human settlements issues, as contained in chapter 7 of Agenda 21, be given appropriate attention within the context of an Agenda for Development, which is being prepared pursuant to General Assembly resolutions 47/181 of 22 December 1992 and 48/166 of 21 December 1993, and reaffirms that the overall human settlements objective is to improve the social, economic and environmental quality of human settlements and the living and working environments of all people, in particular the urban and rural poor;
- 9. Expresses its sincere appreciation to those States and organizations that have made or pledged financial or other contributions in support of the preparatory activities for the Conference, and requests the Secretary-General of the Conference to continue to make every effort to raise the extrabudgetary resources required for Conference activities and preparations;
- 10. Renews its appeal to all Governments, especially those of the developed countries and others in a position to do so, and to international and regional financial institutions, to contribute substantially to the voluntary funds established by the General Assembly in resolution 47/180 for the purpose of financing preparatory activities for the Conference and of supporting developing countries, in particular the least developed among them, in participating fully and effectively in the Conference and its preparatory process;

- 16. <u>Calls upon</u> all States to encourage the broad-based participation of local authorities and all relevant actors, including the scientific community, industry, trade unions, non-governmental organizations and the private sector, in the national, regional and international preparatory process and to encourage a wide exchange of information and experience in this respect, in particular on the programmes of work and activities of national committees;
- 17. <u>Requests</u> the Secretary-General of the United Nations, in consultation with the Secretary-General of the Conference, to report to the General Assembly at its fiftieth session on the progress made in the preparations for the Conference, including the implementation of the present resolution;
- 18. <u>Decides</u> to include in the provisional agenda of its fiftieth session the sub-item entitled "United Nations Conference on Human Settlements (Habitat II)".
