#### II. Equality, Dignity and Tolerance

A new section should be inserted:

## "F. The rights of older persons

#### Paragraph 1

The World Conference reaffirms that all human rights and fundamental freedoms are universal and thus unreservedly include older persons, without restriction of any kind due to age.

## Paragraph 2

Ageing is a lifelong process and should be recognized as such. Preparation of the entire population for the later stages of life should be an integral part of social policies.

#### Paragraph 3

In the context of its own traditions, structures and cultural values, each country should respond to demographic changes which are dramatically altering the age-structure of the world population.

The promotion of the activities, safety and wellbeing of older persons should be and

#### Paragraph 6

Recalling the International Plan of Action on Ageing adopted by the World Assembly on Ageing in 1982, the World Conference urges all nations to strengthen the implementation of the Plan of Action through existing United Nations guidelines such as the United Nations Principles for older Persons, adopted by the General Assembly in 1991, the Global Targets on Ageing for the Year 2001, adopted by the General Assembly in 1992."
