PROGRAMME BUDGET FOR THE BIENNIUM 1980-1981

DRAFTING OF AN INTERNATIONAL CONVENTION AGAINST THE RECRUITMENT, USE, FINANCING AND TRAINING OF MERCENARIES

Administrative and financial implications of the draft resolution contained in document A/C.6/35/L.14 and Corr.1

Statement submitted by the Secretary-General in accordance with rule 153 of the rules of procedure of the General Assembly

- 1. The Sixth Committee, at its 56th meeting on 20 November 1980, adopted the draft resolution contained in document A/C.6/35/L.14 and Corr.1. It had before it a statement of financial implications (A/C.6/35/L.15).
- 2. Under the terms of the draft resolution contained in document A/C.6/35/L.14 and Corr.1, the General Assembly would:
- (a) Decide to establish an <u>ad hoc</u> committee on the "drafting of an international convention against the recruitment, use, financing and training of mercenaries" composed of 35 Member States;
- (b) Request the Secretary-General to provide the Committee with any assistance and facilities it may require for the performance of its work.
- 3. It will be recalled that by adopting resolution 35/5 of 20 October 1980, the General Assembly declared, as a temporary measure, a one-year moratorium on the establishment of new subsidiary organs of the General Assembly. However, the establishment of an ad hoc committee on the drafting of an international convention against the recruitment, use, financing and training of mercenaries would fall under the exceptional clause contained in paragraph 1 (a) of that resolution whereby the provisions of the resolution do not apply to establishment of subsidiary organs relating to the drafting of international conventions.

- 4. For the purpose of costing, the following assumptions have been used:
- (a) The <u>ad hoc</u> committee would meet for four weeks in New York from 19 January to 13 February 1981 and hold two daily meetings;
- (b) Services for pre-session documentation, in-session documentation and interpretation would be provided in five languages (Chinese, English, French, Russian and Spanish): however, post-session documentation, consisting of the ad hoc committee's report to the General Assembly, would be in six languages.
- 5. On the basis of the above, conference-servicing costs are estimated at \$429,800, as follows:
