POLICIES OF APARTHEID OF THE GOVERNMENT OF SOUTH AFRICA

Administrative and financial implications of the draft resolutions contained in documents A/35/L.13, A/35/L.14, A/35/L.15, A/35/L.16, A/35/L.17, A/35/L.18, A/35/L.19, A/35/L.21, A/35/L.22, A/35/L.23, A/35/L.25, A/35/L.26, A/35/L.27 and A/35/L.28

Statement submitted by the Secretary-General in accordance with rule 153 of the rules of procedure of the General Assembly

1. On 8 November the following draft resolutions were submitted to the General Assembly in connexion with its consideration of item 28, Policies of <u>Apartheid</u> of the Government of South Africa: A/35/L.13, A/35/L.14, A/35/L.15, A/35/L.16, A/35/L.17, A/35/L.18, A/35/L.19, A/35/L.21, A/35/L.22, A/35/L.23, A/35/L.25, A/35/L.26, A/35/L.27 and A/35/L.28.

2. The administrative and financial implications arising from the following paragraphs of the following draft resolutions will be considered in the context of the resources requested under draft resolution A/35/L.28 in connexion with the programme of work of the Special Committee:

A. Military and nuclear collaboration with South Africa (A/35/L.14) (\$185,500)

3. By operative paragraph 7 of the draft resolution the General Assembly would authorize the Special Committee:

(a) To continue its efforts to promote a comprehensive and effective embargo on all forms of military and nuclear collaboration with the racist régime of South Africa, and to take appropriate measures for this purpose;

(b) To continue its co-operation with the Security Council Committee established by resolution 421 (1977) concerning the question of South Africa and to organize joint hearings and seminars with that Committee as appropriate.

4. In connexion with the above requests it is understood that a seminar on the implementation and reinforcement of Arms Imbargo against South Africa will be held in Western Europe in June 1981. The holding of the seminar which would last for three days would require interpretation in two languages and provision of pre-, in- and post-session documentation of a total amount of 350 pages. Based on these assumptions the conference servicing requirements would be as follows:

5. To participate in the seminar the Special Committee would send a delegation of five members accompanied by four staff members of the Secretariat. The Special Committee would invite to participate in the seminar 2 representatives of liberation movements, 10 representatives of anti-apartheid groups and international organizations and 15 experts. The relating estimated expenditures in respect of travel and subsistence would arount to \$42,500.

6. Other additional requirements resulting from the implementation of the requests contained in paragraph 7 of the draft resolution will be considered in the context of paragraphs 5 and 6 of draft resolution A/35/L.28.

B. Comprehensive sanctious against Couth Africa (A/35/L.15) (\$23,000)

7. Under the terms of operative paragraph 10 of the draft proposal the General Assembly would request and authorize the Special Committee against Apartheid:

(a) To continue in its campaign to achieve world-wide support for comprehensive mandatory economic and other sanctions against the racist régime of South Africa,

(b) To consult with experts, to hold hearings and organize seminars on all aspects of sanctions against South Africa.

8. It is the understanding of the Secretary-General that in respect of naragraphs 7 (a) and (b) above, the Special Committee intends to organize hearings on bank loans to South Africa, on publicity against <u>apartheid</u>, on all aspects of sanctions against South Africa and on legal aspects of the struggle against <u>apartheid</u>. The hearings will be held in New York, provision of conference servicing will not be required. To hold the hearings the Special Committee may invite 21 witnesses to come to New York for one day. Related provision for travel and subsistence would amount to \$22,000 approximately.

C. International Conference Sanctions against South Africa (A/35/L.21) (\$751,100)

9. Under the terms of draft resolution A/35/L.21 the General Assembly recalling its resolution 34/93 C of 12 December 1979 on an International Conference on Sanctions against South Africa, having considered the special report of the Special Committee against <u>Apartheid</u> (document A/35/22/Add.3-S/14156/Add.3), and endorsing the recommendation of the Special Committee for the convening of the Conference in 1981, would:

(a) Request and authorize the Special Committee against <u>Apartheid</u> to take all necessary steps, in co-operation with the Organization of African Unity, for the organization of the International Conference on Sanctions against South Africa and preparatory meetings, in accordance with the recommendations contained in its special report;

(b) Request the Secretary-General to provide all necessary assistance to the Special Committee in the organization of the Conference.

10. It should be recalled that at its last session by resolution 34/93 C the General Assembly decided to organize, in co-operation with the Organization of African Unity, an International Conference for Sanctions against South Africa in 1980, and authorized the Special Committee to take all necessary steps for the organization of the Conference and preparatory meetings.

11. In paragraph 31 of its third special report (document A/35/22/Add.3-S/14156/Add.3) the Special Committee recommended in respect of the Conference and preparatory meeting that:

(a) The International Conference on Sanctions against Africa shall be organized by the United Nations, in co-operation with OAU, at a date to be decided by the Preparatory Committee in consultation with the Secretary-General of the United Nations. The duration of the Conference shall be six working days.

(b) Invitations to the Conference shall be sent to all Member States of the United Mations and specialized agencies, to United Mations organs concerned, to organizations and institutions within the United Mations system, to the current Chairman of the Conference of Non-Aligned Countries, to intergovernmental organizations accorded observer status in the General Assembly, and to the national liberation movements recognized by the United Mations and OAU. The Preparatory Committee shall decide on invitations to non-governmental organizations and individual experts.

- (c) The Conference shall conduct its work in:
- (i) Plenary meetings, which will be devoted to statements by representatives of Governments, intergovernmental organizations and national liberation movements, as well as others designated by the Preparatory Committee, and for the adoption of the final documents;
- (ii) A Political Commission, which will review action taken by Governments and intergovernmental and non-governmental organizations, and make proposals for further action;
- (iii) A Technical Commission, which will consider the technical aspects of sanctions and other measures.

(d) One or more preparatory meetings will be held for an exchange of views on all matters on the agenda of the Conference and for the preparation of basic documents for discussion at the Conference.

Arrangements for the preparatory meetings shall be decided by the Preparatory Committee.

12. Based on the above recommendations and on the assumption that the Conference would be held in Paris the total estimated cost of the holding of the Conference would amount to \$568,100 as follows:

- (i) Travel, subsistence and miscellaneous expenses in connexion with travel of 19 representatives of the Special Committee, 29 Secretariat staff members and 40 experts: \$153,400.
- (ii) Conference services (provision will be made for interpretation in five languages, publication of pre- and in-session documentation of a total amount of 850 pages in two languages (E and F) and of post-session documentation amounting to 150 pages in six languages):

13. With regard to the preparatory meetings the Government of Nigeria has formally invited the United Mations to hold the meetings in Nigeria. Therefore, in accordance with provisions of General Assembly resolution 31/140 and based on the assumptions that the duration of the meetings would be four days, that interpretation and publication of pre- and in-session documentation of a total amount of 300 pages would be provided in two languages (English and French) and publication of post-session documentation (100 pages) would be in six languages, and that the Special Committee would invite representatives of 17 non-governmental organizations to participate in the preparatory meetings, the cost for the United Hations would be \$183,000 as follows:

D. Assistance to the oppressed people of South Africa and their national liberation movement (A/35/L.22) (\$198,000)

14. By operative paragraph 4 of the draft resolution the General Assembly would decide to continue the authorization of adequate financial provision in the budget of the United Nations to enable the South African liberation movements recognized by the Organization of African Unity - the African National Congress of South Africa and the Pan Africanist Congress of Azania - to maintain offices in New York in order to participate effectively in the deliberations of the Special Committee and other appropriate bodies.

15. The financial implications arising from these requests would amount to \$198,000 as follows:

E. Apartheid in sports $(\Lambda/35/L.25)$ (\$33,000)

16. By operative paragraph 3 and 4 of the draft resolution the General Assembly would:

(a) Request the <u>Ad Hoc</u> Committee on the Drafting of an International Convention against <u>Apartheid</u> in Sports to continue its work with a view to submitting a draft convention to the General Assembly at its thirty-sixth session, and

(b) Authorize the <u>Ad Hoc</u> Committee to widen its consultations to include more sports bodies as well as ministers or authorities in charge of sports and recreation.

17. The <u>Ad Hoc</u> Committee would require the services of one consultant for a period of three months to assist in the revision and completion of the International Convention against <u>Apartheid</u> in Sports at an estimated cost of 59,500, which includes a provision of 52,000 for travel.

18. As regards consultations with representatives of organizations concerned and experts on apartheid in sports, it is estimated that three members of the <u>Ad Hoc</u>

Committee, accompanied by one staff member will undertake four trips, one each to participate in the International Conference on Sanctions against South Africa, to Western Europe, to Eastern Europe and to Africa, for an average duration of four days each. Assuming that some of the missions would be combined, the relating estimated expenditures would amount to 23,500.

F. Women and children under apartheid (A/35/L.26) (324,200)

19. Under the terms of operative paragraph 8 of the draft resolution the General Assembly would request the Special Committee and its Task Force on Women and Children:

(a) To promote and monitor the implementation of the relevant recommendations of the World Conference of the United Nations Decade for Women;

(b) To publicize the plight of women and children under <u>apartheid</u> and their struggle for liberation;

(c) To encourage national, regional and international conferences on women and children under apartheid and to co-sponsor such conferences, as appropriate.

20. To assist the Special Committee and its Task Force in the implementation of the above requests and to service the Task Force as a secretary one additional established post at P-3 level will be required in the Centre against <u>Abartheid</u> of the Secretariat. Related expenditures for salaries and common staff costs would amount to 019,800. In addition, an amount of 04,400 would be needed in connexion with common services costs and an amount of 03,900, in connexion with staff assessment to be offset by income from staff assessment. The description of work to be performed by the incumbent of the requested post is contained in the Annex of the present document.

G. <u>Programme of work of the Special Committee against Apartheid (A/35/L.23)</u> (6612,300)

21. By operative paragraph 1 of the draft resolution the General Assembly would endorse the recommendations of the Special Committee against <u>Apartheid</u> on its programme of work, contained in paragraphs 437 and 438 of its report.

22. In paragraph 437 of its report the Special Committee, considering the need for continuing and expanding its activities in the light of the recommendations contained in its report (document $\Lambda/35/22$, paras. 273 to 435) recommended that the authorizations contained in General Assembly resolution 34/93 L of 17 December 1979, should be renewed and that adequate financial provision be made for that purpose.

23. By its resolution, 34/93 the General Assembly authorized the Special Committee, inter alia:

"(a) To send missions to Member States and to the headquarters of the specialized agencies and other intergovernmental organizations, as required to promote international action against apartheid;

"(b) To intensify co-operation with the movement of non-aligned countries, the Organization of African Unity and other appropriate organizations;

"(c) To participate in conferences concerned with action against apartheid;

"(d) To organize, or participate in the organization of, symposia and other events in the home countries of transnational corporations with a view to educating the general public on the activities of those corporations in South Africa;

"(e) To invite representatives of the South African liberation movements recognized by the Organization of African Unity and those of other organizations active in opposition to <u>apartheid</u>, as well as experts, for consultations on various aspects of <u>apartheid</u> and on international action against <u>apartheid</u>;

"(f) To associate representatives of the South African liberation movements recognized by the Organization of African Unity with the missions of the Special Committee:

"(g) To send representatives to attend meetings of United Nations organs, as well as specialized agencies and other institutions within the United Nations system, as appropriate;

"(h) To commission expert studies on all aspects of <u>apartheid</u> and its international repercussions;

"(i) To hold sessions away from Headquarters as necessary;

"(j) To co-sponsor and promote the organization of conferences and seminars against <u>apartheid</u> in co-operation with Governments and intergovernmental and non-governmental organizations."

24. The estimated cost of renewing the foregoing authorization would amount to \$256,000 as follows:

(a) With regard to the missions to Member States and to the headquarters of the specialized agencies and other intergovernmental organizations, it is understood that six such missions are envisaged: one mission to Latin America lasting for six days, one mission to the Far East for six days, one mission to African front-line States for ten days, one mission to Eastern Europe for seven days, one mission to Western Europe for five days, one mission to the headquarters of the specialized agencies for five days. The average composition of each mission would be three delegates and two staff members, and the total estimated cost would amount to \$73,400.

(b) As regards intensifying co-operation with the movement of non-aligned countries, the Organization of African Unity and other appropriate organizations the Special Committee intends to participate in the Conference of the Council of Ministers of the Non-aligned Countries (New Delhi, three days in February), in two sessions of the NGO Sub-Committee (Geneva, three days in February and three days in summer) and in two sessions of the OAU Council of Ministers (Addis Ababa, three days in February and Nairobi, three days in July). One delegate and one staff member would attend these meetings for a total of 15 days. It is estimated that related expenses would amount to \$20,300.

(c) In connexion with participation in conferences concerned with the action against <u>apartheid</u> the Special Committee intends to be represented at the International Conference in support of the struggle of the Mamibian people (Africa, five days) and in the International Conference on Assistance to Refugees (Geneva, 9 to 10 April). An amount of \$9,600 would be required to cover the related cost for travel and subsistence of delegates and Secretariat staff members. If there should be further conferences at which the Special Committee would be represented, the resulting financial impact would be reported upon to the Ceneral Assembly at its thirty-sixth session.

(d) With regard to symposia and other events to be held in the home countries of transnational corporations the Special Committee intends to organize or participate in the organization of Symposia on Transnational Corporations operating in South Africa as follows two in Vestern Europe, two in North America, one in Africa and one in the Far Fast. Each one of the symposia would last for three days and the Special Committee would send one delegate accompanied by one staff member to each one of them. In addition, the Special Committee intends to participate in the Seminar on Effective Measures to Frevent Transnational Corporations and Other Established Interests from Collaborating with the Racist Régime of South Africa (Geneva, three days in June). A delegation consisting of one member of the Special Committee and one staff member will be sent to participate in the Seminar. The total estimated cost of the above undertakings would amount to \$16,800

(e) In connexion with invitations to representatives of the South African liberation movements recognized by OAU and those of other organizations active in opposition to <u>apartheid</u> as well as experts, for consultations on various aspects of <u>apartheid</u> and on international action against <u>apartheid</u>, related financial implications are considered in paragraphs 24 (j) and 28 below.

(f) The financial implications arising from associating representatives of South African liberation movements recognized by the Organization of African Unity with the missions of the Special Committee are also considered in paragraphs 24 (j) and 28 of this statement.

(c) With regard to the request contained in this paragraph of the draft resolution the Special Committee envisages sending its representatives to attend the session of the Commission on Human Rights (Geneva, 2 February to 13 March), sessions of the <u>Ad Hoc</u> Working Group of the Commission on Human Rights (Geneva, one week in July), the General Conference of the International Labour Organisation

(Geneva, five days in June), International ILO Tripartite meeting on action against South Africa (one of the front-line States in Africa, three days), the session of the Economic and Social Council in Geneva. It is estimated that two delegates and one staff member of the Secretariat would be sent on each such mission and that the related cost would amount to \$24,500.

(h) With regard to commissioning expert studies on all aspects of <u>apartheid</u> and its international repercussions, it is understood that the financial implications arising from this authorization would be met from within the provision for experts and consultants already appropriated under Section 3D of the programme budget for the biennium 1980-1981.

(i) In connexion with the authorization to hold sessions away from Headquarters as necessary, it is understood that one such session is envisaged by the Special Committee in 1981 and that it will be held in conjunction with the proposed International Conference on Sanctions against South Africa. It is estimated that the session would last for two days, that 19 delegates and 20 experts would participate in the meetings and that substantive services of nine staff members would be required. Since the session is to be held in conjunction with the Conference, only provision for subsistence amounting to \$8,700 would be required. As for the conference services, it is assumed that 150 pages of preand in-session documentation would be issued in two languages, and that interpretation and 60 pages of post-session documentation would be required in five and six languages respectively. The related costs would amount to \$95,600 as follows.

(j) In compliance with the authorization to co-sponsor and promote the organization of conferences and seminars against <u>apartheid</u> in co-operation with Governments and intergovernmental and non-governmental organizations the Special Committee intends to co-sponsor the following undertakings:

- (i) Colloquium of Religious Leaders on Mobilization against Apartheid
- (ii) Second World Youth and Student Conference in Solidarity with the Struggling People of South Africa
- (iii) Seminar on the Role of Mass Media in the Struggle against Apartheid
- (iv) Seminar on History of Resistance in South Africa
- (v) Seminar on Loans to South Africa.

The average duration of the above undertakings would be three days. I Special Committee would be represented by three delegates who would be accompanied by two staff members of the Secretariat. In addition, the Special Committee would invite three representatives of national liberation movements and ten experts to participate in the Seminar on history of resistance in South Africa and three representatives of national liberation movements and six experts in the case of the seminar on basic loans to South Africa. Related costs for travel and subsistence would amount to \$62,700. In addition, an amount of \$40,000 would be needed for miscellaneous expenses pertaining to the organization of the seminar on basic loans to South Africa.

25. Under the terms of paragraph 438 of its report (document A/35/22) the Special Committee stressed again that the services of the Centre against <u>Apartheid</u> in assisting the Special Committee and executing its decisions are indispensable for the discharge of its responsibilities. It recommended that the Centre be provided with all necessary resources for the discharge of its responsibilities in connexion with the recommendations in its report. The financial implications of this above recommendation will be considered in the context of requirements related to operative paragraphs 5 and 6 of the draft resolution which are considered below (see para. 32).

26. Under the terms of operative paragraph 2 of the draft resolution the General Assembly would request the Special Committee to continue and intensify its activities in accordance with the relevant resolutions of the General Assembly.

27. It is understood that in compliance with this request the Special Committee, in addition to the activities called for in draft resolutions considered in paragraphs 2 to 25 of this statement will undertake the following:

- (i) International Day for the Elimination of Racial Discrimination, 21 March, and the Week of Solidarity beginning on that day
- (ii) Africa Liberation Day, 25 May
- (iii) International Day of Solidarity with the Struggling People of South Africa (Soweto Day), 16 June
- (iv) Day of Solidarity with South African Political Prisoners, 11 October.

28. The Special Committee intends to invite two representatives of the liberation movements of South Africa for one week in connexion with the event outlined in paragraph 27 (i) above; two representatives of liberation movements and ten special guests for two weeks and two days respectively in connexion with the event indicated in paragraph 27 (iv) above. Related costs for travel and subsistence would amount to \$28,900.

29. The financial implications arising from operative paragraphs 3 (a) to 3 (f) of the draft resolution were considered in paragraphs 24 (a) to 24 (j) of the present document.

30. By operative paragraph 4 of the draft resolution the General Assembly would request the Special Committee, with the assistance of the Centre against <u>Apartheid</u> of the Secretariat and in co-operation with the South African liberation movement recognized by the Organization of African Unity, to promote the international mobilization against <u>apartheid</u> and to facilitate co-ordination of action among anti-<u>apartheid</u> and solidarity movements, trade unions, churches and other religious bodies, women's organizations, student and youth organizations and the mass media. This request will not involve any financial implications over and above those considered in paragraphs 2 to 29 above.

31. By operative paragraphs 5 and 6 of the draft resolution the General Assembly would request the Special Committee to devote special attention in 1981 to:

(a) Promotion of campaigns for the total isolation of the racist régime of South Africa;

(b) Promotion of increased assistance to the oppressed people of South Africa and their national liberation movement:

(c) Monitoring of the implementation of United Nations resolutions on apartheid and exposing all collaboration with South Africa, and

(d) Providing the Centre against <u>Apartheid</u> with all the necessary means to assist the Special Committee in this task.

32. The implementation of the requests in paragraphs 5 and 6 of this draft resolution as well as of those in draft resolutions A/35/L.14 (para. 7), L.15 (para. 10 (c)), L.16 (para. 5), L.18 (para. 4), L.19 (paras. 1 to 3), L.26 (para. 8) and L.27 (paras. 7 and 8) would require the establishment of one post at P-5 level and one post at P-4 level in the Centre against <u>Apartheid</u>. The description of work to be performed by the incumbents of the requested posts is contained in the <u>append</u> to this document. In addition, a General Service post at G-3/4 level would be required to provide secretarial services to the incumbents of the aboverequested Professional posts.

33. Related expenses for salaries and common staff costs would amount to \$63,500. In addition, an amount of \$18,300 would be required for common services costs. Related requirements for staff assessment, to be offset by income from staff assessment would amount to \$15,700.

34. By operative paragraph 7 of the draft resolution the General Assembly would decide to make a special annual allocation of \$150,000 to the Special Committee, from the budget of the United Nations for the biennium 1980-1981, for special projects to be decided on by the Committee to promote the international mobilization against apartheid, in particular:

(a) Co-sponsorship and assistance to national and international conferences and seminars against apartheid;

(b) Assistance to enable national liberation movements to participate in such conferences;

(c) Promotion of the widest observance of international days against <u>apartheid</u> and of international campaigns against <u>apartheid</u>;

(d) Expert studies on apartheid;

35. Net requirements in respect of this draft resolution therefore amount to \$612,300, as detailed in paragraphs 21 to 34 as follows:

37. Therefore should the draft resolutions listed above be adopted by the General Assembly, an additional appropriation of \$537,600 would be required in Sections 3A (\$422,100), 3D (\$92,800) and 2CD (\$22,700). In addition, an amount of \$19,600 would be required for staff assessment in Section 31, offset by an equivalent amount in Income Section 1.

ANNEX

Job descriptions of requested new posts

1. P-5 in Committee Services and Research Branch

Under the supervision of the Chief of Branch to assist the Special Committee against Apartheid in:

- actions to achieve world-wide support for comprehensive mandatory economic and other sanctions against South Africa, as well as consultations with experts, holding hearings and organizing of seminars on all aspects of sanctions against South Africa;
- actions against transnational corporations operating in South Africa;
- efforts to implement a comprehensive and effective embargo on all forms of military and nuclear collaboration with South Africa and the taking of appropriate measures for this purpose;
- co-operation with Security Council Committee established by resolution 421 (1977) concerning the question of South Africa and organizing joint hearings and seminars with that Committee as appropriate;
- -- efforts, including the undertaking of missions, holding of seminars and the publication of studies, in co-operation with Organization of African Unity, to enhance and intensify world-wide support for an effective oil embargo against South Africa.
- intensifying the monitoring, as a matter of priority, of the implementation of, and compliance with, United Nations resolutions against <u>apartheid</u> as well as exposing all collaboration with South Africa

2. P-4 in Publicity, Assistance and Promotion of International Action Branch

Under the supervision of the Chief of Branch, the incumbent plans and provides substantial support and services to the Special Committee in the promotion of the international campaign against <u>apartheid</u> in the main regions of the world;

Sets up and maintains a clearing-house for information on all activities against <u>apartheid</u> by Governments and intergovernmental and non-governmental organizations, and periodically prepares, with the guidance of the Chief of Branch, a newsletter on these activities;

Maintains and periodically publicizes, through the <u>Mewsletter</u>, a register of persons imprisoned or restricted in South Africa for their opposition to apartheid;

Sets up special projects for publicizing public campaigns in different countries on <u>apartheid</u> issues;

Performs the preparatory work for the promotion of the widest observance of the International Day for the Elimination of Racial Discrimination (21 March), the International Day of Solidarity with the Struggling People of South Africa (16 June) and the Day of Solidarity with the South African Political Prisoners (11 October) and other events;

Provides assistance in the substantive servicing of the Special Committee on international caupaign matters;

Acts as leader of the International Campaign Group;

Performs such other work related to the promotion of international campaign action as is deemed necessary by the Chief of Dranch.

3. P-3 in Committee Services and Research Branch

Under the supervision of the Chief of Branch to assist the Special Committee and its Task Force on Women and Children in:

- promoting and monitoring the implementation of the relevant recommendations of the World Conference of the United Mations Decade for Nomen
- publicizing the plight of women and children under <u>apartheid</u>, and their struggle for liberation;
- encouraging national regional and international conferences on women and children under <u>apartheid</u>, and co-sponsoring such conferences as appropriate.
