## Bilateral nuclear-arms negotiations and nuclear disarmament

The General Assembly,

Recalling its previous relevant resolutions,

<u>Recognizing</u> the fundamental changes that have taken place with respect to international security, which have permitted agreements on deep reductions in nuclear armaments of the States possessing the largest inventories of such weapons,

 $\underline{\text{Mindful}}$  that it is the responsibility and obligation of all States to contribute to the process of the relaxation of international tension and to the strengthening of international peace and security,

 $\underline{\text{Stressing}}$  the importance of strengthening international peace and security through disarmament,

 $\underline{\text{Emphasizing}}$  that nuclear disarmament remains one of the principal tasks of our times,

Stressing that it is the responsibility of all States to adopt and implement measures towards the attainment of general and complete disarmament under effective international control,

<u>Appreciating</u> a number of positive developments in the field of nuclear disarmament, in particular the intermediate-range nuclear forces agreement and the Treaty on the Reduction and Limitation of Strategic Offensive Arms,

Noting that there are still significant nuclear arsenals and that the primary responsibility for nuclear disarmament, with the objective of the elimination of nuclear weapons, rests with the nuclear-weapon States, in particular those which possess the largest stockpiles,

<u>Welcoming</u> the steps that have already been taken by those States to begin the process of reducing the number of nuclear weapons and removing such weapons from a deployed status,

<u>Noting</u> the new climate of relations between two major Powers, which permit them to intensify their cooperative efforts so as to ensure the safety, security and environmentally sound destruction of nuclear weapons,

<u>Urging</u> the further intensification of such efforts to accelerate the implementation of agreements and unilateral decisions relating to nuclear-arms reduction,

<u>Welcoming</u> the reductions made by other nuclear-weapon States in some of their arsenals, and encouraging all nuclear-weapon States to consider appropriate measures relating to nuclear disarmament,

<u>Affirming</u> that bilateral and multilateral negotiations on nuclear disarmament should facilitate and complement each other,

- 1. Expresses its satisfaction at the continued implementation of the Treaty on the Elimination of Intermediate-range and Shorter-range Missiles,  $\underline{1}$ / in particular at the completion by the parties of the destruction of all their declared missiles subject to elimination under the Treaty;
- 2. <u>Welcomes</u> the signing of the Second Treaty on the Reduction and Limitation of Strategic Offensive Arms, and urges the parties to take the steps necessary to bring this Treaty into force at the earliest possible date;
- 3. <u>Also welcomes</u> the announcement by the United States of America to seek a ban on the production of nuclear materials for weapons as well as international inspection of its stockpiles;
- 4. <u>Encourages</u> the United States of America, the Russian Federation, Belarus, Kazakhstan and Ukraine to continue their cooperative efforts aimed at eliminating nuclear weapons and strategic offensive arms on the basis of existing agreements, and welcomes the contributions that other States are making to such cooperation as well;
- 5. <u>Further encourages and supports</u> the United States of America and the Russian Federation in their efforts to reduce their nuclear armaments and to

continue to give these efforts the highest priority in order to contribute to the objective of the elimination of nuclear weapons;

6. <u>Invites</u> the United States of America and the Russian Federation to keep other States Members of the United Nations duly informed of progress in their discussions and in the implementation of their strategic offensive arms agreements and unilateral decisions.
