I. INTRODUCTION

1. The fourth session of the Intergovernmental Negotiating Committee for the Elaboration of an International Convention to Combat Desertification in those Countries Experiencing Serious Drought and/or Desertification, particularly in Africa, was held at Geneva from 21 to 31 March 1994. The session was convened in accordance with paragraph 4 of General Assembly resolution 47/188 of 22 December 1992. At its fourth session, the Committee held five meetings (1st to 5th), on 21, 23, 25, 28 and 31 March 1994.

At its 1st meeting, on 21 March, the Committee, bearing in mind paragraph 19 of General Assembly resolution 47/188 and rule 49 of the rules of procedure of the Committee (A/AC.241/3), decided to approve the accreditation of the non-governmental organizations listed in document A/AC.241/9/Add.6 (see appendix II, decision 4/1).

IV. ELABORATION OF AN INTERNATIONAL CONVENTION TO COMBAT
DESERTIFICATION IN THOSE COUNTRIES EXPERIENCING
SERIOUS DROUGHT AND/OR DESERTIFICATION, PARTICULARLY
IN AFRICA

A. Report of Working Group I

11. At the 5th meeting, on 31 March, the Chairman of Working Group I, Mr. Ahmed Djoghlafe (Algeria), drew the Committee's attention to the report of Working Group I (A/AC.241/WG.II/L.3), as adopted.

12. At the same meeting, the Committee adopted the report of Working Group I (see appendix III).

B. Report of Working Group II

13. At the 5th meeting, on 31 March, the Chairman of Working Group II, Ms. Anne De Lattre (France), drew the Committee's attention to the report of Working Group II (A/AC.241/WG.II/L.3), as adopted.

14. At the same meeting, the Committee adopted the report of Working Group II (see appendix IV).

V. REVIEW OF THE SITUATION AS REGARDS EXTRABUDGETARY FUNDS

15. The Committee considered item 3, entitled "Review of the situation as regards extrabudgetary funds" at its 4th and 5th meetings, on 28 and 31 March. At the 4th meeting, the Chairman took note of the approval of the Secretariat's presentation of document A/AC.241/20 and Add.1, while recognizing that there were still refinements to be made. In this regard, the representative of Benin requested a revision of the tables presented in document A/AC.241/20, which was subsequently issued in document A/AC.241/20/Add.2.

A. Special Voluntary Fund

16. The Committee took note of measures taken for its third and fourth sessions with regard to the Special Voluntary Fund. The Committee also agreed that all countries and international organizations should contribute to the Fund to enable the Secretariat to assist developing country participation. The Chairman stressed the importance of having the maximum participation possible for the Paris session and thanked the donors for their contributions.

B. Trust Fund

17. The Committee took note of the activities carried out by the Secretariat to support the preparatory activities at the national, regional and global levels. The Committee also endorsed the measures taken to finance the participation of non-governmental organizations on the basis of contributions to the Trust Fund

earmarked for this specific purpose and requested the Secretary-General to facilitate the participation of non-governmental organizations through the use of the Trust Fund. The Committee agreed that all countries and international organizations should continue to contribute to the Trust Fund to continue to support preparatory activities at the national, regional and global levels. The Chairman thanked the contributors for their support.

VI. ADOPTION OF THE PROVISIONAL AGENDA AND ORGANIZATION OF
WORK FOR THE FIFTH SESSION

18. At the 5th meeting, on 31 March, the Committee decided to approve the draft provisional agenda for its fifth session (see appendix II, decision 4/2).

19. At the same meeting, the Committee took note of the note by the Chairman on the organization of work at the fifth session, which read as follows:

"In decision 2/1, adopted by the Intergovernmental Negotiating Committee for the Elaboration of an International Convention to Combat Desertification in those Countries Experiencing Serious Drought and/or Desertification at its second session, the Committee defined the mandates of the two Working Groups. Article 2 (c) of that decision states the following:

'The two Working Groups should, if possible, complete their work by March 1994, during the fourth session of the Committee at Geneva, in order to allow the Committee, at its fifth session, to finalize negotiations on the basis of a consolidated text.'

"Such a consolidated text is now available, even if there are still a number of brackets, and one important section (articles 22 and 23 on financial resources and mechanisms) continues to be the subject of special consultations. Against this background, the conditions for the completion of the work of the Working Groups would seem to be fulfilled.

"This opens the possibility for a flexible organization of work at the fifth session based on the needs in terms of negotiating specific outstanding issues. In the Chairman's introductory comments to this session of the Committee, on 21 March, the Committee was asked to authorize the Chairman to organize the fifth session in the light of the results of the present session and in the light of consultations during the interim period.

"Even if flexibility is important, there also has to be firm structure of work; and delegations need maximum information in order to prepare themselves for the session. I therefore wish to give the following indications before the end of the present session; they may be supplemented later in the interim period in order to keep delegations updated, if necessary.

/...

"There will be facilities for two major meetings with full interpretation to be held simultaneously, during the fifth session. The meetings will be held at UNESCO headquarters in Paris.

"Meetings of the plenary will be held as required to negotiate outstanding points at that level, in particular during the second week of the session. In order to finalize negotiation on as wide a range of issues as possible at an early stage, informal working groups, meeting in large rooms with full interpretation, will be established under the chairmanship of coordinators, appointed by the Chairman of the Committee after consultation with the Bureau. The present Chairmen of the Working Groups have already indicated that they would be ready to take on such tasks.

"Against this background, Mr. Djoghlaïf and Ms. de Lattre will be asked to take on various negotiating tasks on my behalf. At the very start of the session - after an opening plenary meeting - it is my intention to establish an informal working group to deal with regional annexes, under the chairmanship of Ms. de Lattre. At the same time, outstanding issues in the main part of the convention will be reviewed in plenary meeting. The consultations on financial issues, coordinated by Mr. Pierre-Marc Johnson and Mr. Bolong Sonko will also continue. The Committee will take stock of progress in a plenary meeting in the afternoon or evening of Wednesday, 8 June. After that, other informal working groups will be set up to finalize the remaining items.

"The question of a possible review of the text by legal experts has been raised. A very small number of experts may be asked to assist the Bureau and the Secretariat with this task.

"The Bureau has met all through this session with the Chairmen and Vice-Chairmen of the Working Groups. Even if the Working Groups themselves will not be operative at the fifth session, it is proposed to continue daily meetings with this same Group, which has a balanced composition and which has proved to be a most useful instrument for managing the negotiation. It is also proposed to continue the practice of meetings with the Chairmen of regional and interest groups when necessary."

VII. SIXTH SESSION OF THE COMMITTEE

20. The General Assembly in paragraph 2 of its resolution 48/191 of 20 December 1993, decided that the Intergovernmental Negotiating Committee should hold one session after the adoption of the convention in order to review the situation in the interim period pending its entry into force, in particular with regard to the implementation of provisions adapted to the specific needs of each region. In paragraph 3 of the same resolution, the General Assembly also decided that that session should be held not later than 31 January 1995. Accordingly, the dates proposed for the sixth session are 9 to 20 January 1995.

VIII. ADOPTION OF THE REPORT OF THE COMMITTEE ON
ITS FOURTH SESSION

21. At its 5th meeting, on 31 March, the Committee adopted the draft report on its fourth session, as contained in document A/AC.241/L.17, and authorized the Rapporteur to finalize it in cooperation with the Chairman and the Bureau by incorporating therein the proceedings of the 2nd to 5th meetings.

APPENDIX III

Report of Working Group I

A. Organization of work

1. At its 1st plenary meeting, on 21 March 1994, the Intergovernmental Negotiating Committee, in accordance with its decision 2/1 of 13 September 1993, allocated item 2 of its agenda, entitled "Elaboration of an international convention to combat desertification in countries experiencing serious drought and/or desertification, particularly in Africa" to the working groups. Working Group I would be responsible for the elaboration of such provisions as the preamble, principles, objectives and commitments, including financial arrangements, national and regional action programmes, education and public awareness and capacity-building.
2. At the 1st meeting of Working Group I, on 21 March 1994, the Chairman made an introductory statement.
3. At the same meeting, the Working Group approved its programme of work for the session. It held 13 formal meetings during the session.
4. Working Group I had before it for its consideration a note by the Secretariat entitled "Revised negotiating text of the convention" (A/AC.241/15/Rev.1).

B. Discussion of topics

1. Preamble

First reading

5. Working Group I considered the topic at its 1st meeting, on 21 March, and heard statements by the representatives of 16 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China.

Second reading

6. The Working Group resumed its consideration of the topic at its 6th and 7th meetings, on 24 March. At its 6th meeting, statements were made by the representatives of 10 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China. At the 7th meeting, statements were made by the representatives of 14 States, including one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China.

/...

Third reading

7. The Working Group resumed its consideration of the topic at its 10th meeting, on 28 March, and heard statements by the representatives of 14 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China.

2. Scope of the Convention

First reading

8. Working Group I considered the topic at its 2nd meeting, on 22 March, and heard a statement by the representative of one State speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China.

Second reading

9. The Working Group resumed its consideration of the topic at its 7th meeting, on 24 March, and heard statements by the representatives of 21 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China.

3. Objectives

First reading

10. Working Group I considered the topic at its 2nd meeting, on 22 March, and heard statements by the representatives of five States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China.

4. Principles

First reading

11. Working Group I considered the topic at its 2nd meeting, on 22 March, and heard statements by the representatives of 22 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China.

Second reading

12. Working Group I resumed its consideration of the topic at its 10th meeting, on 28 March, and heard statements by the representatives of six States.

5. General provisions

First reading

13. Working Group I considered the topic at its 2nd and 3rd meetings, on 22 March. At the 2nd meeting, statements were made by the representatives of 18 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China. At the 3rd meeting, statements were made by the representatives of five States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community.

Second reading

14. The Working Group resumed its consideration of the topic at its 8th meeting, on 25 March, and heard statements by the representatives of nine States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China.

Third reading

15. The Working Group resumed its consideration of the topic at its 10th meeting, on 28 March, and heard statements by the representatives of 15 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China.

6. Action programmes

First reading

16. Working Group I considered the topic at its 3rd to 5th meetings, on 22 and 23 March. At the 3rd meeting, on 22 March, statements were made by the representatives of 27 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China, as well as by the representative of one non-governmental organization. At the 4th meeting, on 23 March, statements were made by the representatives of 31 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of Member States of the United Nations that

are members of the Group of 77, as well as by the representative of a non-governmental organization. At the 5th meeting, on 23 March, statements were made by the representatives of 18 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China.

Second reading

17. The Working Group resumed its consideration of the topic at its 8th meeting, on 25 March, and heard statements by the representatives of 16 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community.

Third reading

18. The Working Group resumed its consideration of the topic at its 10th to 12th meetings, on 28 and 29 March. At the 10th meeting, statements were made by the representatives of nine States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China. At the 11th meeting, statements were made by the representatives of 27 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China. At the 12th meeting, statements were made by the representatives of 17 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China.

7. Capacity-building, education and public awareness

First reading

19. Working Group I considered the topic at its 5th meeting, on 23 March, and heard statements by the representatives of 21 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China, as well as by the representative of a non-governmental organization.

Second reading

20. The Working Group resumed its consideration of the topic at its 9th meeting, on 25 March, and heard statements by the representatives of seven States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community, as well as by the representatives of two non-governmental organizations.

8. Financial resources and mechanisms

First reading

21. Working Group I considered the topic at its 6th meeting, on 24 March, and heard statements by the representatives of six States, including one speaking on behalf of the States Members of the United Nations that are members of the European Community and one speaking on behalf of the States Members of the United Nations that are members of the Group of 77 and China.

C. Adoption of the report

22. At its 13th meeting, on 30 March, the Working Group adopted the draft report (A/AC.241/WG.I/L.3).

APPENDIX IV

Report of Working Group II

A. Organization of work

1. At its 1st plenary meeting, on 21 March 1994, the Intergovernmental Negotiating Committee, in accordance with its decision 2/1 of 13 September 1993, allocated item 2 of its agenda, entitled "Elaboration of an international convention to combat desertification in countries experiencing serious drought and/or desertification, particularly in Africa" to the working groups. Working Group II would be responsible for the elaboration of such provisions as definitions, institutional, administrative, technological and scientific aspects; research, data collection and exchange information; procedural arrangements and other legal provisions such as any instruments related to the convention.

2. At the 1st meeting, the Working Group approved its programme of work for 21 to 31 March 1994. Subsequently it held 14 formal and 5 informal meetings during that period.

3. Working Group II had before it for its consideration the following documents:

(a) Note by the Secretariat on the Revised negotiating text of the convention (A/AC.241/15/Rev.1);

(b) Note by the Secretariat on the negotiating text of a regional implementation annex for Africa (A/AC.241/19).
