II. ANNOTATIONS TO THE PROVISIONAL AGENDA

Item 1: Adoption of the agenda and organization of work

The provisional agenda for the second session was approved by the Ad Hoc Working Group at its 4th (closing) meeting on 29 January 1993.

A proposal for the organization of work of the second session is given in section III below.

Item 2: Interrelationship between investment and technology transfer: (a) Investment flows, transfer of technology and competitiveness; (b) Technological capacity-building in developing countries, particularly the least developed countries, and in countries undergoing the process of transition to market-economy; (c) Transfer and development of environmentally sound technologies

As stated under this agenda item, the discussion will be based on the presentation of preliminary or final country case studies and other relevant reports. The UNCTAD secretariat is, therefore, circulating the country case studies in the form and language in which they were received. 1/

In response to the request made in the Work Programme of the Ad Hoc Working Group, 2/ the secretariat has prepared two reports entitled respectively: (i) "Review of the work of the United Nations system and selected organizations dealing with investment-related technology issues" (TD/B/WG.5/6), and (ii) "Fostering technological dynamism: evolution of technology capacity-building and competitiveness" (TD/B/WG.5/7).

The first report provides a review and presents a synthesis of activities on investment-related technology issues carried out by the United Nations system and other selected organizations dealing with areas of concern to the Working Group.

The second report is based on the review and analysis of literature on technological capacity-building and on the role of technology in the international competitiveness of nations and enterprises. The report constitutes an extensive summary of a more comprehensive report which will be published as a United Nations publication. The literature sources that have been consulted in preparing the review are listed in background document UNCTAD/ITD/TEC/12.

In addition to the above documents, the secretariat is also submitting the report of the Workshop on Transfer and Development of Environmentally Sound Technologies held in Oslo, from 13 to 15 October 1993, as part of the work programme of the Ad Hoc Working Group.
