Note by the Secretary-General

1. As indicated in document A/48/102 of 12 April 1993, it will be necessary for the General Assembly, during its current session, to appoint six persons to fill vacancies that will arise in the membership of the Committee on Contributions, effective 31 December 1993.
2. Furthermore, in document A/48/102/Add.1 of 28 October 1993, the Secretary-General informed the General Assembly that he had received notification of the resignation of Mr. Peter Gregg (Australia) from the membership of the Committee and that, accordingly, the Assembly would also be required at the current session to appoint a person to fill the unexpired portion of the term of office of Mr. Gregg, that is, until 31 December 1995.
