Telegram from the Presidium of the Afro-Asian People's
Solidarity Organization to the Secretary-General

We, the participants of the Seventh Presidium of AAPSO, held in Hanoi from 13 to 15 January 1979, extend a strong appeal to all members of the Security Council and of the General Assembly of the United Nations to give full support to the Revolutionary People's Council of Cambodia.

We have been able to witness the developments in the area and to hear evidence of the true parts.

The people of Cambodia rose against a dictatorial régime which murdered millions of citizens and deprived the whole population of all human rights. The régime has fallen under the general popular revolt and the Revolutionary People's Council enjoys the full support of the entire people of Cambodia and carries out all the administration of the external and internal affairs of the country.

It would be detrimental to the institutions of the United Nations, contrary to the principles of the United Nations and interference in the internal affairs of Cambodia to give any audience to anybody who claims to represent a clique which is guilty of mass murder and oppression.

We are sure that the great majority of the United Nations Members will welcome with relief and enthusiasm the Revolutionary People's Council of Cambodia.

We would be grateful if you would urgently circulate our appeal to all members of the Security Council and of the General Assembly.
