I. INTRODUCTION

The Secretary-General has the honour to submit to the General Assembly the curricula vitae of the candidates selected by the Security Council from nominations received from States Members of the United Nations and non-member States maintaining permanent observer missions at United Nations Headquarters, for the election of judges of the Trial Chambers of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States between 1 January and 31 December 1994. The list of candidates selected for this election and the voting procedures to be followed in the General Assembly are set out in a memorandum by the Secretary-General issued as document A/49/893.

II. CURRICULA VITAE

Lennart ASPEGREN

University education

Born in 1931, Mr. Aspegren holds a degree in law (Jur. kand., LL.M.) from the Faculty of Law and Political Sciences, University of Stockholm, awarded in 1958. His studies included international politics and economy (Stockholm) and international law (American University of Beirut, Lebanon).

Foreign languages

Fluent in French (second mother tongue) and in English, also speaks Spanish, German, Italian.

Professional career

A magistrate, Mr. Aspegren entered the Swedish judicial system in 1958 and, after serving in various courts of civil and criminal law, was appointed Judge of Appeal in Stockholm in 1979.

On leave from this judgeship, he served from 1969 as Legal Adviser to the Government, mainly within the Ministry of Finance. Since 1979, he is Under-Secretary for Legal Affairs, from 1983 with the Ministry of Public Administration (Civildepartementet). In this capacity, he has been Head of the Ministry's Legal Secretariat and thus responsible, e.g., for framing substantial parts of Sweden's public law (bills, acts, ordinances, etc.). An executive civil servant, he reported directly to the Cabinet and its Ministers. From 1991, he was made Under-Secretary also for International Affairs, including European Community relations. From 1 December 1992 to 31 December 1993, he was transferred by the Government to the Ministry of Justice to coordinate as a Special Emissary the legal development assistance to Estonia, Latvia and Lithuania.

For the period 1 January 1994 to 30 June 1995, he serves as a member of the Supreme Social Insurance Court.

Since 1980, he also sits on the Labour Court.

In addition, he has served on a number of commissions and boards. During 1992-1995, he has been appointed Chairman of several governmental committees of inquiry, concerning matters such as Swedish public service and its competence for Europe, one-stop shops in Sweden and conditions in Swedish European Union service.

In April 1995, he was designated Special Rapporteur on a bilateral project concerning a contemplated reform of the judiciary in South Africa.

Special international experience

In the 1970s, Mr. Aspegren undertook a series of human rights missions on behalf of Amnesty International (London), namely to Bolivia, Greece, Morocco, Tunisia and Yugoslavia. On behalf of the World Council of Churches (Geneva), he also served on the international delegation of observers at the 1978 general elections in Bolivia.

Later, he represented his Government in negotiations and other official contacts with other Governments and with the International Labour Organization (ILO) (Geneva), the Organisation for Economic Cooperation and Development (OECD) (Paris) and the European Commission (Brussels).

He also contributed to the work of such organizations as the International Society for Labour Law and Social Security (Geneva), the International Institute of Administrative Sciences (Brussels), the European Group of Public Administration (Brussels/Amsterdam), the European Foundation for Management Development (Brussels), the American Society for Public Administration (Washington, D.C.), the Nordic Administrative Federation (Copenhagen) and the Nordic Lawyers' Meetings (Stockholm).

During 1989-1992, Mr. Aspegren served as Vice-Chairman of the Public Management Committee of OECD. An expert on law, he went on missions for ILO to Israel (1979) and for OECD to Turkey (1985) and to Portugal (1981, 1994). Likewise, he was invited by the French Government to act as an expert at the Paris National Convention on the Renewal of the Public Service (1990).

A consultant for the United Nations Development Programme (UNDP), he was Chairman of the Management Development Programme Mission which in July 1990 produced the report "Public Sector Management Improvement in Tanzania" (URT/90/506). The same year, he also took part as an expert in the UNDP-supported Beijing International Symposium on Human Resources Development in the 90s.

Mr. Aspegren has published a range of booklets and articles, mainly in the fields of public employment and public management, both in Swedish and in English, for example, "Public employment in Sweden" (Ds B, 1978:4), "Responsiveness in the Swedish Public Service" (Statens Institut för

Personal Utveckling, 1988) and "The safeguards for public interests during labour conflicts" (in <u>Grèves et services essentiels</u>, Canada, 1994).

Recently, he has published, together with another author, a book on Government employment (<u>Statlig anställning</u>, Publica, 1994).
