ELECTION OF MEMBERS OF THE SUB-COMMISSION ON PREVENTION
OF DISCRIMINATION AND PROTECTION OF MINORITIES

Note by the Secretary-General

1. In accordance with Economic and Social Council resolutions 1334 (XLIV) of 31 May 1968 and 1986/35 of 23 May 1986, and decisions 1978/21 of 5 May 1978 and 1987/102 of 6 February 1987, the Commission on Human Rights at its forty-fourth session (39th meeting, 29 February 1988) elected by secret ballot 26 members of the Sub-Commission on Prevention of Discrimination and Protection of Minorities from nominations of experts made by States Members of the United Nations on the following basis: (a) seven members from African States; (b) five members from Asian States; (c) three members from Eastern European States; (d) five members from Latin American States; (e) six members from Western European and other States.

2. Pursuant to Council resolution 1986/35, members of the Sub-Commission were to be elected for a term of four years and half of its membership and the corresponding alternates, if any, were to be elected every two years. The Chairman of the forty-fourth session of the Commission on Human Rights drew lots to select the members and, as applicable, their corresponding alternates whose term of office should expire after two years in accordance with the following pattern: three members from African States; three members from Asian States; one member from Eastern European States; three members from Latin American States; and three members from Western European and other States.

3. In 1990 and in 1992, when the term of office of half of the membership of the Sub-Commission had expired, the Commission on Human Rights at its forty-sixth and forty-eighth sessions held new elections of Sub-Commission members and alternates. ^{1/}

4. The list of the present members of the Sub-Commission is contained in annex II.

5. As the term of office of half of the membership of the Sub-Commission has again expired, the Commission on Human Rights is called upon at its fiftieth session, to hold a new election of Sub-Commission members and alternates in accordance with the following pattern: three members from African States; three members from Asian States; one member from Eastern European States; three members from Latin American States; and three members from Western European and other States.

6. In its resolution 1993/28 of 5 March 1993, the Commission on Human Rights called upon States to nominate as members and alternates persons meeting the criteria of independent experts who should discharge in that capacity their functions as members of the Sub-Commission and to respect fully the independence of elected members. The Sub-Commission, in its resolution 1987/32 of 4 September 1987, recommended that the Commission on Human Rights try and prevail upon all Governments to nominate more women for election to the Sub-Commission.

7. With regard to the designation of alternates, the Economic and Social Council adopted resolution 1983/32, in which it decided that:

"... notwithstanding paragraph 2 of article 13 of the rules of procedure of the functional commissions of the Economic and Social Council, the following rules shall henceforth apply to the Sub-Commission on Prevention of Discrimination and Protection of Minorities:

(a) A nomination of a candidate for membership of the Sub-Commission may be accompanied by a nomination of an expert of the same nationality, who shall be elected simultaneously with the candidate for membership, and who may serve temporarily as an alternate if the member is unable to attend;

(b) The qualifications for alternates shall be the same as for members;

(c) No person may serve as alternate for a member except the expert elected as alternate, pursuant to subparagraph (a) above."

8. As at 16 November 1993, the Secretary-General has received nominations of candidates for election to membership of the Sub-Commission from the Governments of Argentina, Belize, Benin, Brazil, Cameroon, Chile, China,

Ecuador, France, Greece, Hungary, Mali, Mexico, Nigeria, Philippines, Russian Federation, Senegal, Sudan and the United Kingdom of Great Britain and Northern Ireland.

9. Further communications and nominations of candidates received from Governments will be circulated as addenda to the present document.
