## Section 16

### Economic and Social Commission for Asia and the Pacific

#### Overview

- 16.1 The terms of reference of the Economic and Social Commission for Asia and the Pacific (ESCAP) were established by the Economic and Social Council in its resolution 37 (IV) of 28 March 1947 and amended in subsequent resolutions. Its activities are carried out at ESCAP headquarters at Bangkok and the ESCAP Pacific Operations Centre (EPOC), located in Vanuatu.
- 16.2 The demands placed on the secretariat have increased in the light of the significant increase in membership and expanded geographical scope of the Commission. During the biennium 1996-1997, emphasis will be placed on the promotion and enhancement of existing regional cooperation modalities and the establishment of new modalities; building of national capabilities and technical assistance activities in the context of the current and emerging socio-economic and political imperatives that have an impact on the Asia and Pacific region; and strengthening the implementation of the directives and mandates.
- 16.3 The thematic orientation of the programme of work implemented in the biennium 1994-1995, based on the former sectoral orientation, is reflected in the composition of the intergovernmental structure subsidiary to the Commission. This structure comprises three thematic committees, namely, the Committee for Regional Economic Cooperation, the Committee on Environment and Sustainable Development, and the Committee on Poverty Alleviation through Economic Growth and Social Development; two other committees, namely, the Committee on Statistics and the Committee on Transport and Communications; and two special bodies, namely, the Special Body on Least Developed and Land-locked Developing Countries and the Special Body on Pacific Island Developing Countries. The benefits of the thematic approach should evolve during the biennium 1996-1997 as changes are effected to the secretariat structure to support the thematically oriented programme of work.
- 16.4 In implementing its programme of work, ESCAP will continue its liaison and coordination with the other regional commissions and the substantive organs, departments and offices of the United Nations Secretariat, as well as with relevant United Nations specialized agencies and non-governmental and intergovernmental organizations and institutions at the international, regional and subregional levels working in fields related to its programme of work.
- 16.5 The overall level of resources proposed for the biennium 1996-1997 reflects an increase of \$287,000, or 0.4 per cent, resulting from the establishment of one P-5 post under subprogramme 3, Poverty alleviation through economic growth and social development, and one P-4 post under subprogramme 6, Least developed, land-locked and island developing countries, and the reclassification of one Local level post to the P-2 level as a result of the General Service classification exercise under Programme support. Other increases under contractual services, general operating expenses and equipment are partially offset by decreases under other staff costs, consultants and experts and travel.
- 16.6 The estimated percentage distribution of the total resources of ESCAP in 1996-1997 would be as follows:

- 16.7 The Commission, which meets annually, provides overall direction to the work of the secretariat. The Commission has 49 member and 10 associate member countries and territories. In addition to the subsidiary bodies of the Commission mentioned in paragraph 16.3 above, an Advisory Committee of Permanent Representatives and Other Representatives Designated by Members of the Commission meets monthly to advise the Executive Secretary in the exercise of his functions and to liaise between the Commission and the secretariat.

**Resource requirements (at current rates)***Other staff costs*

- 16.8 The proposed requirements of \$396,200, including an increase of \$30,000 under temporary assistance for meetings to cover interpretation and translation services required during peak times in connection with the annual Commission sessions and meetings of committees, intergovernmental and special bodies, and ad hoc ministerial conferences.

*Consultants and experts*

- 16.9 The estimated requirements of \$43,700 would cover the cost of consultants to provide expertise in connection with the preparation of special thematic studies as may be mandated by the Commission.

*Travel*

- 16.10 The estimated requirements of \$339,600 relate to the travel costs of conference-servicing staff detailed from New York and Geneva to service the Commission sessions and other meetings held under the auspices of ESCAP.

*Contractual services*

- 16.11 The estimated requirements of \$85,200 relate to contractual editing required for documentation submitted to the intergovernmental bodies, in particular for the annual *Economic and Social Survey of Asia and the Pacific*.

*General operating expenses*

- 16.12 The estimated requirements for hospitality and miscellaneous services during the holding of the Commission sessions and its subsidiary bodies would amount to \$6,800. The reduction of \$13,800 relates to the completion of the conference complex, which obviates the need for rental of furniture and equipment during the sessions.

*Supplies and materials*

- 16.13 An estimated amount of \$27,500 is proposed for supplies and materials required for the holding of the Commission sessions and other meetings.

- 16.14 The Office of the Executive Secretary provides overall direction, supervision and management of the secretariat and substantive and support services to the Commission and its subsidiary bodies; and promotes economic and social development and regional cooperation among the member and associate member countries of the Commission through the implementation of its legislative mandates and the approved programme of work.

**Resource requirements (at current rates)***Posts*

- 16.15 The staff resources would comprise four posts in the Professional category and above and seven Local level posts.

*Consultants and experts*

- 16.16 The estimated requirements of \$23,700 relate to consultants to provide expertise to undertake research and an overview of new and emerging needs in the work of the Commission.



*Travel*

- 16.17 The estimated requirements of \$165,800 relate to travel of the Executive Secretary and his immediate staff to attend meetings within and outside the region, for consultations with Governments and intergovernmental and non-governmental organizations and for coordination with other United Nations entities.

## C. Programme of work

- 16.18 Programme 31, Regional cooperation for development in Asia and the Pacific, of the medium-term plan for the period 1992-1997, as revised (A/47/6/Rev.1), provides the framework for the activities to be undertaken by ESCAP during the biennium 1996-1997. These activities are described under the six subprogrammes presented below. The resource distribution of the programme of work may be seen under the relevant subprogrammes.

- 16.20 The activities carried out under the subprogramme during the biennium 1994-1995 focused on structural changes, economic restructuring and policy reforms, and consisted of research and operational activities with the objective of strengthening institutional capacities, skill development and promoting trade, investment and technology linkages in the region.
- 16.21 Activities during the biennium 1996-1997 will aim at further spreading the development dynamism being experienced by an increasing number of developing countries in the Asia-Pacific region and will focus on analytical perspectives on economic development issues, strategies and policies; and identifying and analysing emerging development challenges facing the countries of the region, as well as the deepening trends towards greater complementarity and interdependence among them.
- 16.22 Efforts will be intensified to assist the developing members and associate members of the Commission in the implementation of the agreements of the Uruguay Round of multilateral trade negotiations. The potential offered by the growing prospects for intraregional trade, investment and technology transfer and industrial complementarities will be pursued, and regional, subregional and inter-subregional cooperation will be fostered. Trade efficiency measures, including business process re-engineering, will be promoted and stimulated through increased use of recent developments in information and communication technologies, with special attention to the role of the private sector.
- 16.23 Intensified efforts will be made to enable greater participation of the least developed and island developing countries and the disadvantaged economies in transition in the mainstream of the region's economic development.

**Activities***1. International cooperation*

*External relations.* Cooperation and liaison with governmental and non-governmental institutions and organizations in strengthening analytical perspectives on economic development issues, industrial and technological development and strategies and policies on trade and investment issues, and, with subregional organizations, to promote inter-subregional cooperation.

- (b) *Group training, seminars and workshops.* Macroeconomic management and policy reform; Agenda for Development as a basis for strengthening regional economic cooperation; Regional Forum for Sustainable Industrial Development and Restructuring in Asia and the Pacific; export-oriented small and medium industries, including adoption of ISO 9000; industrial investment technology flows and consultancy services for emerging technologies in manufacturing industries; industrial and technological skills; agricultural and allied industries and national capacity-building for diversification of trade; intra- and inter-subregional cooperation in trade and investment; intraregional trade and investment policies and prospects; regional cooperation in trade efficiency and business process re-engineering; promotion of exports of developing countries, with particular emphasis on least developed and Pacific island countries and developing economies in transition; implementation of the agreements of the Uruguay Round of multilateral trade negotiations and their impact on Asian and Pacific economies and emerging issues related to international trade, investment flows and technology transfer; trade/transit facilities for land-locked countries; networks of institutional support for development of trade and investment flows; promotion of women's participation in economic development; and strengthening of regional information services for trade and investment.

- 16.24 The estimated requirements relate to 35 posts in the Professional category and above and 29 Local level posts. It is proposed to redeploy one P-4 and one Local level post from programme support to strengthen the activities relating to trade and trade-related investment policies. It is also proposed to redeploy one P-3 post to subprogramme 3, Poverty alleviation through economic growth and social development, and one P-2 post to subprogramme 2, Environment and sustainable development.

*Consultants and experts*

- 16.25 The estimated requirements of \$153,000 relate to expert assistance in the preparation of specialized reports and studies (\$95,200) and the convening of the ad hoc expert group meetings referred to above (\$57,800).

*Travel*

- 16.26 The estimated requirements of \$144,100 relate to attendance at meetings of United Nations bodies and other intergovernmental organizations, servicing of meetings, advisory services and consultations with Governments and relevant authorities, and data collection for the implementation of the programme of work.

*Contractual services*

- 16.27 The estimated requirements of \$88,600 relate to the printing of various publications of the subprogramme.

16.28 The activities under this subprogramme will aim at strengthening the capability of ESCAP members and associate members in environmental and natural resource management; integration of environmental considerations into economic policy decision-making; transfer of environmentally sound technologies; sustainable rural and urban development; population and sustainable development; and natural disaster reduction.

16.29 During the biennium 1996-1997, work will focus on practical actions in the following specific areas: capacity-building for sustainable development; environmental protection; integration of environmental considerations into economic decision-making; energy development and management; mineral resource assessment, development and management; land-use planning and management; assessment and integrated development and management of water resources; natural disaster reduction; space technology applications for sustainable development; transfer of environmentally sound technologies; environmentally friendly crop protection; assessment of demographic change in the environmental context; environment database development; and environmentally sound and sustainable rural and urban development.

**Activities***1. International cooperation*

*External relations.* Liaison and cooperation with intergovernmental and non-governmental organizations on matters relating to all aspects of the subprogramme, in particular with the Coordinating Committee for Coastal and Offshore Geoscience Programmes in East and South-East Asia, the Typhoon Committee, the Panel on Tropical Cyclones and the Interim Committee for Coordination of Investigations of the Lower Mekong Basin.

- (b) *Group training, seminars and workshops.* Environmentally sound and sustainable development in Asia and the Pacific; environmental awareness and management; resource conservation and energy efficiency; new and renewable sources of energy; energy resource options, technologies and investment (2); power-system planning and maintenance; mineral exploration techniques and evaluation methodologies for resource assessment, and environmental management of mineral resources development; economic geology, mineral resource economics and legislation, and investment promotion in mineral exploration and mining; geological factors in land-use planning and resource accounting; integrated marine policies and non-living marine resources assessment and development; water pricing, water saving and economic use of water; protection of water resources and aquatic ecosystems; investment promotion for water and sanitation, the role of women in water for sustainable development and natural hazard reduction; implementation of the Beijing declaration on space technology applications for environmentally sound and sustainable development in Asia and the Pacific, and the regional strategy and action plan on space applications for sustainable development; regional space applications programme; remote sensing and GIS for land and sea resources management and for tropical ecosystem monitoring; strengthening of national capabilities in space applications for development; monitoring, mapping and sampling techniques for environment and natural resources management; integration of environmental considerations into economic decision-making; assessment of the establishment of a regional cooperative policy mechanism to promote the transfer of environmentally sound technologies; population and environment; promotion of healthy cities and settlements upgrading (2); environmental protection and urban development in secondary cities; and environmentally friendly concepts of crop protection and development and management of agro-chemicals in support of sustainable agricultural development.

### 6. *Coordination, harmonization and liaison*

Liaison and cooperation with organizations and entities of the United Nations system and other international organizations active in areas related to the subprogramme, including the Inter-Agency Committee on Environment and Sustainable Development in Asia and the Pacific; the Inter-Agency Task Forces on Water for Asia and the Pacific and the Implementation of the Strategy and Action Plan on Space Applications for Sustainable Development in Asia and the Pacific.

**Resource requirements (at current rates)***Posts*

- 16.30 The estimated requirements relate to 26 posts in the Professional category and above and 16 Local level posts. It is proposed to redeploy one P-2 post from subprogramme 1, Regional economic cooperation, to strengthen capacity-building, coordination, monitoring and review of the implementation of Agenda 21; and one Local level post from programme support.

*Consultants and experts*

- 16.31 The estimated requirements of \$78,900 relate to consultants to provide expertise for the preparation of specialized reports and publications (\$45,200) and to the convening of the expert group meetings listed above (\$33,700).

*Travel*

- 16.32 The estimated requirements of \$100,200 relate to attendance at sessions of the Commission on Sustainable Development, meetings related to the implementation of Agenda 21 and the Committee on Natural Resources, liaison with regional and international organizations active in the field of work, and collection of information and data for the publications under the subprogramme.

*Contractual services*

- 16.33 The estimated requirements of \$70,300 relate to the printing and binding of publications.

- 16.34 The objectives of this subprogramme are to increase the understanding and improve the quality and availability of data and analyses of poverty trends, issues and problems, as well as to improve national capabilities in enhancing the quality of social services to meet the basic needs of the poor in Asia and the Pacific. In previous bienniums, those objectives were met through a series of parliamentary, research, information and technical assistance activities, with emphasis on mobilizing government action through the adoption of regional plans of actions.
- 16.35 Activities for the biennium 1996-1997 will focus on assisting member countries in their efforts to alleviate poverty through economic growth, investment to increase the productivity of the poor, improved access to income-earning opportunities, and enhancement of the quality of life through an improved social services delivery system. The work programme will also address the impact of macroeconomic liberalization on poverty alleviation; social security and services for the poor; human resources development for the poor; population; urbanization; rural development; women in development; and the impact of technology on the poor.

- 16.36 The work will be carried out under the guidance of the Committee on Poverty Alleviation through Economic Growth and Social Development.

### Activities

#### 1. *International cooperation*

*External relations.* Liaison and cooperation with intergovernmental and non-governmental organizations on matters relating to the subprogramme.

#### 2. *Parliamentary services*

It is also proposed to redeploy one P-4 post and one P-2 post from programme support and one P-3 post from subprogramme 1, Regional economic development, to strengthen the substantive activities of this subprogramme.

*Consultants and experts*

- 16.38 The estimated requirements of \$125,700 relate to consultants to provide expertise in the preparation of specialized studies and publications (\$60,600) and for the convening of ad hoc expert group meetings (\$65,100).

*Travel*

- 16.39 The estimated requirements of \$123,100 are requested for representation at meetings of United Nations bodies, missions on data collection in the context of preparation of publications and various studies, provision of advisory services, consultations with Governments and governmental and non-governmental organizations, servicing of the Administrative Committee on Coordination Subcommittee on Rural Development, and participation in meetings related to rural poverty alleviation.

*Contractual services*

- 16.40 The estimated requirements of \$39,900 relate to the printing and binding of publications.

- 16.41 The focus of the subprogramme will be on improving the transport and communications services and infrastructural facilities of the developing countries in the region; and increasing their natural capabilities in institutional development in line with the strategic themes and related issues identified for phase II (1992-1996) of the Transport and Communications Decade for Asia and the Pacific and with the New Delhi action plan on infrastructure development in Asia and the Pacific.
- 16.42 Recognizing that the provision of transport and communications infrastructure and services is a key requirement for economic growth, the activities under this subprogramme have been designed to provide maximum support to the economic growth of the countries in the region. Other significant aspects of the subprogramme are the analysis of problems in relation to infrastructure development needs and the strengthening of inter-agency coordination and cooperation in the field of transport and communications at the regional level.

**Activities***1. International cooperation*

*External relations.* Cooperation with and support to other governmental, non-governmental and intergovernmental organizations on matters related to the subprogramme.

*2. Parliamentary services*

- (a) *Parliamentary documentation.* Report to Economic and Social Council on phase II of the Transport and Communications Decade for Asia and the Pacific; annual reports to the Commission on the progress of work carried out under this subprogramme (2); six reports to the Committee on Transport and Communications; three reports to the meeting of ministers on infrastructure;
- (b) *Substantive services.* Substantive and technical services will be provided to the meetings of the Committee on Transport and Communications; and the meeting of ministers on infrastructure;
- (c) *Ad hoc expert groups and related work.* Expert group meeting on financing and administration of rural infrastructure.

It is proposed to convert a temporary P-3 post to an established post dealing with the implementation of the New Delhi action plan on infrastructure development in Asia and the Pacific, given the continuing nature of the plan.

### *Consultants and experts*

- 16.44 The estimated resource requirements of \$23,000 relate to specialized expertise for the preparation of publications (\$11,800) and for the convening of one ad hoc expert group meeting (\$11,200).

### *Travel*

- 16.45 The estimated requirements of \$54,400 relate to travel of staff for fact-finding missions and data collection, consultations with Governments, United Nations bodies and the specialized agencies, and participation in national, regional and inter-agency meetings, including consultations with ESCWA on phase II of the Transport and Communications Decade for Asia and the Pacific.

*Contractual services*

16.46 The estimated requirements of \$5,700, relate to the printing of publications.

- 16.47 During the biennium 1996-1997, the subprogramme will continue to assist member countries and groups of countries in developing and improving their capability to identify, collect, process, analyse and utilize the data needed for the formulation, monitoring and evaluation of development plans and policies; improve the maintenance, dissemination and availability of data on the region through the gathering of demographic, social, economic and other statistics; and foster the utilization of modern information technology in the public sector in order to strengthen the ability of the countries in the region to plan and manage economic and social development, both at central and local levels.
- 16.48 Activities will also include the implementation of the 1993 System of National Accounts and the development of statistics on services; intensification of work on gender statistics and on the development and utilization of data on poverty; initial preparations for the year 2000 round of population and housing censuses; and the further improvement of environment statistics and environmental and natural resource accounting. Effort will be concentrated on fully operationalizing the ESCAP statistical information system, including provision of on-line access, and on promoting electronic interchange and networking among national statistical offices of the region. Emphasis will be placed on developing the Committee on Statistics as the focus of regional statistical development, in line with the recommendations of the United Nations Statistical Commission.

**Activities***1. International cooperation*

*External relations.* Cooperation and liaison of statistical activities undertaken in the programme of work with related activities undertaken by intergovernmental and non-governmental organizations in the region.

*2. Parliamentary services*

- (a) *Parliamentary documentation.* Report to the Commission on the progress of work carried out under the subprogramme; and five reports to the Committee on Statistics;
- (b) *Substantive services.* Substantive and technical services will be provided to the meetings of the Committee on Statistics;
- (c) *Ad hoc expert groups.* One ad hoc expert group to examine topics to be designated by the Committee on Statistics.

### 3. *Published material*

- (a) *Twenty-six recurrent publications.* (i) *Statistical Newsletter* (8); (ii) *Government computerization newsletter* (4); (iii) *Statistical Yearbook for Asia and the Pacific* (2); (iii) *Foreign Trade Statistics of Asia and the Pacific* (2); (iv) *Statistical Indicators for Asia and the Pacific* (8); and (v) *Asia-Pacific in Figures* (2);
- (b) *Seven non-recurrent publications.* (i) Statistical profiles by subregion (2); (ii) regional compendium of environmental statistics; (iii) statistical charts on thematic topics (2); and (iv) technical publications on socio-economic and environment statistics (2);
- (c) *Technical materials.* Development and maintenance of the ESCAP statistical information system; ad hoc statistical information services through conventional means and on-line access; and distribution of data on diskettes and/or CD-ROM.

### 4. *Operational activities (XB)*

- (a) *Advisory services.* Services on organizational and institutional issues affecting national statistical services; implementation of the 1993 System of National Accounts; economic, social and demographic statistics; electronic interchange and networking; design and development of government information systems; and technical and substantive support to the Statistical Institute for Asia and the Pacific;
- (b) *Group training, including seminars, and workshops.* Improved management and organization of national statistical services; economic statistics, including implementation of the revised System of National Accounts and the International Comparison Programme; social and demographic statistics; environment statistics and environmental accounting; and design and development of information systems.

### 5. *Coordination, harmonization and liaison*

Coordination with and inputs to the Administrative Committee on Coordination machinery and other bodies, organizations and departments within the United Nations system on statistical activities.

## Resource requirements (at current rates)

### *Staff costs*

- 16.49 The estimated requirements relate to 8 posts in the Professional category and above and 15 Local level posts.

### *Consultants and experts*

- 16.50 The estimated requirements of \$36,000 relate to consultants to provide expertise in the preparation of specialized publications and dissemination of outputs from the ESCAP statistical information system (\$24,800); and for the convening of an expert group meeting (\$11,200).

### *Travel*

- 16.51 The estimated requirements of \$45,900 relate to participation in regional and inter-agency meetings, consultations with Governments and data collection. The increase of \$8,600 is due to the change in the periodicity of the meetings of the Statistical Commission Working Group on International Statistical Programmes and Coordination from biennial to annual and to the expanded role of ESCAP in coordination.

### *Contractual services*

- 16.52 The estimated requirement of \$51,100 relates to the printing of publications.

- 16.53 The main orientation of work will be to assist the least developed countries in achieving the goals set out in the Programme of Action for the Least Developed Countries for the 1990s. The secretariat is undertaking a comprehensive mid-term review of the implementation of the Programme of Action to assess the achievements that have been made and to recommend measures for more effective implementation of the Programme of Action. The focus of work for the biennium 1996-1997 will be on enhancing effectiveness of action and measures at the national level; capacity-building; providing support in the implementation of ongoing economic reforms in the least developed countries with a view to improving macroeconomic management, relaxing direct controls, enhancing domestic resource mobilization, promoting private sector development, reforming public enterprises, attracting a larger inflow of foreign investment and technology, and instituting more effective measures to redress social issues, particularly with regard to alleviating poverty, human resources development and protecting the environment. Attention will also be given to the question of adequacy of resource flows to the least developed countries, including issues related to the quality of such resources, matching assistance to needs and effective utilization of aid on the part of recipient countries.
- 16.54 The Programme of Action for the Sustainable Development of Small Island Developing States, adopted at the Global Conference in 1994, calls on the Commission to coordinate the implementation of the conference outcomes at the regional level, to act as a point of liaison between the United Nations agencies and the Department for Policy Coordination and Sustainable Development at Headquarters and between the United Nations agencies at the regional and subregional levels; to report on the implementation of the Programme of Action at the regional level; and to assist regional and subregional organizations and mechanisms involved in the promotion of sustainable development. The Special Body on Pacific Island Developing Countries will provide the forum for the dialogue and exchange of experience between the countries of the ESCAP region.
- 16.55 Activities during the biennium 1996-1997 will also address the special problems of the land-locked countries, in particular as regards transport and transit trade. These activities will lead to recommendations for suitable measures to solve these problems in accordance with international legal instruments.

## Activities

### 1. *International cooperation*

*External relations.* Liaison and cooperation with intergovernmental and non-governmental organizations on issues related to the least developed, land-locked and Pacific island developing countries in support of the programme of work.

### 2. *Parliamentary services*

- (a) *Parliamentary documentation.* Five reports to the Commission;
- (b) *Substantive services.* Substantive and technical services will be provided to the Special Body on Least Developed and Land-locked Developing Countries, third session (1997); and the Special Body on Pacific Island Developing Countries, fourth session (1997).

### 3. *Published material*

*Nine non-recurrent publications.* (i) Follow-up to the mid-term review of progress in the implementation of the Programme of Action for the Least Developed Countries for the 1990s; (ii) overcoming institutional constraints of least developed countries in implementing macroeconomic policies; (iii) increasing efficiency in resource management in the least developed countries; (iv) population and development in the least developed countries; (v) island developing countries; (vi) policy and institution-building issues associated with increased trade and investment, particularly with east and south-east Asia; (vii) manual for the design and implementation of economic stabilization, liberalization and deregulation initiatives in the Pacific island developing countries; (viii) study on shipping and port capacities in the island developing countries; and (ix) development of policy options for replacing ageing ships in the Pacific island countries.

### 4. *Operational activities (XB)*

- (a) *Advisory services.* Services on economic reforms in the least developed countries; economic and financial management in Pacific island developing countries; demographic issues in the Pacific island

developing countries; institutional capability-building, including private sector development for the promotion of industrial investment and technology transfer; and promotion of sustainable development in small island developing States;

- (b) *Group training, including seminars and workshops.* Follow-up to the mid-term review of progress in the implementation of the Programme of Action for the Least Developed Countries for the 1990s; improving the access of women to formal credit and financial institutions in selected least developed countries; overcoming institutional constraints of least developed countries in implementing macroeconomic policies; increasing efficiency in resource management in the least developed countries; policy and institution-building for enhanced trade and investment in the Pacific island developing countries; economic stabilization, liberalization and deregulation in the Pacific island developing countries; demographic issues in the Pacific island developing countries; development of freight forwarding and multimodal transport in the land-locked countries; policy reorientation and capability-building for effective industrial and technological development, including promotion of industrial investment and technology transfer.

#### 5. *Coordination, harmonization and liaison*

Coordination with and inputs to the Administrative Committee on Coordination machinery and other bodies, organizations and departments within the United Nations system on activities related to the subprogramme.

#### Resource requirements (at current rates)

##### *Posts*

- 16.56 The estimated requirements relate to six posts in the Professional category and above and one Local level post. It is proposed to establish one P-4 post for the follow-up to the Global Conference on the Sustainable Development of Small Island Developing States. Provision under general temporary assistance was made for that purpose in 1995.

##### *Other staff costs*

- 16.57 The provision of \$53,400 for general temporary assistance for the follow-up to the Global Conference on the Sustainable Development of Small Island Developing States would be discontinued in connection with the proposed creation of one P-4 post mentioned above.

##### *Consultants and experts*

- 16.58 The estimated requirements of \$15,300 relate to consultants to provide expertise in the preparation of specialized publications and studies.

##### *Travel*

- 16.59 The estimated requirements of \$45,900 relate to attendance at the sessions of the Trade and Development Board in Geneva on matters related to the least developed countries and the sessions of the South Pacific Forum in Suva, Fiji, on matters related to the Pacific island developing countries, consultations with Governments, data collection for studies and publications and provision of advisory services.

16.60 Programme support comprises programme management, information services, conference services and administration and common services.

**Activities***1. Programme management*

- (a) Activities include overall coordination of programme planning, budgeting, monitoring and evaluation services to the Commission and other meetings, collaboration with other entities and organizations of the United Nations system and appropriate outside institutions, mobilization of extrabudgetary resources and management of technical cooperation activities;
- (b) *Parliamentary documentation.* Annual report to the Commission on technical cooperation activities and on economic and technical cooperation among developing countries; biennial report to the High-level Committee on the Review of Technical Cooperation among Developing Countries; and annual reports to the Commission on the implementation of the programme of work;
- (c) Two workshops on national focal points for technical cooperation among developing countries.

*2. Information services*

Activities include full coverage of the work of the Commission by preparing press releases, summaries of proceedings and debates, special brochures, booklets, wall charts, information kits, films, videotapes, briefings and exhibitions; and library services.

*3. Conference services*

Activities include the provision of conference services to meetings of the policy-making organs and other intergovernmental meetings held under the auspices of ESCAP; and translation and printing of documents and publications.

*4. Administration and common services*

These services relate to human resources management, financial administration and resource planning, and use of common services to support the implementation of the work programme. Activities will include (a) recruitment, placement, career development, staff training, staff administration, staff counselling and medical services; (b) financial management, control and treasury services; (c) general services, including

security and safety, communications, procurement, transportation; and (d) electronic data-processing services.

#### Resource requirements (at current rates)

##### *Posts*

- 16.61 The estimated resources relate to 62 posts in the Professional category and above, 229 Local level posts and three Field Service posts. The reclassification from Local level to P-2 of a post for a building management officer is proposed as a result of the classification exercise carried out in ESCAP. It is also proposed to redeploy one P-4 and one Local level post to subprogramme 1, Regional economic cooperation; one P-4 and one P-2 post to subprogramme 3, Poverty alleviation through economic growth and social development; and one Local level post to subprogramme 2, Environment and sustainable development. The decrease of \$765,600 is due to these redeployments.

##### *Other staff costs*

- 16.62 The estimated requirements of \$494,600 relate to general temporary assistance (\$267,900) for assistance during peak workload periods and to cover the replacement of staff on extended sick leave and maternity leave, and a provision (\$226,700) for overtime in peak workload periods and night differential.

##### *Travel*

- 16.63 The estimated requirements of \$71,000 relate to travel for consultations at Headquarters and ESCAP institutes on programme coordination and administrative, financial and personnel matters.

##### *Contractual services*

- 16.64 The estimated requirements of \$229,700 relate to language training (\$55,300); external printing of publications and studies (\$16,000); exhibits and other public information requirements (\$5,100); and data processing (\$153,300). The increase of \$58,100 is due to increased requirements for software acquisition and systems design and development, partially offset by the discontinuation of provisions related to training to be centrally administered at Headquarters.

##### *General operating expenses*

- 16.65 The estimated requirements of \$4,399,800 comprise the following: (i) \$1,317,000 for rental and maintenance of premises, including a reduction of \$78,200, for minor alterations, supplies and other miscellaneous expenses related to the maintenance of premises; (ii) \$1,805,300 for utilities, including water and electricity; (iii) \$117,500, including an increase of \$38,900, for rental of office equipment for the secretariat and the conference complex; (iv) \$39,900, including a decrease of \$30,400, for rental and maintenance of equipment; (v) \$680,900 for communications; (vi) \$13,200 for official functions; (vii) \$100,100, including an increase of \$78,100, for maintenance of transportation, communications, and office automation equipment; and (viii) \$325,900 for miscellaneous services, such as insurance, freight and related costs, and other services.

##### *Supplies and materials*

- 16.66 An estimated amount of \$692,000 would be required for office supplies, internal reproduction supplies and data-processing supplies.

##### *Equipment*

- 16.67 An estimated provision of \$1,468,100 would be required as follows: \$207,500, including an increase of \$71,700, for replacement of office equipment as part of the replacement schedule; \$945,000, including an increase of \$37,100, for acquisition of automation equipment and related software; \$85,700, including an increase of \$52,700, for replacement of printing equipment and conference-servicing equipment; \$51,300 for transportation equipment; \$25,600 for communication equipment; and \$153,000 for other equipment, including building maintenance, medical and security and safety equipment.
