RESOLUTION ADOPTED BY THE GENERAL ASSEMBLY

[on the report of the Third Committee (A/48/632/Add.4)]

48/141. <u>High Commissioner for the promotion and protection of all human rights</u>

The General Assembly,

<u>Reaffirming</u> its commitment to the purposes and principles of the Charter of the United Nations,

Emphasizing the responsibilities of all States, in conformity with the Charter, to promote and encourage respect for all human rights and fundamental freedoms for all, without distinction as to race, sex, language or religion,

<u>Emphasizing</u> the need to observe the Universal Declaration of Human Rights <u>1</u>/ and for the full implementation of the human rights instruments, including the International Covenant on Civil and Political Rights, <u>2</u>/ the International Covenant on Economic, Social and Cultural Rights, <u>2</u>/ as well as the Declaration on the Right to Development, <u>3</u>/

<u>Reaffirming</u> that the right to development is a universal and inalienable right which is a fundamental part of the rights of the human person,

<u>Considering</u> that the promotion and the protection of all human rights is one of the priorities of the international community,

<u>Recalling</u> that one of the purposes of the United Nations enshrined in the Charter is to achieve international cooperation in promoting and encouraging respect for human rights,

<u>Reaffirming</u> the commitment made under Article 56 of the Charter to take joint and separate action in cooperation with the United Nations for the achievement of the purposes set forth in Article 55 of the Charter,

Emphasizing the need for the promotion and protection of all human rights to be guided by the principles of impartiality, objectivity and non-selectivity, in the spirit of constructive international dialogue and cooperation,

<u>Aware</u> that all human rights are universal, indivisible, interdependent and interrelated and that as such they should be given the same emphasis,

<u>Affirming</u> its commitment to the Vienna Declaration and Programme of Action, $\frac{4}{4}$ adopted by the World Conference on Human Rights, held at Vienna from 14 to 25 June 1993,

<u>Convinced</u> that the World Conference on Human Rights made an important contribution to the cause of human rights and that its recommendations should be implemented through effective action by all States, the competent organs of the United Nations and the specialized agencies, in cooperation with non-governmental organizations,

<u>Acknowledging</u> the importance of strengthening the provision of advisory services and technical assistance by the Centre for Human Rights of the Secretariat and other relevant programmes and bodies of the United Nations system for the purpose of the promotion and protection of all human rights,

<u>Determined</u> to adapt, strengthen and streamline the existing mechanisms to promote and protect all human rights and fundamental freedoms while avoiding unnecessary duplication,

<u>Recognizing</u> that the activities of the United Nations in the field of human rights should be rationalized and enhanced in order to strengthen the United Nations machinery in this field and to further the objectives of universal respect for observance of international human rights standards,

<u>Reaffirming</u> that the General Assembly, the Economic and Social Council and the Commission on Human Rights are the responsible organs for decisionand policy-making for the promotion and protection of all human rights,

<u>Reaffirming</u> the necessity for a continued adaptation of the United Nations human rights machinery to the current and future needs in the promotion and protection of human rights and the need to improve its coordination, efficiency and effectiveness, as reflected in the Vienna Declaration and Programme of Action and within the framework of a balanced and sustainable development for all people,

<u>Having considered</u> the recommendation contained in paragraph 18 of section II of the Vienna Declaration and Programme of Action,

1. <u>Decides</u> to create the post of the High Commissioner for Human Rights;

2. Decides that the High Commissioner for Human Rights shall:

(a) Be a person of high moral standing and personal integrity and shall possess expertise, including in the field of human rights, and the general knowledge and understanding of diverse cultures necessary for impartial, objective, non-selective and effective performance of the duties of the High Commissioner;

 (\underline{b}) Be appointed by the Secretary-General of the United Nations and approved by the General Assembly, with due regard to geographical rotation, and have a fixed term of four years with a possibility of one renewal for another fixed term of four years;

(<u>c</u>) Be of the rank of Under-Secretary-General;

3. <u>Decides</u> that the High Commissioner for Human Rights shall:

 (\underline{a}) Function within the framework of the Charter of the United Nations, the Universal Declaration of Human Rights, $\underline{1}/$ other international instruments of human rights and international law, including the obligations, within this framework, to respect the sovereignty, territorial integrity and domestic jurisdiction of States and to promote the universal respect for and observance of all human rights, in the recognition that, in the framework of the purposes and principles of the Charter, the promotion and protection of all human rights is a legitimate concern of the international community;

(b) Be guided by the recognition that all human rights - civil, cultural, economic, political and social - are universal, indivisible, interdependent and interrelated and that, while the significance of national and regional particularities and various historical, cultural and religious backgrounds must be borne in mind, it is the duty of States, regardless of their political, economic and cultural systems, to promote and protect all human rights and fundamental freedoms;

(<u>c</u>) Recognize the importance of promoting a balanced and sustainable development for all people and of ensuring realization of the right to development, as established in the Declaration on the Right to Development; 3/

4. <u>Decides</u> that the High Commissioner for Human Rights shall be the United Nations official with principal responsibility for United Nations human rights activities under the direction and authority of the Secretary-General; within the framework of the overall competence, authority and decisions of the A/RES/48/141 Page 4

General Assembly, the Economic and Social Council and the Commission on Human Rights, the High Commissioner's responsibilities shall be:

(<u>a</u>) To promote and protect the effective enjoyment by all of all civil, cultural, economic, political and social rights;

 (\underline{b}) To carry out the tasks assigned to him/her by the competent bodies of the United Nations system in the field of human rights and to make recommendations to them with a view to improving the promotion and protection of all human rights;

 (\underline{c}) To promote and protect the realization of the right to development and to enhance support from relevant bodies of the United Nations system for this purpose;

 (\underline{d}) To provide, through the Centre for Human Rights of the Secretariat and other appropriate institutions, advisory services and technical and financial assistance, at the request of the State concerned and, where appropriate, the regional human rights organizations, with a view to supporting actions and programmes in the field of human rights;

(<u>e</u>) To coordinate relevant United Nations education and public information programmes in the field of human rights;

 (\underline{f}) To play an active role in removing the current obstacles and in meeting the challenges to the full realization of all human rights and in preventing the continuation of human rights violations throughout the world, as reflected in the Vienna Declaration and Programme of Action; 4/

(g) To engage in a dialogue with all Governments in the implementation of his/her mandate with a view to securing respect for all human rights;

 (\underline{h}) To enhance international cooperation for the promotion and protection of all human rights;

 (\underline{i}) To coordinate the human rights promotion and protection activities throughout the United Nations system;

(j) To rationalize, adapt, strengthen and streamline the United Nations machinery in the field of human rights with a view to improving its efficiency and effectiveness;

 (\underline{k}) To carry out overall supervision of the Centre for Human Rights;

5. <u>Requests</u> the High Commissioner for Human Rights to report annually on his/her activities, in accordance with his/her mandate, to the Commission on Human Rights and, through the Economic and Social Council, to the General Assembly;

6. <u>Decides</u> that the Office of the High Commissioner for Human Rights shall be located at Geneva and shall have a liaison office in New York;

7. <u>Requests</u> the Secretary-General to provide appropriate staff and resources, within the existing and future regular budgets of the United Nations, to enable the High Commissioner to fulfil his/her mandate, without

diverting resources from the development programmes and activities of the United Nations;

8. <u>Also requests</u> the Secretary-General to report to the General Assembly at its forty-ninth session on the implementation of the present resolution.
