1. Mrs. EMERSON (Portugal), introducing draft resolution A/C.5/49/L.34, which had been the subject of informal consultations, drew attention to the provisions of paragraphs 1, 5, 7, 13 and 14 and, in particular, to the financial provisions in paragraphs 9, 10 and 12. She recommended that the draft resolution should be adopted by consensus.

2. Draft resolution A/C.5/49/L.34 was adopted.

3. The CHAIRMAN said that the Committee had concluded its consideration of agenda item 124 and requested the Rapporteur to report thereon direct to the General Assembly.

The CHAIRMAN drew attention to a note by the Secretary-General (A/49/102/Add.1) advising the General Assembly of the resignation of Mrs. Norma Goicochea Estenoz (Cuba) from the membership of the Committee on Contributions. The General Assembly would be required to appoint a person to fill the unexpired portion of the term of office of Mrs. Goicochea Estenoz, namely until 31 December 1995. The Secretary-General also informed the General Assembly that the Government of Cuba had nominated Mr. Enrique Moret Echeverría to fill that vacancy, a nomination which had the support of the Group of Latin American and Caribbean States. Since there were no other candidates, he took it that the Committee wished to recommend by acclamation the appointment of Mr. Moret Echeverría to the Committee on Contributions for a term commencing on the date on which the General Assembly approved the appointment and expiring on 31 December 1995.

5. It was so decided.

6. The CHAIRMAN said that the Committee had concluded its consideration of agenda item 17 (b) and requested the Rapporteur to report thereon direct to the General Assembly.
