SISTEMA GENERALIZADO DE PREFERENCIAS

Esquema del Japón para el ejercicio económico de 1995

Nota de la secretaría de la UNCTAD

La secretaría de la UNCTAD ha recibido del Gobierno del Japón una comunicación relativa a las modificaciones introducidas en su esquema de preferencias generalizadas para el ejercicio económico de 1995, que son las siguientes:

"1. Nuevos beneficiarios del trato preferencial

Los países que figuran a continuación han sido designados como nuevos beneficiarios del trato preferencial a partir del 1º de abril de 1995: Albania, Armenia, Belarús, Estonia, Georgia, Kazajstán, la ex República Yugoslava de Macedonia, Letonia, Lituania, República de Moldova, Sudáfrica, Turkmenistán y Ucrania.

2. Nuevos beneficiarios de medidas especiales en favor de los países menos adelantados en virtud del esquema

A partir del 1º de abril de 1995, Angola puede acogerse a las medidas especiales en favor de los países menos adelantados en virtud del esquema. Botswana, país beneficiario de las medidas especiales en favor de los países menos adelantados, pasó a ser beneficiario del trato preferencial ordinario a partir del 1º de abril de 1995.

3. Anuncio de los límites máximos para el ejercicio económico de 1995

Se anuncian oficialmente los límites máximos para el ejercicio económico de 1995 que figuran en el anexo.

4. Reforma del esquema para la aplicación de la Ronda Uruguay

Se aplican diversas reducciones arancelarias a los productos agrícolas que figuran en el anexo, entre los cuales 12 productos tropicales, a partir del 1º de abril de 1995, y a los productos de pesquería que figuran en el anexo a partir del 1º de enero de 1995, respectivamente."
