秘书处的说明

1. 大会第48/108号决议, 决定考虑到妇女地位委员会第37/7号决议,<sup>1</sup> 通过决议附件所载列的非政府组织、特别是发展中国家的非政府组织参加第四次妇女问题世界会议: 以行动谋求平等、发展与和平及其筹备进程并做出贡献的方式。

2. 本说明的目的在于向作为会议筹备机关的妇女地位委员会提供关于不具有经济及社会理事会咨商地位或不在理事会名册上但已要求认可参加会议及其筹备进程的非政府组织的有关资料。非政府组织提出申请的截止日期为1995年1月13日。但会议秘书处决定1995年1月30日前收到的申请均予考虑。

3. 会议秘书处已按照大会第48/108号决议评估了下文附件所列的302个组织, 并认为均与会议工作有相关性。因此, 会议秘书处建议作为会议筹备机关的妇女地位委员会认可这些组织参加。妇女地位委员会在其1994年第三十八届会议上认可了102个非政府组织。<sup>2</sup> 任何其他非政府组织的名单将作为本说明增编开列。
