Note by the Secretary-General

1. By a communication dated 8 October 1980, addressed to States Parties to the Statute of the International Court of Justice, the Secretary-General drew attention to the vacancy in the International Court of Justice caused by the death, on 4 October 1980, of Judge Salah El Dine Tarazi (Syrian Arab Republic). In the same communication, the Secretary-General, in accordance with Article 5 of the Statute of the Court, invited national groups to undertake the nomination of candidates for the election of a judge to serve on the Court for the remainder of Judge Tarazi's term of office which will expire on 5 February 1985.

2. In his communication, the Secretary-General drew attention, <u>inter alia</u>, to the provision of Article 5, paragraph 1, of the Statute of the Court that nominations should be undertaken "within a given time", and he requested that nominations should be sent so as to reach him not later than 10 December 1980.

3. In accordance with Article 7 of the Statute of the Court, the Secretary-General has the honour to submit to the General Assembly and to the Security Council an alphabetical list of the candidates for the election to fill the vacancy in the Court caused by the death of Judge Tarazi nominated by national groups by 10 December 1980 (see annex).

4. The composition of the Court and the voting procedure to be followed in the General Assembly and in the Security Council are discussed in a memorandum by the Secretary-General, issued as document A/35/708-S/14283. <u>Curricula vitae</u> of the candidates will appear in document A/35/789-S/14314.
