Item 1. Election of officers

Rule 15 of the rules of procedure of the functional commissions of the Economic and Social Council (E/5975/Rev.1) provides that, at the commencement of the first meeting of a regular session, the Commission shall elect, from among the representatives of its members, a Chairman, one or more Vice-Chairmen and such other officers as may be required. At the second session, the Commission elected, in addition to a Chairman, four Vice-Chairmen, one of whom also served as Rapporteur.

The membership of the Commission in 1995 is given in annex II below.

Item 2. Adoption of the agenda and other organizational matters

Rule 7 of the rules of procedure provides that the Commission shall, at the beginning of each session, after the election of its officers, adopt the agenda for that session on the basis of the provisional agenda.

In decision 1994/300, the Economic and Social Council approved the provisional agenda for the third session of the Commission.

Item 3. <u>General discussion on progress in the implementation of Agenda 21,</u> <u>focusing on the cross-sectoral components of Agenda 21 and the critical</u> <u>elements of sustainability</u>

In 1995, in accordance with the multi-year thematic programme of work adopted by the Commission at its first session (E/1993/25/Add.1, chap. I, sect. A, annex), this item is to focus on the following chapters of Agenda 21: chapter 3 (Combating poverty); chapter 5 (Demographic dynamics and sustainability); chapter 8 (Integrating environment and development in decisionmaking); chapters 23-32 on strengthening the role of major groups; and chapter 40 (Information for decision-making).

At its second session, the Commission decided to review matters related to trade, environment and sustainable development, as well as consumption patterns, on an annual basis.

Item 4. Financial resources and mechanisms

At its first session, recognizing its mandate to review the adequacy of the financial resources available for the implementation of Agenda 21, the Commission decided to establish an Inter-sessional Ad Hoc Open-ended Working Group on Finance to assist it in its work.

At its second session, the Commission reconfirmed the mandate of the Working Group and decided that the Working Group would consider all issues related to the financial aspects of the transfer of environmentally sound technologies. The Working Group met from 6 to 9 March 1995. The Commission will have before it the report of the Working Group.

Item 5. <u>Education, science, transfer of environmentally sound technologies,</u> <u>cooperation and capacity-building</u>

In 1995, in accordance with the Commission's multi-year thematic programme of work, chapters 16, 34 and 35 of Agenda 21 are the focus of the cluster entitled "Education, science, transfer of environmentally sound technologies, cooperation and capacity-building".

10. At its second session, the Commission, taking into account the need for effective implementation of its functions related to the transfer of environmentally sound technologies, cooperation and capacity-building, decided that the functions of its Inter-sessional Ad Hoc Open-ended Working Group on Technology Transfer and Cooperation, established at its first session for a trial period of one year, would be carried out by the two ad hoc working groups as follows:

(a) The Inter-Sessional Ad Hoc Open-ended Working Group on Finance would consider all issues related to the financial aspects of the transfer of environmentally sound technologies;

(b) The Inter-Sessional Ad Hoc Open-ended Working Group on Sectoral Issues would consider technology transfer issues in relation to the specific sectoral issues under review in 1995, including the experience of individual countries.

Item 6. <u>Review of sectoral cluster: Land, desertification, forests and</u> biodiversity

In accordance with its multi-year thematic programme of work, the Commission reviews a different sectoral cluster each year. In 1995, the Commission is to review the cluster entitled "Land, desertification, forests and biodiversity" on the basis of the following chapters of Agenda 21:

(a) Integrated approach to the planning and management of land resources (chapter 10);

(b) Combating deforestation (chapter 11); and the Non-legally Binding Authoritative Statement of Principles for a Global Consensus on the Management, Conservation and Sustainable Development of All Types of Forests;

(c) Managing fragile ecosystems: combating desertification and drought (chapter 12); (d) Managing fragile ecosystems: sustainable mountain development (chapter 13);

(e) Promoting sustainable agriculture and rural development (chapter 14);

(f) Conservation of biological diversity (chapter 15).

At its first session, the Commission requested the Secretary-General to prepare thematic reports, corresponding to the Agenda 21 sectoral clusters to be included in the agendas of forthcoming sessions of the Commission, in accordance with its multi-year thematic programme of work.

At its second session, the Commission decided to establish an inter-sessional ad hoc open-ended working group composed of Governments, with a one-year mandate, which would nominate experts to assist the Commission in the preparation, in a coordinated and integrated way, of the examination of sectoral issues to be reviewed by the Commission at its third session, in accordance with the Commission's multi-year thematic programme of work - namely, the sectoral cluster entitled "Land, desertification, forests and biodiversity".

The Commission also decided that the Inter-sessional Ad Hoc Open-ended Working Group on Sectoral Issues would consider technology transfer issues in relation to the specific sectoral issues under review in 1995, including the experience of individual countries.

Item 8. <u>High-level meeting</u>

In resolution 47/191, the General Assembly recommended that the Commission adopt at its first session a multi-year thematic programme of work, including a high-level meeting, with ministerial participation, to have an integrated overview of the implementation of Agenda 21, to consider emerging policy issues and to provide necessary political impetus to the implementation of the decisions of the United Nations Conference on Environment and Development and commitments contained therein.

At its first session, the Commission decided that, as a rule, its highlevel meetings should last for a period of up to three days and that they should be integral parts of the session of the Commission and its decision-making process. The organization of work of the high-level meetings should, <u>inter alia</u>, provide for an open exchange of views among the participants and for holding informal meetings, as the need arose to resolve outstanding issues related to the work of the Commission that required high-level consideration. The result of the meeting could be a concise document, should the participants deem that appropriate.

Also at its first session, the Commission recommended that the report of the High-level Advisory Board on Sustainable Development, containing its expert advice on issues relating to the implementation of Agenda 21, be submitted to the Commission through the Secretary-General.
