He also participated in a series of diplomatic conferences held by the United Nations for the adoption of conventions for the codification of certain international legal issues, such as the ones on diplomatic relations (1961), the reduction of cases of statelessness (1961), consular relations (1963), the law of treaties (1968-1969), representation of States in their relations with international organizations of a universal character (1975) and succession of States in respect of treaties (1977-1978). He also participated in the elaboration by the General Assembly of the Convention on Special Missions (1969).

In addition to this activity related to drafting conventions, declarations, resolutions, reports, draft articles and comments by the above-mentioned organs, he contributed to the formulation and coordination of programmes related to the codification and progressive development of international law. He also directed or drafted studies and publications prepared by the Codification Division as requested by the General Assembly, and also an important amount of survey work for the International Law Commission and its Special Rapporteurs, about subjects such as international watercourses, law of treaties, international humanitarian law, succession of States, international responsibility of States, etc.

He was also in charge of the final revision of the contents, structure and presentation of the "Survey of international law" prepared by the Codification Division in 1970-1971 (International Law Commission Yearbook, 1971, vol. II, second part).
