#### Добавление

- 1. Во исполнение соответствующих резолюций Экономического и Социального Совета, и в частности резолюции 1986/35, Комиссия по правам человека на своей пятидесятой сессии должна избрать половину членского состава Подкомиссии и соответствующих заместителей, если это необходимо, по следующей сжеме: три члена от африканских государств; три от азиатских государств; один от восточноевропейских государств; три от латиноамериканских государств и три от западноевропейских и других государств.
- 2. В документах Е/СN.4/1994/85 и Add.1 и 2 Генеральный секретарь информировал Комиссию о фамилиях кандидатов и их заместителей, выдвинутых для избрания в Подкомиссию, которые были получены к 4 февраля 1994 года. В этих документах также содержатся представленные биографические данные кандидатов и заместителей.
- 3. После 4 февраля 1994 года получены дополнительные фамилии кандидатов и биографические данные. В настоящем документе содержится обновленный перечень фамилий кандидатов в члены Подкомиссии по состоянию на 16 февраля 1994 года.
