FOR THE FIFTY-FIRST SESSION OF THE COMMISSION

Note by the Secretary-General

If necessary, the draft provisional agenda will be amended in the light of any decisions which the Commission may take after the preparation of this document.

XXV. DRAFT PROVISIONAL AGENDA FOR THE FIFTY-FIRST
SESSION OF THE COMMISSION

1. Election of officers.
2. Adoption of the agenda.
3. Organization of the work of the session.
