Acreditación de las organizaciones no gubernamentales  
en la Cuarta Conferencia Mundial sobre la Mujer

Nota de la Secretaría

1. La Asamblea General, en su resolución 49/243 de 21 de abril de 1995, pidió que se prolongara el plazo de presentación de solicitudes para la acreditación de las organizaciones no gubernamentales en la Conferencia hasta el 28 de abril de 1995 y que el examen de esas solicitudes fuera transparente, de conformidad con los criterios establecidos en el anexo de la resolución 48/108.
2. La Asamblea General también pidió que la secretaria de la Cuarta Conferencia Mundial sobre la Mujer se comunicara por escrito con las organizaciones no gubernamentales que para el 15 de marzo de 1995 hubieran solicitado que se las acreditase en la Conferencia, pero que aún no se hubieran acreditado, y les informara de las razones por las cuales la secretaria no había enviado el nombre de la organización a la Comisión de la Condición Jurídica y Social de la Mujer a fines de acreditación, y que las invitara a presentar, en el plazo de cuatro semanas a partir de la fecha de envío de la comunicación escrita de la secretaria, información pertinente adicional con respecto a las calificaciones para su acreditación.
3. La secretaria siguió recibiendo nuevas solicitudes hasta el fin del nuevo plazo pedido por la Asamblea General, el 28 de abril de 1995. A principios de mayo la secretaria de la Conferencia también se comunicó por escrito con todas

las organizaciones no gubernamentales a las que se hace referencia en el párrafo 2 supra y les pidió que respondieran antes del 31 de mayo de 1995.

4. La presente nota tiene por objeto proporcionar al Consejo Económico y Social los nombres de las organizaciones no gubernamentales que, tras haber presentado sus solicitudes de acreditación en la Conferencia antes del 28 de abril de 1995, facilitaron la información y la documentación que necesitaba la secretaría de la Conferencia para recomendar su acreditación al Consejo Económico y Social, conforme a lo dispuesto en las resoluciones 48/108 y 49/243 de la Asamblea General. En el anexo I de la presente nota se incluye la lista de dichas organizaciones.

5. En el anexo I también se incluyen los nombres de las organizaciones que en un principio no cumplían los requisitos para el examen preliminar pero que, sobre la base de la información o documentación adicional presentada, parecen ser pertinentes a la labor de la Cuarta Conferencia Mundial sobre la Mujer y tener la competencia necesaria para participar en ella.

6. En el anexo II de la presente nota aparece la lista de organizaciones a que se hace referencia en la resolución 49/243 de la Asamblea General y que la secretaría de la Conferencia no está en condiciones de recomendar sobre la base de la información y la documentación que han presentado. Esas organizaciones se enumeran junto con un código que se refiere a las razones en que se funda la no recomendación, con arreglo a lo solicitado en el párrafo 6 de la resolución 49/243.

7. Los códigos correspondientes a la no recomendación que figuran en el anexo II representan las razones concretas en que se funda la falta de recomendación, dentro del marco amplio de "competencia y pertinencia" fijado en las directrices establecidas por la Asamblea General en su resolución 48/108 para efectuar el examen. Los códigos son los siguientes:

1. La organización era estrictamente local, o la información presentada no demostraba suficientemente que su composición y sus actividades tenían carácter nacional o internacional.
2. El objetivo o propósito principal de la organización no era claramente pertinente o parecía quedar fuera del ámbito sustantivo de la Cuarta Conferencia Mundial sobre la Mujer y de su proceso preparatorio.
3. No se suministró información suficiente para que la secretaría pudiera concluir su examen.
4. El grupo no era una organización no gubernamental reconocida o bona fide, o no aportó información que demostrara que se trataba de una organización constituida en el país en que tenía su sede.
