Introductory note

Pursuant to rule 8 of the Rules of Procedure of the Board, the Secretary-General of UNCTAD will submit during the session a draft provisional agenda for the first part of the forty-first session of the Board.

Item 1(d) - Provisional agenda for the pre-session executive session of the Board in September 1994

The Board may wish to request the Secretary-General of UNCTAD to draw up a draft provisional agenda in the light of developments nearer to the time of the session, and to submit it for approval to the consultative machinery established in accordance with paragraph 83 of the Cartagena Commitment.

Item 2 - Trade policies, structural adjustment and economic reform:

- Increased participation in international trade in goods and services by developing countries and economies in transition: some problems and opportunities

In paragraph 63 (1) of the Cartagena Commitment, the Conference stated that it is crucial to ensure the enhanced participation in the world economy of developing countries, as well as countries undergoing the process of transition to market economies.

In paragraph 128, the Conference agreed that the trade policy reforms, structural adjustment and trade liberalization efforts by developing countries should be supported by the international community through adequate improved market access and increased flows of financial resources.

In paragraph 129, the Conference invited member countries to support the transition of countries in Central and Eastern Europe to a market economy and to liberalize their trade regimes vis-à-vis all of them. The Conference held the view that it is important that discriminatory measures aimed specifically at these countries be abolished and that non-tariff measures which affect their exports be relaxed on a MFN basis. At the same time, the interests of the world economy would be best served if the trade regimes that are emerging in the Central and Eastern European countries are kept open to imports from all potential trading partners, without prejudice to preferential agreements under the relevant provisions of GATT. Special attention should be paid in this regard to trade with developing countries, in accordance with international commitments on differential and more favourable treatment for them.

In paragraph 129, the Conference also called for a periodic assessment of the above process by the Board and for UNCTAD to identify the opportunities resulting from the developments for the mutual benefit of developing countries and individual countries of Central and Eastern Europe.

The Board will have before it a report relating to the participation in international trade by developing countries and economies in transition, problems and opportunities for trade among economies in transition, and trade and economic cooperation between developing countries and economies in transition.

Item 3 - Developments and issues in the Uruguay Round of particular concern to developing countries

In its resolutions 45/206 of 21 December 1990 and 46/209 of 20 December 1991, the General Assembly invited the eighth session of the Conference to assess the outcome of the Uruguay Round. In the absence of an outcome at that stage, the Conference, in paragraph 144 of the Cartagena Commitment, requested the Trade and Development Board to analyze and assess the outcome of the Uruguay Round, in particular in areas of interest or concern to developing countries, and its impact on the international trading system.

The Board has continued to discuss developments in the Uruguay Round at its regular sessions. Its third executive session, on 27 April 1993, was devoted to discussions on this issue at a high level. The President's summing-up of discussions under this item at the first part of the fortieth session of the Board drew attention to the recognition that UNCTAD had an important role to play in the analysis and assessment of the outcome of the Round.

In its resolution 48/55, of 10 December 1993, on "International trade and development", the General Assembly reaffirmed the Message from the Trade and Development Board to the Governments participating in the Round (adopted by the Board at the second part of its thirty-ninth session).

On 15 December 1993 the Final Act embodying the results of the Uruguay Round was adopted by the Trade Negotiations Committee (TNC). The Final Act, which provides for the establishment of a World Trade Organization, will be formally signed by participants at the Ministerial Meeting of the TNC convened for this purpose in Marrakesh, Morocco (12-15 April 1994).

To assist the Board in launching its analysis and assessment of the outcome of the Round, the secretariat will submit, as a basis for discussion, a brief conference room paper.

Item 4 -

Sustainable development:

- The effect of internalization of external costs on sustainable development

By decision 402 (XXXIX) of 26 March 1993, on sustainable development, the Board decided that henceforth, at the first part of each of its annual sessions, it would consider a topic under the theme "Trade and environment", and that at its spring sessions it would consider another theme or themes on sustainable development. Annexed to the same decision, in response to General Assembly resolution 47/191, is a report on the Board's specific plans to implement Agenda 21.

In its conclusions 407 (XL) of 1 October 1993, on sustainable development, the Board noted that the broad convergence which had emerged from its discussions under this item included the view that the efforts of individual countries to promote the internalization of externalities should be encouraged and given wide international support.

In paragraph 4 of the same conclusions, the Board recommended that, at the second part of its fortieth session, it should consider the theme "The effect of the internalization of external costs on sustainable development".

Accordingly, the Board will have before it a report in which the basic principles for internalization, particularly the resource pricing principle, and the impact on sustainable development of policy-induced distortions, are discussed; the primary instruments for internalization are reviewed, and consideration given to the choice of an appropriate policy mix (chapter III). Chapter IV is devoted to the international dimension, focusing on cooperative instruments for internalization in the fields of finance, commodities, trade

and environmentally sound technologies. Chapter V contains the secretariat's conclusions and suggestions for future work in UNCTAD on internalization.

Item 5 - Review of progress in the implementation of the Programme of
Action for the Least Developed Countries for the 1990s

Pursuant to the relevant provisions of the Programme of Action, the Cartagena Commitment and General Assembly resolution 45/206, of 21 December 1990, the Board has undertaken, at each of its annual spring sessions since 1991, a global review of progress in the implementation of the Programme of Action.

In its resolution 48/171, of 21 December 1993, the General Assembly, inter alia, stressed the importance of effective follow-up and monitoring mechanisms for the Programme of Action, noted that the regular follow-up undertaken by the Trade and Development Board on the basis of the annual Report on the Least Developed Countries helped contribute to the development dialogue between the LDCs and their development partners, and urged that that exercise be strengthened. The Assembly also called upon UNCTAD to initiate further innovative measures to mobilize adequate resources for the effective implementation of the Programme of Action.

It will be recalled that in paragraph 7(a) of its resolution 45/206, the General Assembly called for UNCTAD's Intergovernmental Group on the Least Developed Countries to meet in 1995 "to carry out the mid-term review of the situation of those countries, report to the General Assembly on progress made in the implementation of the Programme of Action and consider new measures as necessary." This mandate was revised by virtue of resolution 48/171, in which the Assembly decided to convene a "high-level intergovernmental meeting" in the early part of September 1995, or any other suitable date during the second half of 1995 (para.16) and termed the meeting as "mid-term global review conference" (para.18). The Assembly stressed that the mid-term review should be organized by UNCTAD in accordance with paragraph 40 of the Programme of Action and that the results would be submitted to the General Assembly.

The General Assembly also reiterated its request to the Secretary-General of United Nations, contained in resolution 46/156, to mobilize extra-budgetary resources to ensure the participation of at least one representative from each least developed country at the spring sessions of the Board and at the preparatory phases for the Conference, as well as the effective participation of representatives of the least developed countries in the Conference itself.

In the same resolution, the Assembly stressed the importance of timely, adequate and thorough preparations for the mid-term global review and requested the Trade and Development Board to "consider, at its spring session in 1994, the elaboration of the preparatory activities for the mid-term global review conference, including intergovernmental, expert, sectoral and inter-agency preparatory meetings and the substantive documentation"; and decided that at its forty-ninth session it would consider the recommendations of the Trade and Development Board concerning preparations for the mid-term global review, as well as the question of meeting the cost of full and effective participation of representatives of the least developed countries in the Conference.

In accordance with paragraph 66 of the Cartagena Commitment, the Least Developed Countries 1993-1994 Report will be made available.

Item 6 - UNCTAD's contribution to the implementation of the United Nations New Agenda for the Development of Africa in the 1990s:

- Investment promotion, foreign direct investment, transfer of technology

At its 816th plenary meeting on 14 October 1992, the Board adopted a decision concerning UNCTAD's contribution to the implementation of the United Nations New Agenda for the Development of Africa in the 1990s,³ whereby the Secretary-General of UNCTAD was requested to undertake Africa-specific studies, analyses and reports on specific issue areas. For the spring session in 1994, the Board requested that a report be submitted on "Investment promotion, foreign direct investment, transfer of technology".

By the same decision, the Board requested the Secretary-General of UNCTAD to present progress reports on UNCTAD's contribution to the implementation of the New Agenda to the spring sessions of the Board.

The Board will thus have before it a report, Part II of which draws attention to some obstacles to investment in Africa and how African Governments have been responding, particularly since the 1980s; Part III discusses measures to encourage increased domestic investment and foreign direct investment, as well as the associated technology transfer; and Part IV suggests possible areas for further action (policies which could be introduced and new initiatives which could be taken).

A brief progress report concerning UNCTAD's on-going activities in contributing to the implementation of the New Agenda will be made available in a conference room paper.

Item 7 - Review and evaluation of work programmes (mid-term)

In paragraph 68 of the Cartagena Commitment, the Conference called for the Board to conduct, midway between Conferences, a review and evaluation of the work programme of the intergovernmental machinery, including its own; of technical assistance programmes; and, bearing in mind the calendar established in this regard, of the programme budget and medium-term plan, so as to ensure full integration of all work undertaken by UNCTAD and to establish or adjust priorities for the period up to the following Conference.

In approving the draft calendar of meetings for 1994 the Board, at the first part of its fortieth session, decided that it would resume the second part of its fortieth session from 25 to 27 May 1994, for the purpose of conducting the mid-term review.

At the Consultations of the Secretary-General of UNCTAD on 17 January 1994, discussions concerning the mid-term review focused on an informal issues note drawn up by the Secretary-General of UNCTAD on the basis of wide-ranging informal discussions he had held with a cross-section of delegations.

The Consultations decided to establish a Mid-term Review Informal Working Group which would report to an executive session of the Board or to the regular session in April 1994. The intention would be to carry forward as far as possible the work of the mid-term review, including if possible the preparation of a draft document for adoption by the Board at its mid-term review session (May 1994).

In the context of informal consultations on the organization of the work of the present session, it was agreed that the Board should devote two meetings to a review of the progress of the work of the Informal Working Group and other aspects of the preparatory work required for the mid-term review.

Item 11(f) - Status of the European Community in the Special Committee on Preferences

In a communication dated 11 March 1993, addressed to the Deputy Secretary-General of UNCTAD, the Commission of the European Community requested that it be granted membership status in the Special Committee on Preferences, i.e. the same status which it had been granted in the Intergovernmental Group of Experts on Restrictive Business Practices.

By letter of 29 September 1993 to the Secretary-General of UNCTAD, the Permanent Representative of Belgium, on behalf of the European Community and its member States, requested that the question of the status of the European Community in the Special Committee on Preferences be inscribed in the agenda for the second part of the fortieth session of the Board.

In approving the provisional agenda for the second part of its fortieth session, the Board took note of the related understanding pertaining to item 11 (f), reached in informal consultations, that the inclusion of the item was contingent on the delegation which had proposed the item submitting, in due course, an explanatory memorandum in accordance with the Rules of Procedure of the Board.

In accordance with the Board's decision concerning the inclusion of this item on the agenda, the European Union will circulate an explanatory memorandum.
