# ADOPTION OF THE AGENDA AND OTHER ORGANIZATIONAL MATTERS

Election of one member of the International Narcotics Control Board under the provisions of article 9, paragraph 1, of the Single Convention on Narcotic Drugs, 1961, as amended by the <u>1972 Protocol</u>

Note by the Secretary-General

Election of one member from among the candidates nominated by the World Health Organization to fill the vacancy arising from the resignation of Elisaldo Luiz de Araújo Carlini (Brazil), for a term ending on 1 March 2000

1. The Secretary-General was informed on 16 January 1995 of the resignation of Elisaldo Luiz de Araújo Carlini (Brazil), a newly elected member of the International Narcotics Control Board (INCB). Mr. Araújo Carlini's term of office would have started on 2 March 1995 and expired on 1 March 2000.

2. Since Elisaldo Luiz de Araújo Carlini was elected by the Economic and Social Council in 1994 from among the candidates nominated by the World Health Organization (WHO), under the provisions of article 9, paragraph 1 (a), of the Single Convention on Narcotic Drugs, 1961, as amended by the 1972 Protocol, the member to be elected to fill the remainder of the term should be elected from a list of at least three candidates nominated by WHO.

3. In accordance with established procedure, the Secretary-General invited the Director-General of the World Health Organization to propose candidates with a view to filling the post.

4. The Director-General of the World Health Organization, by a communication dated 29 May 1995, has informed the Secretary-General that the candidates proposed by WHO are:

# NUMBER, LENGTH AND PLACE OF MEETINGS, PAYMENTS AND PRESENT MEMBERSHIP OF THE INTERNATIONAL NARCOTICS CONTROL BOARD

1. The Board shall meet as often as, in its opinion, may be necessary for the proper discharge of its functions, but shall hold at least two sessions in each calendar year (Single Convention, article 11, paragraph 2).

2. The duration of each session varies from one to three weeks. In 1994 its sessions were as follows:

<u>Fifty-sixth session</u>, 9-19 May 1994 <u>Fifty-seventh session</u>, 31 October-17 November 1994

3. The sessions are normally held at the headquarters of the Board's secretariat in Vienna (Vienna International Centre).

4. In accordance with General Assembly resolution 2491 (XXIII) of 21 December 1968, the members of the Board receive a per diem allowance while participating in Board sessions or in official missions. As of May 1995, this allowance at Vienna is US\$ 319 per day. Members' travelling expenses are defrayed by the United Nations according to current administrative practice.

5. In accordance with General Assembly resolution 35/218 of 17 December 1980, members of the Board receive honoraria on the following annual basis:

President: US\$ 5,000 Vice-Presidents: US\$ 4,000 Members: US\$ 3,000
