Letter dated 2 March 1994 from the representatives of Angola, Brazil, Cape Verde, Guinea-Bissau, Mozambique, Portugal and Sao Tome and Principe to the United Nations addressed to the Secretary-General

We have the honour to transmit herewith the joint communiqué of the First Meeting of the Ministers for Foreign Affairs and External Relations of the Portuguese-Speaking Countries, which was held at Brasília on 9 and 10 February 1994, with the participation of Angola, Brazil, Cape Verde, Guinea-Bissau, Mozambique, Portugal and Sao Tome and Principe (see annex).

## ANNEX

Joint communiqué adopted at Brasília on 10 February 1994 by the First Meeting of the Ministers for Foreign Affairs and External Relations of the Portuguese-Speaking Countries

## The Ministers

for External Relations of Brazil, Mr. Celso L. N. Amorim,

for Foreign Affairs of Cape Verde, Mr. Manuel Casimiro de Jesus Chantre,

for Foreign Affairs and Cooperation of Guinea-Bissau, Mr. Bernardino Cardoso,

for Foreign Affairs of Mozambique, Mr. Pascoal Mocumbi,

for Foreign Affairs of Portugal, Mr. José Manuel Durão Barroso,

for Foreign Affairs of Sao Tome and Principe, Mr. Albertino Bragança, and

the Director of the Americas Department of the Ministry for External Relations of Angola, Ambassador João Felipe Martins, representing the Minister for External Relations of Angola,

<u>Having met</u> at Brasília on 10 February 1994 for an exchange of views on the community of Portuguese-speaking countries,

<u>Considering</u> that the idea of the creation of the community of Portuguese-speaking countries derives spontaneously from civil society, on the basis of a common language that has forged special relations among seven countries,

<u>Considering</u> that the seven countries share universal values, such as those of democratic ideals, respect for human rights, repudiation of racism and the traditional principles of coexistence among States,

<u>Considering</u> that the initiative of the establishment of the community reflects the consensus recognition by the participating Governments of the need to give concrete expression to an existing reality, which also confers a distinct identity to the seven States in the current international scenario,

<u>Considering</u> that the current international context has opened up new possibilities for initiatives of open and non-exclusive association among countries with similar values and interests,

<u>Considering</u> that, through the mechanism of political and diplomatic concertation to be established within the community, a more active presence of the seven countries in international forums will be assured,

1. Reaffirmed the intention of their Governments to support the establishment of the community of Portuguese-speaking countries, conceived as a

privileged forum for the strengthening of mutual friendship and for the establishment of an agenda of cooperation among Angola, Brazil, Cape Verde, Guinea-Bissau, Mozambique, Portugal and Sao Tome and Principe;

- 2. For the implementation of this initiative, agreed upon the following:
- (a) To recommend to their Governments the holding, in the first half of 1994, of a summit meeting at Lisbon, which would bring together the Heads of State and/or Government of the seven countries, with the aim of adopting the constituent act of the community;
- (b) To make efforts on the basis of the most absolute solidarity and with respect for national specificities towards making the community of Portuguese-speaking countries an instrument of political concertation and of cooperation in the social, cultural and economic fields;
- (c) To recommend to the Governments of the seven countries that they make every effort to facilitate the establishment as soon as possible of an international institute of the Portuguese language;
- (d) To underscore the importance of the development of interparliamentary cooperation activities among the legislative organs of the countries of the community and of the eventual establishment of a parliament of Portuguesespeaking countries;
- (e) To stimulate the consideration of economic and commercial cooperation mechanisms, with a view to promoting reciprocal exchanges and investments, with the wide participation of the private sector and of international organizations with these aims;
- (f) To recommend the enhancement of existing inter-university cooperation and the strengthening of discussions on the establishment of a university of the seven;
- (g) To support the development of a regional cooperation project for the promotion of the book and of reading in the five African countries with Portuguese as their official language, to be called the bibliographic fund of the Portuguese language, with its headquarters at Maputo;
- (h) To support the immediate and effective cease-fire in Angola and to express the certainty that peace will only be lasting if it is achieved in strict respect of the Bicesse Agreements and of the results of the free and fair elections of September 1992;
- (i) To encourage the implementation of the Rome Agreements, national reconciliation and the consolidation of democratic order in Mozambique;
- (j) To recommend the establishment of a commission with the mandate of mobilizing and coordinating the efforts towards the reconstruction of Angola and Mozambique;

- (k) To reiterate that the question of East Timor must be solved in conformity with the norms and principles of international law and with respect for human rights;
- (1) To establish a working group for permanent concertation at Lisbon, within the framework of the preparations for the summit meeting, composed of the Ambassadors of the six countries accredited to the Government of Portugal and of a high official of the Ministry for Foreign Affairs of Portugal;

(m) To meet at Lisbon immediately preceding the summit meeting.
