CONSIDERATION OF REPORTS SUBMITTED BY STATES PARTIES
UNDER ARTICLE 9 OF THE CONVENTION

Thirteenth periodic reports of States parties due in 1994

1. Thirteenth periodic reports under article 9, paragraph 1 (b), of the International Convention on the Elimination of All Forms of Racial Discrimination are due in 1994 from 36 States parties.

2. The thirteenth periodic reports of the following 26 States parties are due on 4 January 1994: Argentina, Brazil, Bulgaria, Costa Rica, Cyprus, Ecuador, Egypt, Ghana, Hungary, Iceland, India, Iran (Islamic Republic of), Kuwait, Libyan Arab Jamahiriya, Niger, Nigeria, Pakistan, Panama, Philippines, Poland, Sierra Leone, Spain, Tunisia, Uruguay, Venezuela and Yugoslavia (Serbia and Montenegro). The reports of the remaining 10 States parties are due on the following dates:
