NOTE VERBALE DATED 21 MARCH 1994 FROM THE SECRETARY-GENERAL
ADDRESSED TO THE PRESIDENT OF THE SECURITY COUNCIL

The Secretary-General of the United Nations presents his compliments to the President of the Security Council and, in accordance with paragraph 8 of Security Council resolution 816 (1993), has the honour to bring to his attention further information received by UNPROFOR regarding apparent violations of the ban on flights in the airspace of Bosnia and Herzegovina.

Between 18 and 20 March 1994, there appear to have been 8 flights of fixed- or rotary-wing aircraft in the airspace of Bosnia and Herzegovina other than those exempted in accordance with paragraph 1 of resolution 816 (1993) or approved by UNPROFOR in accordance with paragraph 2 of that resolution. Details as to the itinerary of flights in this reporting period are attached as the annex to this note verbale.

The total number of flights assessed as apparent violations is now 1,536.

1553	18 Mar	12.40	12.43	UNPROFOR personnel observed a MI-8 helicopter with a Serbian flag landing at Zvornik helipad. Some soldiers disembarked. The helicopter took off immediately afterwards preventing the Military Observer from inspecting it. When asked, he was told that this was the MEDEVAC flight No. 489. However, the red cross and the tail number given by the Monitoring and Close Air Support Coordination Centre (MCCC) were missing. The unauthorized flight occurred in an area controlled by Bosnian Serbs.	Unknown Slow Low		
1554	18 Mar	13.20	13.25	UNPROFOR personnel observed a white helicopter with blue stripes 15 kilometres southwest of Vitez, heading west. The unauthorized flight occurred in an area controlled by the Government of Bosnia and Herzegovina.	Southwest Slow Low		
1555	19 Mar	09.14	09.15	UNPROFOR personnel observed a white and blue MI-8 helicopter at Zenica, heading east. The unauthorized flight occurred in an area controlled by the Government of Bosnia and Herzegovina.	East Low Slow
