Item 3(d) - Ad Hoc Working Group on Expansion of Trading Opportunities for
(continued) Developing Countries, third session (28 February-4 March 1994)

The Ad Hoc Working Group on Expansion of Trading Opportunities for Developing Countries held its third session from 28 February to 4 March 1994 to consider the following issues arising from its work programme: (a) country presentations of national experience (export capabilities, export promotion and marketing); (b) market opportunities (regional integration arrangements, environmental measures); and (c) technical cooperation.

Attention is drawn to annex I to the report, containing the Chairman's summary of the results of the session. The provisional agenda for the fourth session is contained in annex II.

Attention is also drawn to paragraph 12 of the report, recording the Ad Hoc Working Group's intention to submit an interim progress report to the mid-term review (25-27 May) and to prepare its final report at its fourth session (4-8 July 1994), following the Working Group's consideration of the results of the Uruguay Round and their effects on the trading prospects of the developing countries.
