Scheme of Poland

Amendment

The UNCTAD secretariat has received from the Permanent Mission of Poland the following information concerning changes to its GSP scheme:

"As of 1 January 1994, the following countries have been removed from the Polish list of GSP beneficiaries: Argentina, Belize, Dominica, Fiji, Grenada, Saint Lucia and Syrian Arab Republic.

"Botswana was removed from the Polish GSP scheme as of 1 January 1995.

"As of 1 January 1995, Algeria, Congo, Dominican Republic, Guyana, Peru and Zimbabwe were added to the list of developing countries beneficiaries of the Polish GSP scheme.

"The most recent lists of countries covered by the Polish GSP scheme, divided into two categories - LDCs and developing countries -are attached. These lists constitute the Annexes to the Ordinance of the Council of Ministers of 13 June 1995."
