Corrigendum

Page 15, draft decision 2

- 1. In the text of the decision recommended to the Commission on Human Rights for adoption, line 6 $\underline{should\ read}$ as follows:
 - "... slavery-like practices, in particular during wartime, including internal armed ..."
- 2. In the text of the decision recommended to the Economic and Social Council for adoption, line 5 should read as follows:

Pages 63-64, resolution 1993/24, operative paragraphs 1 and 4

The change indicated above should also be reflected, i.e. after the word "including", $\underline{\text{delete}}$ the words "in particular" and $\underline{\text{insert}}$ them after the word "practices,".

Page 108, paragraph 46

In the last line, after the words "17 to", add the words "20 August and".

Page 133, paragraphs 250-254

Replace the text by the following:

- "250. The Sub-Commission considered item 7 together with item 8 (see chap. IX) at its 27th to 29th and 33rd meetings, on 20, 23 and 25 August 1993.
- "251. The Sub-Commission had before it the following document in connection with its consideration of the item:

Written statement submitted by the Inter-Parliamentary Union, a non-governmental organization in consultative status (category I) (E/CN.4/Sub.2/1993/NGO/8).

- "252. In the general debate on item 7, statements $\underline{1}$ / were made by the following members of the Sub-Commission: Mr. Alfonso Martínez (29th), Ms. Chavez (28th), Mr. Eide (28th), Mr. Sachar (28th).
- "253. A statement was made by the observer for Iraq (28th).
- "254. The Sub-Commission also heard statements by the representatives of the following non-governmental organizations: American Association of Jurists (27th), Habitat International Coalition (28th), International Association against Torture (27th), International Association of Educators for World Peace (27th), International Commission of Jurists (27th), International Educational Development (27th), International Fellowship of Reconciliation (27th), International Indian Treaty Council (27th), Movement against Racism and for Friendship among Peoples (27th), Women's International League for Peace and Freedom (27th), World Muslim Congress (27th), World Organization against Torture (27th)."

Page 133, paragraph 255

Delete the paragraph.

Page 135, paragraph 260

In line 2, replace "24th" by "25th".

Page 136, paragraph 266

In the last line, after the word "Guatemala", $\underline{replace}$ "(24th)" \underline{by} "(25th)".

Page 138, paragraph 284

In the last line, after the words "paragraphs 5 to 9", \underline{insert} the following:

"which read as follows:

- 5. <u>Encourages</u> the Special Rapporteur to initiate consultations with the international financial institutions, the United Nations Development Programme and other United Nations bodies in the preparation of his preparatory document;
- 6. <u>Requests</u> the Secretary-General to provide the Special Rapporteur with all the financial, technical and expert assistance required in the preparation of the preparatory document;
- 7. <u>Invites</u> the Special Rapporteur to submit the preparatory document to the Sub-Commission at its forty-sixth session for examination of the issues arising from the relationship between income distribution and the realization of economic, social and cultural rights;
- 8. $\underline{\text{Recommends}}$ the following draft decision to the Commission on Human Rights:

"The Commission on Human Rights, taking note of Sub-Commission on Prevention of Discrimination and Protection of Minorities resolution 1993/... of .. August 1993, endorses the decision by the Sub-Commission to appoint ... as Special Rapporteur on human rights and income distribution to submit a preparatory document to the Sub-Commission at its forty-sixth session and to request the Secretary-General to provide the Special Rapporteur with all the financial, technical and expert assistance required in the preparation of his study and the necessary assistance to compile and analyse the information and documents collected."

9. <u>Also recommends</u> the following draft decision to the Economic and Social Council for adoption:

"The Economic and Social Council, noting Commission on Human Rights decision 1994/... and resolution 1993/... of the Sub-Commission on Prevention of Discrimination and Protection of Minorities, decides to endorse the request of the Sub-Commission and the Commission to appoint ... as Special Rapporteur on human rights and income distribution and requests ... to submit a preliminary report to the Sub-Commission at its forty-seventh session, and requests the Secretary-General to provide the Special Rapporteur with all the assistance he may require."

Page 153, paragraph 386

In the second entry, after the words "(category II)", \underline{add} "(E/CN.4/Sub.2/1993/NGO/17)."

Page 160, paragraph 441

The text should read as follows:

"441. Mr. Alfonso Martínez proposed amending the draft resolution by inserting in operative paragraphs 1, 4 and 5 the words 'in particular' before the words 'during wartime'."

In the last line, <u>delete</u> the words "to none".

Page 169, paragraph 509

In the last line, after the words "by 14 votes", $\underline{\text{insert}}$ the words "to none".
