Chapter IV

PROCEDURAL, INSTITUTIONAL, ORGANIZATIONAL, ADMINISTRATIVE AND RELATED MATTERS

A. Opening of the session

1. The first part of the forty-second session of the Trade and Development Board was opened on 11 September 1995 by Mr. William Rossier (Switzerland), the President of the Board at its forty-second session.

B. Election of officers

- 2. At its eleventh (pre-sessional) executive session, on 5 September 1995, the Board had elected by acclamation Mr. William Rossier (Switzerland) to be the President of the Board throughout its forty-second session.
- 3. At its 862nd (opening) plenary meeting, on 11 September 1995, the Board completed the election of officers to serve on the Bureau of the Board throughout its forty-second session by electing 10 Vice-Presidents and the Rapporteur. Accordingly, the elected Bureau was as follows:

- 4. At the same meeting, the Board, having noted a minor typographical error in item 2, adopted the provisional agenda for the first part of the forty-second session as circulated in section I of TD/B/42(1)/1. (For the adopted agenda, see annex).
- 5. The Board approved the organization of work for the session as outlined in TD/B/42(1)/1/Add.1. The President stated that the reduction of the current session of the Board from two weeks to eight working days and the proposal to establish only one sessional committee were due to the fact that the High-level Intergovernmental Meeting on the Mid-term Global Review of the Implementation of the Programme of Action for the Least Developed Countries for the 1990s would begin in New York on Monday, 25 September. This was an exceptional measure and did not constitute a precedent for the duration or organization of future sessions of the Board.
- 6. In accordance with the proposed organization of work, the Board established a Sessional Committee to consider and report on the following agenda items:

 - Item 4 UNCTAD's assistance to the Palestinian people.

- 8. At its 863rd meeting, on 12 September 1995, the Board took note that there were no new applications from intergovernmental organizations.

Also at its 863rd meeting, the Board approved the applications of two non-governmental organizations and decided, in accordance with the recommendation of the Secretary-General of UNCTAD and of the Bureau, to designate and classify them for the purposes of rule 77 of the rules of procedure and in accordance with paragraph 12 (a) and 12 (b) of Board decisions 43 (VII) as follows:

General category: International Council of Environmental Law (ICEL)
(TD/B/42(1)/R.1);

<u>Special category</u>: Fundación Futuro Latinoamericano (FFLA) (TD/B/42(1)/R.2) so that it may participate in the work of the Standing Committee on Commodities, the Ad Hoc Working Group on Trade, Environment and Development and the Ad Hoc Working Group on Trading Opportunities in the New International Trading Context.

10. At the same meeting, the Board noted that the International Savings Banks Institute (ISBI), which had been granted status in the special category by the Board at its thirteenth session, had been dissolved and that the World Savings Banks Institute (WSBI) had taken over its activities. The Board agreed to the recommendation of the Secretary-General of UNCTAD and of the Bureau that, in accordance with its wishes, WSBI be reclassified in the general category.
