XX. IMPLICATIONS OF HUMANITARIAN ACTIVITIES FOR  
THE ENJOYMENT OF HUMAN RIGHTS

1. At the 34th meeting, on 24 August 1995, the Sub-Commission resumed consideration of draft resolution E/CN.4/Sub.2/1995/L.39.
2. Ms. Warzazi made the following revisions:
  - (i) Add a new seventh preambular paragraph reading as follows:  
"Bearing in mind that the work carried out at the United Nations Conference on Environment and Development, held at Rio, the World Conference on Human Rights at Vienna, and the World Summit for Social Development at Copenhagen, in particular, represent considerable progress in the respective areas with regard to the work of the United Nations, as well as the importance acquired by the humanitarian activities carried out by the United Nations, which require better planning and coordination,";
  - (ii) Add a new operative paragraph 2 reading as follows: "Draws the attention of the States Members of the United Nations to the advisability and importance of organizing in the near future a world summit on humanitarian assistance, in order to strengthen their development and to coordinate better their action in this field", and renumber the following paragraphs accordingly.
3. Ms. Mbonu also revised the text by adding after the last preambular paragraph a new preambular paragraph reading as follows: "Taking note of Commission on Human Rights decision 1995/107 of 3 March 1995 and the need expressed therein for the Sub-Commission to avoid making judgements on issues that are within the responsibility of other United Nations bodies,".
4. The draft resolution, as revised, was adopted without a vote.
