REPORT BY THE SECRETARY-GENERAL CONCERNING THE CREDENTIALS OF THE REPRESENTATIVES AND DEPUTY AND ALTERNATE REPRESENTATIVES OF THE MEMBERS OF THE SECURITY COUNCIL ELECTED FOR THE PERIOD 1981-1982

At its 41st and 61st meetings on 20 October and 13 November 1980, respectively, the General Assembly elected Ireland, Japan, Panama, Spain and Uganda non-permenent members of the Security Council for a term of two years, beginning on 1 January 1981.

Pursuant to rule 15 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to report that, with regard to the representation of the members of the Security Council elected for the period 1981-1982, he has received the communications referred to hereunder.

Ireland. The Secretary-General has received credentials signed on 17 December 1980 by the Minister for Foreign Affairs of Ireland stating that Mr. Noel Dorr has been appointed representative of Ireland on the Security Council, Mr. Aidan Mulloy deputy representative and Mr. Bernard Davenport, Mr. Declan O'Donovan, Mr. Eugene Hutchinson and Mr. Declan Kelleher alternate representatives. In the opinion of the Secretary-General, these credentials are in order.

Japan. The Secretary-General has received credentials signed on 19 December 1980 by the Minister for Foreign Affairs ad interim of Japan stating that Mr. Masahiro Nisibori has been appointed representative of Japan on the Security Council, Mr. Wataru Miyakawa deputy representative and Mr. Kimio Fujita, Mr. Katsumi Sezaki and Mr. Hideki Harashima alternate representatives. In the opinion of the Secretary-General, these credentials are in order.

Panama. The Secretary-General has received credentials signed on 10 December 1980 by the Minister for External Relations of Panama stating that Mr. Jorge E. Illueca has been appointed representative of Panama on the Security Council. In the opinion of the Secretary-General, these credentials are in order.

Spain. The Secretary-General has received credentials signed on 17 December 1980 by the Minister for External Affairs of Spain stating that Mr. Jaime de Piniés has been appointed representative of Spain on the Security Council, Mr. José Luis Xifra deputy representative and Mr. Fermin Zelada,

Mr. Jorge Fuentes, Mr. Eduardo Garrigues, Mr. Agustin Font and Mr. Antonio Viñal alternate representatives. In the opinion of the Secretary-General, these credentials are in order.

Uganda. The Secretary-General has received a telegram dated 23 December 1980 from the President of Uganda stating that Mr. Olara Otunnu has been appointed representative of Uganda on the Security Council. In the opinion of the Secretary-General, this communication constitutes adequate provisional credentials. The Secretary-General has also received a letter dated 23 December 1980 from the Permanent Representative of Uganda to the United Nations stating that Mr. Nathan Irumba has been appointed deputy representative of Uganda on the Security Council and Mr. Kakima Ntambi, Mr. Alex Okwonga and Miss Elizabeth Anyoti alternate representatives. In the opinion of the Secretary-General, this letter constitutes adequate provisional credentials.
