# ANNOTATED LIST OF ISSUES FOR CONSIDERATION BY THE CONSULTATIONS AMONG SENIOR OFFICIALS

# Note by the UNCTAD secretariat

1. In its resolution 49/98, of 19 December 1994, the General Assembly decided to convene the High-level Intergovernmental Meeting on the Mid-term Global Review of the Implementation of the Programme of Action for the Least Developed Countries for the 1990s in New York from 26 September to 6 October 1995, to be preceded by a one-day meeting of Senior Officials on 25 September 1995. The High-level Meeting will carry out the mid-term global review, consider new measures as necessary, and report to the General Assembly on progress made in the implementation of the Programme of Action.

2. The Consultations among Senior Officials are open to the States participating in the High-level Meeting. The Consultations may wish to invite any intergovernmental organization with observer status in the General Assembly to participate, at its request, as an observer in these Consultations.

### ORGANIZATION OF THE HIGH-LEVEL INTERGOVERNMENTAL MEETING

3. The Meeting of Governmental Experts of Donor Countries and Multilateral and Bilateral Financial and Technical Assistance Institutions with Representatives of the Least Developed Countries (Donor/Recipient Meeting), acting as a preparatory meeting for the High-level Intergovernmental Meeting, has made a number of recommendations concerning the organization of the Meeting.1/

These recommendations, as endorsed by the Consultations among Senior Officials, together with the Senior Officials' own decisions on outstanding issues noted below, will form the basis of the Senior Officials' report to the Meeting.

#### A. Adoption of the rules of procedures

4. As recommended by the Donor/Recipient Meeting, the High-level Intergovernmental Meeting may wish to apply the rules of procedure of the General Assembly, as appropriate.

### B. <u>Election of officers</u> (Item 1 of the provisional agenda)

5. The Senior Officials may wish to make arrangements for the nomination of the Chairman to be elected by the High-level Intergovernmental Meeting.

6. The Senior Officials may also wish to consider arrangements for 29 Vice-chairmen, one of whom will assume the duties of Rapporteur, so that at the opening Plenary of the Meeting the various groups are in a position to make nominations with a view to the election of all officers by acclamation, thus dispensing with the need for a secret ballot.

# C. Adoption of the agenda and organization of work (Item 2 of the provisional agenda)

#### Adoption of the agenda

7. On the basis of the recommendation made by the Trade and Development Board in the annex to agreed conclusions 423 (XLI) of 31 March 1995, the Donor/Recipient Meeting has recommended that the pre-conference meeting of Senior Officials may wish to approve the draft provisional agenda and the organization of work recommended by the Trade and Development Board. (For the provisional agenda, see TD/B/LDC/GR/4 - attached.)

8. The Senior Officials may wish, in that light, to recommend the provisional agenda for adoption by the High-level Meeting.

## Organization of work and establishment of sessional bodies

9. The High-level Intergovernmental Meeting will have nine working days at its disposal. The secretariat has prepared a tentative timetable for the High-level Intergovernmental Meeting (Annex I).

10. The Meeting may wish to establish a Committee of the Whole in addition to the Plenary. The Committee of the Whole would be chaired by the Chairman of the High-level Intergovernmental Meeting. The general debate will take place in the Plenary. The Committee of the Whole may wish to consider and report on agenda item 3, namely: Mid-term global review of progress towards the implementation of the Programme of Action for the Least Developed Countries for the 1990s:

- (a) Review of progress in implementation at the country level;
- (b) Review of progress in international support measures;
- (c) Consideration of new measures for ensuring the full and effective implementation of the Programme over the second half of the decade.

The Committee of the Whole may, as necessary, establish working groups to deal with the above item.

11. The Senior Officials may therefore wish to recommend that a Committee of the Whole be established to discuss item 3 of the provisional agenda and that all other items be dealt with in plenary. Moreover, the Senior Officials may wish to approve the proposals for the organization of work in section E below.

# D. <u>General debate</u>

12. The Officer-in-charge of UNCTAD, in a note (TDN 330/17(1-10)) dated 14 August 1995, informed Governments of the establishment of a list of speakers for the general debate, which is scheduled to open on the morning of 26 September. The General Assembly has set a guideline establishing a time-limit of 10 minutes for interventions by representatives of States and of 5 minutes for statements by other participants. This guideline should be strictly observed during the general debate. The Senior Officials may wish to recommend that the Meeting adopt these time-limits.

# E. Organization of work of the Meeting

13. With regard to the organization of work of the Meeting, the Senior Officials may wish to recommend to the attention of the High-level Meeting, the following:

- (i) The total available services for meetings will be distributed, as required, among the Plenary, the Committee of the Whole and regional group meetings. Facilities exist for a maximum of 2 simultaneous meetings to be held with interpretation each morning and afternoon.
- (ii) A "meeting" is deemed to have an average duration of three hours; thus, the services provided for a meeting of three hours might, on occasion, be shared between two sessional bodies, and/or contact or regional groups, provided that the meetings so linked together take place consecutively.
- (iii) Working hours of the Meeting should be 10.00 a.m. to 1.00 p.m. and 3.00 to 6.00 p.m., Monday to Friday, the period from 9 a.m. to 9.30 a.m. being reserved for group meetings to the extent possible. However, in order to accommodate the many speakers intending to participate in the general debate, it will be necessary for plenaries devoted to this item to start punctually at the scheduled hour (i.e. 10.00 a.m. and 3.00 p.m.).

- (iv) The general debate has been scheduled from 26 September to 4 October. It is suggested that the list of speakers in the general debate should be closed on 29 September (p.m.). There will be no general debate in the Committee of the Whole.
- (v) Governments may wish, to the extent possible, to designate as heads of delegation persons of ministerial or equivalent rank.
- (vi) In order to enable the High-level Meeting to conclude its work on time and in the interest of an orderly organization of its work, it is essential that a timetable be approved at the beginning of the session and that every effort be made to adhere to it.

14. A proposed tentative schedule of meetings is annexed to the present document. This schedule calls for the general debate to begin on 26 September and for the Committee of the Whole to begin its work on the afternoon of that day. For the general debate, the secretariat has made provision for one evening plenary, but more evening plenaries may prove necessary.

#### F. <u>Seating arrangements for the Meeting</u>

15. It is proposed that the seating pattern at the High-level Meeting will conform to that of the current session of the General Assembly.

#### G. <u>Report by the Chairman of the Consultations</u> among Senior Officials of the Meeting

16. The Senior Officials may wish to authorize the Chairman to report to the Meeting on the outcome, including the conclusions and recommendations of the Consultations.
