Organization of work

Note by the Secretariat

1. The Secretariat submits herewith, for consideration, a proposed programme of work for the second session of the Committee on Natural Resources, taking into account the time available and the conference services allocated to the Committee (see annex below).

2. The present schedule should be considered tentative and indicative. In order to utilize the time available to the Committee in an efficient manner, it is suggested that the delegations wishing to make statements in the general discussion of agenda items, should inscribe their names on the list of speakers as early as possible.

3. With regard to the length of statements in the general discussion, it is proposed that a 10-minute time-limit be set for the delivery of statements.

4. Two meetings a day with interpretation have been allocated to the Committee (one in the morning and one in the afternoon). It is suggested that meetings be held from 10 a.m. to 1 p.m. and from 3 p.m. to 6 p.m. These arrangements are reflected in the proposed programme of work.
