Amendment

The UNCTAD secretariat has received the following communication from the Permanent Mission of Norway concerning the new version of Norway's scheme of generalized preferences as regards agricultural products:

"Please find enclosed a notification of Norway's newly revised GSP scheme, in effect since 1 July 1995. It replaces the interim GSP arrangement that was introduced on 1 January in response to the WTO Agreement's requirement of tariffication of all non-tariff border measures. The Permanent Mission requests that the notification be given due distribution."

**THE NORWEGIAN SCHEME OF GENERALIZED PREFERENCES (GSP).
IMPORTS OF AGRICULTURAL PRODUCTS.**

Implementation of the WTO agreement as of 1 January required tariffication of all non-tariff border measures in the agricultural sector and a revision of the Norwegian GSP scheme. An interim GSP arrangement was implemented from 1 January, and a revised, new scheme took effect on 1 July. The new scheme implies a significant improvement in the product coverage for agricultural products.

For **least developed countries** the following conditions apply:

- duty free and quota free market access for all agricultural products with the exception of flour, grains and feeding stuffs, which are given a tariff reduction of 30% within indicative tariff ceilings, cfr. list 1. The tariff reductions are calculated in relation to applied tariff rates. Automatic licencing is applied for imports of flour, grains, feeding stuffs and meat from these countries.

For **other developing countries** the scheme implies:

- duty free market access for agricultural products contained in list 2.
- 100% tariff reduction on the industrial element of industrially processed agricultural products, cfr. list 3.
- 50 % tariff reduction on oils and fats, cfr. list 4.
- 15 % tariff reduction on certain flower, fruit and vegetable products, cfr. list 5.
Automatic licencing is applied for products on this list.
- 10 % tariff reduction on flour, grains and feeding stuffs, cfr. list 1.
- 10% tariff reduction on meat and meat products, cfr. list 6.
Automatic licencing is applied for products on this list.
- 10 % tariff reduction on products within the new WTO minimum access quotas. cfr. list 7.

All tariff reductions are calculated in relation to applied tariff rates.

LIST 1
