- 11. $\underline{\text{Mr. MERIFIELD}}$ (Canada), supported by $\underline{\text{Ms. SAEKI}}$ (Japan) and $\underline{\text{Mr. FRANCIS}}$ (Australia), said it was regrettable that the Committee had not authorized assessments which would give the Secretariat the money it needed to carry out the mandates of the Security Council. It was important for the Committee to act responsibly.
- 12. Mr. SPAANS (Netherlands) noted that the Committee could have taken more far-reaching decisions had the relevant documentation been available. Paragraph (d) of each resolution, referring to levels of arrears, was of particular importance since the fact that some \$570 million was owed in respect of the five peace-keeping operations had contributed to the current financial problems.
- 13. $\underline{\text{Mr. MADDENS}}$ (Belgium) said that the Committee had acted responsibly in re-establishing the legal basis for all expenditures on the five peace-keeping operations in question while recognizing the rights and duties of Member States.

ORGANIZATION OF WORK

14. After a procedural discussion, $\underline{\text{the CHAIRMAN}}$ said that the Bureau would decide on the date of the Committee's next formal meeting on peace-keeping operations.
