ADOPTION OF THE AGENDA AND ORGANIZATION OF WORK

Status of documentation for the thirty-fourth session as at 20 April 1994

Note by the Secretariat

1. In accordance with Economic and Social Council resolution 2008 (LX) of 14 May 1976, the thirty-fourth session of the Committee for Programme and Coordination (CPC) will be held in two parts: the first part from 16 to 27 May 1994 and the second part from 29 August to 16 September 1994.
2. In its resolutions 1979/1 of 9 February 1979 and 1979/69 of 2 August 1979 on the control and limitation of documentation and 1988/77 of 29 July 1988 on the revitalization of the Economic and Social Council, the Council reiterated that the Secretariat should circulate the relevant documentation in all working languages six weeks before the opening of the sessions of the Council and its subsidiary organs, and invited the Secretariat to take steps to ensure effective compliance with rule 13, paragraph 4, of the rules of procedure of the Council. In resolution 1979/69, the Council requested the Secretariat to inform the Council and its subsidiary bodies which documents had not been issued in accordance with the six-week rule, with a full explanation of the reasons that prevented their circulation.
3. In view of the dates of the first part of the thirty-fourth session of CPC, the documentation for that part of the session should have been circulated by 4 April 1994. The documents to be issued for the whole session are listed in the annex to the present note. The explanations for any delay will be provided by the office responsible for the delay.
