UNCTAD CALENDAR OF MEETINGS

The present document contains in its annex the calendar of UNCTAD meetings for the remainder of 1995 and a draft calendar for the first half of 1996 as approved by the Board at the first session of its forty-second session.

It also gives in summary form the overall calendar provisions for UNCTAD meetings for the biennium 1996-1997.

At this stage, no specific dates are proposed for meetings of the intergovernmental machinery of UNCTAD in the period July 1996-December 1997, pending discussions by the Trade and Development Board at its eighteenth special session (11-15 December 1995) and decisions at UNCTAD IX.

However, as part of the secretariat's forward planning, tentative meeting slots have been reserved with the UN Office at Geneva for the second half of 1996 and for 1997 in order to accommodate such future meetings of the intergovernmental machinery as may be decided upon by the Board or the Conference, and to cover such other meetings as may be required.
