# SUMMARY OF 1994 RECOMMENDATIONS FOR GENERAL RESOURCES AND SUPPLEMENTARY FUNDING PROGRAMMES

### SUMMARY

The present document, known informally as the "round-up" document, has been prepared to facilitate review by the Executive Board of recommendations for new general resources programmes and supplementary funding proposals. The addendum to the present document also provides estimates of future expenditures for all the country programmes as well as regional and interregional projects, with a breakdown by sources of funding.

#### INTRODUCTION

- 1. The present "round-up" document summarizes all programme recommendations submitted for approval by the Executive Board at its second regular session of 1994. They include recommendations funded from general resources as well as recommendations to be financed from supplementary funding contributions. The paper includes 58 country programmes, 3 bridging recommendations for services for Palestinian children and women and 1 programme for an area office for countries in the former Yugoslavia, as well as 2 interregional proposals. Of these recommendations, 6 country programmes with annual planning levels not exceeding \$1 million are included in documents E/ICEF/1994/P/L.15, E/ICEF/1994/P/L.16, E/ICEF/1994/P/L.17 and E/ICEF/1994/P/L.18.
- 2. Owing to programme requirements and accelerated implementation, additional amounts from general resources are recommended for 13 country programmes essentially for the same programme cycle as already approved by the Board in earlier years. These are detailed in documents E/ICEF/1994/P/L.30, E/ICEF/1994/P/L.31, E/ICEF/1994/P/L.32 and E/ICEF/1994/P/L.34 and are indicated by an asterisk after the country name in table 1 below.
- 3. In order to meet documentation deadlines, country programme recommendation documents had to be prepared before aggregate financial data for 1993 were finalized. The recommendations from general resources shown in the country programme recommendations are shown in table 1 under the column "recommended funding from general resources for the period".
- 4. The total amount of programmes from general resources recommended for approval at the current session is \$329.4 million. The details are shown by region and country in table 1. Breakdowns of new recommendations from general resources by major programme fields and regions are provided in table 2.
- 5. Supplementary funding proposals for 6 countries and 1 interregional programme in the total amount of \$46.5 million, for which no full length general resources programmes are recommended for approval at the current session, are presented in documents E/ICEF/1994/P/L.35, E/ICEF/1994/P/L.36, E/ICEF/1994/P/L.37 and E/ICEF/1994/L.9. These supplementary funding proposals are also listed separately by region and country in table 1. A double asterisk after the country name indicates a supplementary funding proposal without a general resources recommendation. The total amount of supplementary funding proposals at the current session is \$613.6 million.
- 6. A comprehensive picture of approved general resources and supplementary funding for all the countries with which UNICEF cooperates, as well as of regional and interregional programmes, is provided separately in the addendum to the present document. It shows balances as of the end of 1993 of programmes approved earlier by the Board and new recommended general resources for review and approval by the current session of the Board. To provide a total picture of possible financing for the future, unfunded supplementary funding proposals for the country are also shown. It should be noted, however, that implementation will depend on funds being raised to finance these programmes.
