LETTER DATED 15 AUGUST 1994 FROM THE ACTING PRESIDENT
OF THE GOVERNING COUNCIL OF THE UNITED NATIONS
COMPENSATION COMMISSION ADDRESSED TO THE PRESIDENT OF
THE SECURITY COUNCIL

I have the honour to transmit herewith, for the attention of the Security Council, the following information on the third special session of the Governing Council, held on 12 August 1994 at Geneva.

At its 44th plenary meeting, the Governing Council, on the recommendation of the Secretary-General, appointed Mr. Rafael Rivas-Posada as Commissioner for the panel for claims in category A, filling the post left vacant after the death of Mr. José María Ruda. At the same meeting, the Council also decided that Mr. Kamal Hossain should be the panel's chairman.

The text of the letter from the Deputy Executive Secretary of the Commission to the Acting President of the Governing Council enclosing the curriculum vitae of Mr. Rivas-Posada is attached herewith (see annex).
