The General Assembly, at its 91st plenary meeting, on 18 April 1989, and the Security Council, at its 2854th meeting, on the same date, proceeded independently of one another to elect, in accordance with Articles 2 to 4, 7 to 12 and 14 and 15 of the Statute of the International Court of Justice, rules 150 and 151 of the rules of procedure of the Assembly and rules 40 and 61 of the provisional rules of procedure of the Council, a member of the Court for a term of office expiring on 5 February 1991 to fill a vacancy resulting from the death of Mr. Nagendra SINGH (India).
