## The meeting was called to order at 10.25 a.m.

AGENDA ITEM 143: CONSIDERATION OF THE DRAFT ARTICLES ON THE STATUS OF THE DIPLOMATIC COURIER AND THE DIPLOMATIC BAG NOT ACCOMPANIED BY DIPLOMATIC COURIER AND OF THE DRAFT OPTIONAL PROTOCOLS THERETO (continued) (A/45/10)

1. The CHAIRMAN said that, as a revised version of draft resolution A/C.6/45/L.8 was in preparation, the Committee would return to the agenda item at a later meeting.

AGENDA ITEM 141: REPORT OF THE UNITED NATIONS COMMISSION ON INTERNATIONAL TRADE LAW ON THE WORK OF ITS TWENTY-THIRD SESSION (continued) (A/C.6/45/L.10)

- 2. Mr. TUERK (Austria), introducing draft resolution A/C.6/45/L.10 on behalf of its sponsors, said that Bahrain, Canada and Thailand had also become sponsors. The draft resolution expressed the General Assembly's appreciation for the valuable work being undertaken by the United Nations Commission on International Trade Law (UNCITRAL) in the field of the progressive harmonization and unification of international trade law. Drawing attention to the fourth preambular paragraph, he said that it reflected the many references made in the course of the debate on the item to the potential contribution by UNCITRAL to the United Nations Decade of International Law, particularly with regard to the dissemination of international trade law. He also drew attention to paragraphs 2, 4 and 5, and expressed the hope that the draft resolution could be adopted without a vote.
- 3. Draft resolution A/C.6/45/L.10 was adopted without a vote.

AGENDA ITEM 135: OBSERVER STATUS OF NATIONAL LIBERATION MOVEMENTS RECOGNIZED BY THE ORGANIZATION OF AFRICAN UNITY AND/OR BY THE LEAGUE OF ARAB STATES (continued) (\(\lambda/C.6/45/L.12\))

- 4. Mrs. SILVERA (Cuba) said that her delegation had recently joined the sponsors of draft resolution A/C.6/45/L.12, and had the honour to introduce it. Drawing attention to paragraph 2, she pointed out that many States had granted facilities, privileges and immunities in their countries to the national liberation movements in question.
- 5. The CHAIRMAN said that the Committee would take a decision on the draft resolution at a later meeting.

AGENDA ITEM 147: CONCILIATION RULES OF THE UNITED NATIONS (continued) (A/C.6/45/L.9)

6. Mr. VILLAGRAN KRAMER (Guatemala), introducing draft decision A/C.6/45/L.9, said that its purpose was to channel the discussion concerning the draft conciliation rules of the United Nations in the direction of the United Nations Decade of International Law and the Special Committee on the Charter. He hoped

that at some future time the Sixth Committee could consider the various ideas on the subject which had been generated within the United Nations and by the scientific and academic community.

7. Draft decision A/C.6/45/L.9 was adopted without a vote.

- 8. Mr. TUERK (Austria), introducing draft resolution A/C.6/45/L.11 on behalf of its sponsors, drew attention to its major provisions and expressed the hope that it could be adopted without a vote.
- 9. Draft resolution A/C.6/45/L.11 was adopted without a vote.
