NARCOTIC DRUGS

Report of the Social Committee

- 1. The Social Committee considered the question of narcotic drugs (agenda item 21) at its 7th to 13th meetings, on 13 to 19 July 1993. It had before it the following documents:
- (a) Note by the Secretary-General on the update of the United Nations System-Wide Action Plan on Drug Abuse Control (A/48/178-E/1993/70);
- (b) Report of the Commission on Narcotic Drugs on its thirty-sixth session ($\mathbb{E}/1993/29$); 1/
- (c) Summary of the report of the International Narcotics Control Board for 1992 (E/1993/45);
- (d) Note by the Secretary-General transmitting the report of the Executive Director of the United Nations International Drug Control Programme on the administrative arrangements to ensure the full technical independence of the International Narcotics Control Board (E/1993/94).

- 2. At its 7th to 12th meetings, on 13 to 16 July 1993, the Committee held a general discussion on the item. At the 7th meeting, on 13 July, the Committee heard introductory statements by the Director of Treaty Implementation of the United Nations International Drug Control Programme, and by the President of the International Narcotics Control Board.
- 3. At the same meeting, statements were made by the representatives of Belgium (on behalf of the States Members of the United Nations that are members of the European Economic Community), the Bahamas and Suriname.
- 4. At the 8th meeting, on 13 July, statements were made by the representatives of Turkey, Kuwait and Poland.
- 5. At the same meeting, the representatives of the World Health Organization and the Food and Agriculture Organization of the United Nations made statements.
- 6. At the 9th meeting, on 14 July, statements were made by the representatives of Austria and China.
- 7. At the 10th meeting, on 14 July, statements were made by the representatives of Chile and Peru, and the observers for Myanmar and Finland (on behalf of the Nordic countries).
- 8. At the 11th meeting, on 15 July, statements were made by the representatives of the Republic of Korea, the Russian Federation, the United States of America, Belarus, Mexico and India, and the observers for the Czech Republic and Bolivia.
- 9. At the 12th meeting, on 16 July, statements were made by the representatives of Ukraine, Cuba and the Philippines, and the observer for Slovakia.

Recommendations contained in the report of the Commission on Narcotic Drugs on its thirty-sixth session

- 10. Chapter I of the report of the Commission on Narcotic Drugs on its thirty-sixth session (E/1993/29) contained nine draft resolutions and six draft decisions recommended for adoption by the Council. Programme budget implications of draft resolution VIII contained in the report were set out in annex II to the report.
- 11. At the 12th meeting, on 16 July, the Chairman informed the Committee that draft resolutions I to VII and IX and draft decisions I to VI contained in the report had no programme budget implications.

Demand reduction as part of balanced national strategic plans to combat drug abuse

12. At the 12th meeting, on 16 July, the Committee adopted draft resolution I, entitled "Demand reduction as part of balanced national strategic plans to combat drug abuse" (see para. 31 below, draft resolution I).

Frequency of and arrangements for meetings of Heads of National Drug Law Enforcement Agencies, Europe

Demand for and supply of opiates for medical and scientific needs

14. At the 12th meeting, on 16 July, the Committee adopted draft resolution III, entitled "Demand for and supply of opiates for medical and scientific needs" (see para. 31 below, draft resolution III).

Measures to prevent substances listed in Schedules III and IV of the Convention on Psychotropic Substances of 1971 from being diverted from international trade into illicit channels

- 23. At the 12th meeting, on 16 July, the Committee postponed taking action on draft decision III, entitled "Venue of the Sixth Meeting of Heads of National Drug Law Enforcement Agencies, Latin America and the Caribbean".
- 24. At the 13th meeting, on 19 July, statements were made by the representative of Chile and the observer for the Dominican Republic.
- 25. At the same meeting, the Committee adopted the draft decision (see para. 32 below, draft decision III).

Reconvened session of the Commission on Narcotic Drugs

- 26. At the 12th meeting, on 16 July, the Committee adopted draft decision IV, entitled "Reconvened session of the Commission on Narcotic Drugs" (see para. 32 below, draft decision IV).
- 27. After the draft decision was adopted, the representative of the United States of America made a statement.
