# Note by the Secretary-General

- 1. The Commission on Human Settlements has 58 members. Pursuant to General Assembly resolutions 32/162 of 19 December 1977, 40/202 of 17 December 1985 and 45/264 of 13 May 1991, the Economic and Social Council is to elect, at its resumed organizational session for 1994, 20 members of the Commission, for a four-year term beginning on 1 January 1995, to fill the vacancies that will occur on 31 December 1994 upon the expiration of the terms of the following members: Antigua and Barbuda, Bangladesh, Brazil, Cameroon, Chile, Colombia, Egypt, Finland, Iran (Islamic Republic of), Japan, Nigeria, Pakistan, Romania, Russian Federation, Sierra Leone, Turkey, Uganda, United Kingdom of Great Britain and Northern Ireland, United States of America and Zimbabwe.
- 2. In accordance with paragraph 1 of section II of General Assembly resolution 32/162, the 20 members are to be elected on the following basis:

Six seats for African States;

Four seats for Asian States;

Two seats for Eastern European States;

Four seats for Latin American and Caribbean States;

Four seats for Western European and other States.
