RESOLUTIONS

1950 (LIX). Annual report of the Economic Commission for Africa

The Economic and Social Council

- 1. Takes note of the report of the Economic Commission for Africa for the period 24 February 1974 to 28 February 1975 1 and of the recommendations and resolutions contained in part III thereof;
- 2. Endorses the medium-term plan for the period 1976-1979 contained in part V of the report;
- 3. Takes note also of part I of the document entitled "Survey of economic and social conditions in Africa, 1974", 2 dealing with the mid-term review and appraisal of progress in implementing the International Development Strategy for the Second United Nations Development Decade:
- 4. Decides to amend the terms of reference of the Economic Commission for Africa by adding the following new paragraph between paragraphs 9 and 10:

"The Commission shall invite any national liberation movement recognized by the Organization of African Unity to send observers to participate in its consideration of any matter of interest to that movement. Such observers shall have the right to submit proposals. which may be voted upon at the request of any member of the Commission. The Commission shall defray all travel and other related expenses of representatives of the national liberation movements invited to attend such proceedings"; 3

5. Recommends that the General Assembly should approve the adoption of Arabic as an official and working language of the Economic Commission for Africa, in addition to English and French.4

> 1971st plenary meeting 22 July 1975

1951 (LIX). Assistance to Zambia

The Economic and Social Council.

Recalling the resolutions of the General Assembly and of the Security Council concerning the United Nations policy of sanctions against the illegal régime in Southern Rhodesia.

Further recalling Security Council resolution 329 (1973) of 10 March 1973, and the previous Economic and Social Council resolutions on the question of assistance to Zambia to enable that country to offset the adverse economic consequences arising from the closure of its border with Southern Rhodesia.

- 1. Takes note with satisfaction of the oral report on the current state of the programme of assistance for Zambia made on behalf of the Secretary-General by the Co-ordinator of United Nations Assistance to Zambia; 5
- Reiterates the expression of its appreciation to those Member States which have contributed to the programme of assistance for Zambia, and further invites Member States in a position to do so to render additional assistance to supplement Zambia's own efforts to bear the burden arising from its implementation of the United Nations policy of sanctions against the illegal régime in Southern Rhodesia:
- 3. Further reiterates its expression of satisfaction with the efforts which the Secretary-General continues to make in order to mobilize and co-ordinate the assistance to Zambia provided by Member States and by the United Nations system;
- 4. Endorses the request of the Government of Zambia that the United Nations programme of assistance for Zambia should be extended throughout 1976, in the light of present conditions and possible future developments.

1952 (LIX). Regional co-operation

The Economic and Social Council,

Recalling its resolution 1896 (LVII) of 1 August 1974 on regional co-operation,

Noting with satisfaction that, as requested in paragraph 1 of that resolution, the regional commissions, at their intergovernmental sessions held during the first half of 1975, paid special attention to adjusting, as appropriate, their respective programmes of work and activities in order to discharge effectively their responsibilities in connexion with resolution 1896 (LVII),

Bearing in mind that regional co-operation may contribute to the fulfilment of the objectives of article 17 of the Charter of Economic Rights and Duties of States, 6 which affirms that international co-operation for development is the shared goal and common duty of all States,

Recognizing that the regional commissions have emphasized the need to promote interregional co-operation in order to assist developing countries in their efforts to achieve development in the changing circumstances of the world economic situation,

Noting further that, as also requested in its resolution 1896 (LVII), the Secretary-General and the Administrator of the United Nations Development Programme have entered into consultations with a view to complying with the Council's request in paragraph 5 of that resolution to make the necessary arrangements allowing for the delegation of the appropriate functions of an executing agency to the regional commissions for regional, subregional and interregional projects, financed by the Programme, in cases where such delegation is requested by the countries concerned and recommended by the Administrator of the Programme,

- 1. Invites the regional commissions to continue and intensify their activities concerning the implementation of the relevant global policy decisions taken by the Council and the General Assembly, and in particular of the resolutions of the sixth special session of the Assembly, and, in addition to exercising their regional responsibilities, to give special attention to these matters;
- 2. Requests the Executive Secretaries of the regional commissions to intensify their efforts in favour of all developing countries by promoting interregional as well as intra-regional co-operation consistent with the aims and objectives of the decisions taken by all agencies of the United Nations at the global level, in particular the resolutions of the sixth special session of the General Assembly:
- 3. Requests the Secretary-General to assist the Executive Secretaries of the regional commissions by providing the necessary resources for the purposes mentioned in paragraphs 1 and 2 above;
- 4. Further requests the regional commissions at their intergovernmental sessions to pay increasing attention, in preparing their programmes of activities, to the inclu-

sion of interregional projects which will directly assist their members in strengthening their development efforts and to take at these sessions greater initiatives, in consultation with the United Nations Development Programme and the countries concerned, in order to identify projects for which the regional commissions would be given the function of executing agencies by the United Nations Development Programme;

- 5. Calls upon the Secretary-General and the Administrator of the United Nations Development Programme to expedite in this connexion the conclusion of the necessary arrangements, in order that the regional commissions may function as executing agencies for regional, subregional and interregional projects financed by the Programme;
- 6. Requests the Administrator of the United Nations Development Programme to utilize the services of the regional commissions at the request of the countries concerned for the purpose of making contributions to the forthcoming programme cycle, in particular to intercountry programming.

1973rd plenary meeting 23 July 1975

1959 (LIX). World Conference of the International Women's Year

The Economic and Social Council,

Recalling General Assembly resolution 3010 (XXVII) of 18 December 1972 and Economic and Social Council resolutions 1849 (LVI), 1850 (LVI) and 1851 (LVI) of 16 May 1974, on the proclamation of the year 1975 as International Women's Year, the programme for the Year, the establishment of a fund for the Year and the convening of an international conference as a focal point of the international observance of the Year,

Considering that the World Conference of the International Women's Year, held at Mexico City from 19 June to 2 July 1975, marked a turning point signalling decisive changes designed to improve the status of women,

Noting that the General Assembly, in its resolution 3276 (XXIX) of 10 December 1974, requested the Conference to submit, if possible, such proposals and recommendations as it deemed appropriate to the General Assembly at its special session to be held in September 1975 and that it also decided to consider at its thirtieth regular session an item entitled "International Women's Year, including the proposals and recommendations of the Conference of the International Women's Year",

Considering that certain of the recommendations and resolutions of the Conference require urgent action,

Considering also that the Conference has stressed the need for adequate data and research on all aspects of the status of women,

1. Expresses its appreciation to the Government and people of Mexico for their generous contribution to the success of the World Conference of the International Women's Year;

- 2. Takes note of the report of the World Conference of the International Women's Year, 7 and in particular of the Declaration of Mexico on the Equality of Women and their Contribution to Development and Peace, 1975, 8 and the World Plan of Action for the Implementation of the Objectives of the International Women's Year; 9
- 3. Draws the attention of the General Assembly at its special session devoted to development and international economic co-operation to the proposals and recommendations of the Conference, especially those relating to women and development;
- 4. Recommends that the General Assembly should give due priority to the consideration at its thirtieth regular session of the report of the Conference and of the measures needed to implement the recommendations adopted and in particular the World Plan of Action, and should ensure that adequate budgetary provision is made for this purpose;

- 5. Urges Member States and all organizations of the United Nations system to take intensified and sustained action to achieve the full equality of men and women and to improve the quality of life for all human beings;
- 6. Recommends to the General Assembly that, in proclaiming 1975-1985 as the Decade for Women and Development, ¹⁰ it ensure that continuing action is taken at the national, regional and international levels throughout that period;
- 7. Invites Governments to contribute to the voluntary fund established under Council resolution 1850 (LVI), in order to supplement the budgetary resources available for the implementation of the decisions of the Conference;
- 8. Requests the Secretary-General to report to the General Assembly at its thirtieth session on the establishment of the international research and training institute for the promotion of women. 11

At its 1971st meeting, on 22 July 1975, the Council took note of the report by the Secretary-General on economic, financial and technical assistance to the Government of Guinea-Bissau ¹² and the report by the Secretary-General on economic, financial and technical assistance to the territories still under Portuguese domination, ¹³ and decided to transmit those reports to the General Assembly at its thirtieth session.

102 (LIX). Annual report of the Economic Commission for Europe

At its 1971st meeting, on 22 July 1975, the Council:

- (a) Took note of the report of the Economic Commission for Europe for the period 30 April 1974 to 24 April 1975, ¹⁴ of the views expressed during the discussion in the Commission ¹⁵ and of the resolutions and other decisions adopted by the Commission at its thirtieth session, contained in part IV of that report;
- (b) Decided to endorse the programme of work and priorities contained in parts V and VI of the report.

103 (LIX). Annual report of the Economic and Social Commission for Asia and the Pacific

At its 1971st meeting, on 22 July 1975, the Council:

- (a) Took note of the report of the Economic and Social Commission for Asia and the Pacific for the period 7 April 1974 to 7 March 1975 ¹⁶ and of the recommendations and resolutions contained in chapters II and III of that report;
- (b) Decided to endorse the programme of work and priorities contained in chapter IV of the report;
- (c) Decided to amend the wording of paragraph 2 of the Commission's terms of reference ¹⁷ by replacing the term "Continental Australia" by the word "Australia".

At its 1971st meeting, on 22 July 1975, the Council:

- (a) To designate the organizations invited to participate in the work of the Council in accordance with the decision taken at its fiftieth session, ²⁵ namely, the Council of Europe, the Organisation for Economic Co-operation and Development, the Organization of Petroleum Exporting Countries, and Regional Co-operation for Development, to participate, on a continuing basis, in the work of the Council, under rule 79 of the rules of procedure of the Economic and Social Council;

Recalling, the Lima Declaration and Plan of Action on Industrial Development and Co-operation, 38 which constitute a positive contribution towards the establishment of a new international economic order,

Recalling paragraph 69 of the Lima Declaration and Plan of Action, in which it is recommended that the United Nations Industrial Development Organization should be converted into a specialized agency of the United Nations,

Recalling General Assembly resolutions 2626 (XXV) of 24 October 1970 containing the International Development Strategy for the Second United Nations Development Decade, 3201 (S-VI) and 3202 (S-VI) of 1 May 1974 on the Declaration and the Programme of Action on the Establishment of a New International Economic Order, and 3281 (XXIX) of 12 December 1974 containing the Charter of Economic Rights and Duties of States,

Reaffirming Industrial Development Board resolution 45 (IX) of 30 April 1975 concerning the follow-up of the decisions and recommendations of the Second General Conference of the United Nations Industrial Development Organization, ³⁹

1. Takes note of the report of the Second General Conference of the United Nations Industrial Development Organization, 40 the report of the Industrial Development Board on the work of its ninth session, 41 the report of the Executive Director of the United Nations Industrial Development Organization on measures taken or contemplated by the Industrial Development Board at its ninth session with a view to implementing the Lima Declaration and Plan of Action on Industrial Development and Co-

- 3. Recommends that at its thirtieth regular session the General Assembly examine the possibilities of expanding the areas of agreement with respect to matters dealt with in the Lima Declaration and Plan of Action, with a view to improving the conditions for their earliest implementation;
- 4. Recommends further that adequate resources be provided for the United Nations Industrial Development Organization to enable it to implement the relevant provisions of the Lima Declaration and Plan of Action.

The Economic and Social Council,

Taking into account the importance of natural resources, inter alia, for world economic development,

Noting the great importance of non-fuel minerals such as copper and some others,

Recognizing the importance of training national personnel of the developing countries,

Requests the Secretary-General:

- (a) To co-ordinate and strengthen the research and dissemination of information with regard to projections of supply, demand, consumption and reserves of natural resources, especially in the medium term, drawing upon the work carried out within and outside the United Nations system;
- (b) To ensure that serious attention is given in the next few years not only to oil and gas but also to the problems of the development of alternative sources of energy, both from fossil fuel and renewable sources, which can play an important part in the economic development of all countries, particularly the developing countries, taking into account the environmental aspects of the problem;

- (c) To prepare for the Committee on Natural Resources at its fifth session comprehensive reports on the following:
 - (i) The status of the use of coal, oil shale and geothermal energy in developed and developing countries and of rational measures for expanding the use of those sources of energy;
 - (ii) The dissemination of world experience in the use of fossil coal and oil shale as chemical raw materials and as raw materials for obtaining high-calorie liquid and gaseous fuel;
- (d) To organize an international seminar on the evaluation and working of coal deposits and the planning of mining enterprises for the coal industry within the next few years;
- (e) To submit to the Committee on Natural Resources at its fifth session a comprehensive report containing a 10 to 15-year evaluation of prospects for the development of the raw materials base for the copper industry and also of the demand for copper, including its recycling, which should pay special attention to the evaluation of measures being taken to assist the developing countries in this field; within the limits of available resources, similar studies should be undertaken in relation to other non-ferrous metals.

The Economic and Social Council,

Recognizing the need to find agreement on terminology used in categorizing mineral resources so that there should be comparable and generally agreed statistics,

Having due regard to the work of the International Geological Correlation Programme and the Committee on Storage and Automatic Retrieval of Geological Data of the International Union of Geological Sciences,

- 1. Requests:
- (a) The Centre for Natural Resources, Energy and Transport to review the present definitions and terminology for reserves, production and consumption that are being used in the mineral resources field;
- (b) The Secretary-General to convene afterwards a group of experts selected on an equitable geographical basis to prepare a report recommending a common set of definitions and terminology which might be used internationally for the purpose of reporting to the United Nations on mineral resources;

Taking fully into account General Assembly resolutions 3201 (S-VI) and 3202 (S-VI) of 1 May 1974 containing respectively the Declaration and the Programme of Action on the Establishment of a New International Economic Order.

Fully conscious of the provisions of the Charter of Economic Rights and Duties of States, 44

Recalling paragraph 2 of Council resolution 1911 (LVII) of 2 August 1974,

Bearing in mind the provisions of the Declaration and the Programme of Action on the Establishment of a New International Economic Order and of the Charter of Economic Rights and Duties of States on the principle of permanent sovereignty over natural resources,

- 1. Recognizes the need for the increased use of natural resources by developing countries for their national development;
- 2. Stresses the urgent need for measures to avoid the irrational and wasteful consumption and use of natural resources of all countries, particularly those of developing countries;
- 3. Expresses the conviction that reserves of natural resources should be viewed in a dynamic context in the light of changing technology, scientific advancement and economic structures;
- 4. Asserts the need to take measures to promote the processing of raw materials in the producer developing countries, and to establish appropriate processing arrangements which would allow the fullest benefits to developing countries:
- 5. Considers that there is an urgent need to promote the development and transfer of technology in the field of the production and use of natural resources, in order to accelerate the development efforts of the developing countries:
- 6. Emphasizes the crucial importance of securing a fair and equitable return on natural resources exported in any form by the developing countries;
- 7. Underlines the importance of promoting co-operation among developing countries in the field of natural resources, as provided for by the Programme of Action on the Establishment of a New International Economic Order, within the framework of interdependence and without prejudice to over-all co-operation;
 - 8. Requests the Secretary-General:
- (a) To continue to collect and to provide information on natural resources, including relevant data on processing, transportation and the structure and operations of industries in natural resources sectors;
- (b) To provide assistance to developing countries, at their request, in their efforts to improve data on their

resources and the methodologies necessary for the national forecasting of the supply of and demand for natural resources, and in the formulation of appropriate policies, consistent with the needs of their national development plans;

- (c) To take appropriate action to strengthen and intensify international co-operation by promoting:
 - (i) The organization of specific research and development programmes in developing countries directed towards their energy needs, including the special requirements in rural areas;
 - (ii) The exchange of information between countries on energy research and development, its conservation and greater efficiency in fuel use, and on the nonconventional sources such as solar energy, geothermal energy, wind power, oil shales and biogas;
- (d) To develop and promote the standardization of concepts, terminology and methods of measurement of reserves, supplies and consumption of natural resources, taking into account the special interests of developing countries;
- (e) To examine the problems of natural resources, reserves and supplies in the light of world economic and monetary conditions;
- (f) To work closely with the regional commissions and the United Nations Conference on Trade and Development in complying with this request.

Survey of current problems in the fields of energy and minerals

The Economic and Social Council,

Aware of the urgency of developing alternative sources of energy,

Recognizing the importance of geothermal and solar energy as energy sources which could provide relatively low-cost alternative energy in the short term in various parts of the world,

Recognizing also the important work that is being done through training courses sponsored by the United Nations Educational, Scientific and Cultural Organization and by the Pisa Geothermal Data Bank, in co-operation with the United Nations,

Noting, however, that the development and wider application of geothermal energy is hampered by lack of exploration and of trained personnel,

Further noting that the Council of the newly established United Nations University has decided to include the management and use of natural resources among its initial programme priorities, ⁴⁵

The Economic and Social Council,

Recognizing the increasing need for the strengthening of the voluntary exchange of information on natural resources on a global basis,

Affirming the role of the United Nations as a clearing-house for information on natural resources.

Emphasizing the importance of intensifying the capabilities of the United Nations information services concerning energy, mineral and water resources.

Recalling its resolution 1761 B (LIV) of 18 May 1973.

Bearing in mind that the General Assembly, in its resolution 3345 (XXIX) of 17 December 1974, has requested the Secretary-General to provide facilities for research in related fields and to report on the result of this research on a continuing basis to the Economic and Social Council,

Requests the Secretary-General to submit to it, at one of its sessions in 1976, a proposal for the implementation of the recommendations concerning the intensification of United Nations information services in the natural resources field as agreed upon by the Committee on Natural Resources at its fourth session, ⁴⁶ as well as the implementation of Economic and Social Council resolution 1761 B (LIV), and to indicate the total estimate of funds and manpower resources required for the programme;
- 2. Decides to formulate a programme after its deliberation on the proposal to be submitted by the Secretary-General in accordance with paragraph 1 above.

Recalling General Assembly resolution 3129 (XXVIII) of 13 December 1973 on co-operation in the field of the environment concerning natural resources shared by two or more States, in which the Assembly took note with satisfaction of the relevant parts of the Economic Declaration adopted by the Fourth Conference of Heads of State or Government of Non-Aligned Countries, held at Algiers in September 1973. 47

Recalling also General Assembly resolution 3281 (XXIX) of 12 December 1974 containing the Charter of Economic Rights and Duties of States, in which the Assembly further confirmed the principles stated in its resolution 3129 (XXVIII),

- Requests the Secretary-General to utilize the experience, knowledge and capacity of the Centre for Natural Resources, Energy and Transport and other organizations of the United Nations system having direct interest in the field:
- (a) For assisting the International Law Commission in its study of the law of the non-navigational uses of international watercourses by providing the necessary advice on related technical, scientific and economic problems, so as to enable the Commission to decide on the principles and methods for determining criteria for the equitable sharing of responsibilities and benefits in the management and integrated development of international river basins;
- (h) For co-operating with the United Nations Environment Programme in its implementation of General Assembly resolution 3129 (XXVIII), which should be read in conjunction with General Assembly resolution 3281 (XXIX);
- 2. Requests the Secretary-General to submit the reports on the action taken pursuant to the request in paragraph 1 above to the Committee on Natural Resources at its fifth session;
- 3. Appeals to the International Law Commission to give priority to the study of the law of the non-navigational uses of international watercourses and to submit a progress report to the United Nations Water Conference, which is to take place in 1977.

1956 (LIX). Permanent sovereignty over natural resources

The Economic and Social Council,

Recalling the pertinent provisions of the Declaration and the Programme of Action on the Establishment of a New International Economic Order, ⁴⁸ and of the Charter of Economic Rights and Duties of States, ⁴⁹

Reaffirming the inviolable principle that every State has the right to adopt the economic and social system which it deems most favourable to its development,

Reiterating that the inalienable right of each State to the full exercise of national sovereignty over its natural resources has been recognized by the international community in numerous resolutions of various organs of the United Nations,

- 1. Strongly reaffirms the inalienable right of States to exercise full permanent sovereignty over all their wealth, natural resources and economic activities;
- 2. Reaffirms that the application of the principle of nationalization carried out by States, as an expression of their sovereignty in order to safeguard their natural resources, implies that each State is entitled to determine the amount of possible compensation and the mode of payment, and that any disputes which might arise should be settled in accordance with the national legislation of each State carrying out such measures;
- 3. Also reaffirms the right of all States to associate in organizations of primary commodity producers;
- 4. Considers it to be indispensable for States to regulate and supervise the activities of transnational corporations within their national jurisdiction and to take measures to ensure that such activities comply with their laws, rules and regulations and conform with their economic and social policies;
- 5. Re-emphasizes that actions, measures or legislative regulations applied by States aimed at coercing, directly or indirectly, other States or peoples engaged in the reorganization of their internal structure or in the exercise of their sovereign rights over their natural resources are in violation of the Charter of the United Nations and the principles contained in the Charter of Economic Rights and Duties of States;
- 6. Requests the Secretary-General, in the light of the outcome of the special session of the General Assembly devoted to development and international economic cooperation and of any other relevant developments and taking into consideration the views expressed in the Committee on Natural Resources at its fourth session, to update his recent reports on the subject of permanent sovereignty over natural resources. ⁵⁰

The Economic and Social Council.

Taking into account the importance of co-ordinating the programmes of the United Nations organs and specialized agencies operating in the field of natural resources and with a view to eliminating duplication and wastage of resources and concentrating efforts in the most important directions,

- 1. Recommends that the States members of the Committee on Natural Resources and other States concerned and organizations of the United Nations system operating in the field of natural resources should consider carefully the data compiled by the Secretariat on the work programmes of the United Nations system relating to natural resources and submit to the Secretary-General within one year any specific proposals they may have concerning the improvement of those programmes from the standpoint of their co-ordination and the reallocation of resources;
- 2. Recognizing that the preparation of a more broadly based plan of action will require far-reaching efforts in joint inter-agency programme analysis and planning,

Conscious of the need to overcome as rapidly as possible the constraints on programme planning referred to in the report of the Secretary-General, 53

- 1. Urges all United Nations organs and specialized agencies to co-operate under the auspices of the Economic and Social Council in programming an expanded and joint plan of action for the development of natural resources, based, inter alia, on the "Guidelines for action in the development of natural resources" and on relevant decisions of the United Nations organs and decision-making bodies of related agencies; in order to perform this task, objectives should be defined and programme planning procedures used by the various participating bodies should be reviewed and harmonized;

Noting that dangerous goods account for an increasingly large proportion of international trade,

Conscious that the transport of such goods in complete safety needs to be ensured in a manner which will not hamper either the development of this important trade or the participation of developing countries,

Reaffirming that the intermodal transport of such goods necessitates thorough harmonization of the rules governing the various modes of transport,

Noting the concern expressed by the Committee of Experts on the Transport of Dangerous Goods in its report to the Economic and Social Council pursuant to Council resolution 1743 (LIV) of 4 May 1973,⁶¹ that, when the same problems are considered by different groups, they may be given solutions that are scarcely compatible and that are therefore likely to impede harmonization.⁶²

Taking note of the observations of the Committee of Experts in that report concerning the divergencies currently existing in the modal practices applicable to the transport of dangerous goods in respect of their classification, identification, labelling and packaging and on the steps that should be taken with a view to bringing about uniformity in the various modes of transport,

Considering the work of the Intergovernmental Preparatory Group for a Convention on Intermodal Transport, established in pursuance of Council resolution 1734 (LIV) of 10 January 1973,

Considering also resolution No. I adopted by the International Conference on the Safety of Life at Sea, 1974, with a view to the drafting of a self-contained international convention on the transport of dangerous goods by all modes of transport, as well as the discussions which took place during the eighth session of the Committee of Experts.⁶³

- 1. Requests the Committee of Experts on the Transport of Dangerous Goods, taking into consideration the real capabilities of the developing countries, to pursue its efforts in particular in two areas: that of giving the recommendations of the Committee of Experts 64 more scope and depth and that of strengthening harmonization on the bases that have now been laid;
- 2. Also requests the Committee of Experts to study, in consultation with other bodies concerned, particularly the United Nations Conference on Trade and Development, the Inter-Governmental Maritime Consultative Organization, the International Civil Aviation Organization, the International Air Transport Association and the regional commissions, the possibility of a joint approach to the drafting of an international convention on the transport of dangerous goods by all modes of transport which would take into account the general scope of a future convention on international intermodal transport, and to report to the Economic and Social Council the results of its study;

efforts of the Committee of Experts, in particular by giving appropriate instructions to their representatives on the various bodies concerned at the international or at the regional or subregional level;

Recalling in particular that packaged goods carried by sea and air are normally conveyed by other modes of transport at some stage of their journey and that conflicting requirements hamper trade,

- 1. Recommends that the international organizations concerned should, in drawing up their requirements, take into account the standards recommended by the Committee of Experts on the Transport of Dangerous Goods, with due regard to the needs of other modes of transport concerned;
- 2. Urges Governments of Member States, in the interests of harmonizing packaging requirements, particularly for Classes 3-9 in the recommendations of the Committee of Experts, 68 to accept, as providing an adequate physical standard of safety for journeys to and from airports and seaports, packagings which meet the requirements of the Inter-Governmental Maritime Consultative Organization, the International Civil Aviation Organization or the International Air Transport Association, to the extent that such packagings comply with or exceed the recommendations of the Committee of Experts;

3. Invites Governments of Member States to take appropriate steps for the application of adequate packaaging standards for the carriage of dangerous goods by sea and air, based in principle on the regulations of the Inter-Governmental Maritime Consultative Organization, the International Civil Aviation Organization or the International Air Transport Association, to the extent that such packagings meet or exceed the recommendations of the Committee of Experts.

Taking particular note of the findings of the Meeting of Experts concerning recent changes and trends in public administration and finance in developing countries and its recommendations on the work programme of the Division of Public Administration and Finance for 1976-1977 and the medium-term plan for 1976-1979,71

Recognizing that the further improvement of public administration and finance systems could contribute significantly to the achievement of national objectives under the International Development Strategy for the Second United Nations Development Decade 72 and the Declaration and the Programme of Action on the Establishment of a New International Economic Order, 73

- 1. Requests the Secretary-General, taking into account the needs and experience of developing countries in this particular field, to formulate programmes for the improvement of public administration and finance required to further national development objectives, and to consider the feasibility of measures for forecasting specific public administration and finance objectives for the 1980s and of initiating steps for formulating them;
- 2. Requests the international organizations, and, in particular, the United Nations Development Programme, to support projects in the field of public administration and finance at the national, regional and interregional levels, and measures for the development and dissemination of information on critical problems of public administration and finance in developing countries;
- 3. Further requests that the next Meeting of Experts on the United Nations Programme in Public Administration and Finance review progress in public administration and finance and recommend additional measures appropriate for promoting the establishment of a new international economic order, review the feasibility of the development of pertinent objectives in public administration and finance for the 1980s, and, in the light of the foregoing, review the integrated United Nations programme in public administration and finance.

123 (LIX). Report of the Board of Governors of the United Nations Special Fund

At its 1978th meeting, on 30 July 1975, the Council took note of the report of the Board of Governors of the United Nations Special Fund on the work of its first session ⁷⁸ and decided to transmit it, together with the comments and suggestions made thereon at its fifty-ninth session, to the General Assembly at its thirtieth session.

127 (LIX). Draft provisional agenda and annotations for the third session of the Preparatory Committee for the Special Session of the General Assembly Devoted to Development and International Economic Co-operation

At its 1979th meeting, on 31 July 1975, the Council approved the following draft provisional agenda and annotations for the third session of the Preparatory Committee for the Special Session of the General Assembly Devoted to Development and International Economic Co-operation:

1. Adoption of the agenda

[The dran provisional agenda for the third session was approved by the Economic and Social Council at its 1979th meeting, on 31 July 1975.]

2. Development and international economic co-operation: international trade, international monetary reform and transfer of real resources for financing the development of developing countries, science and technology, industrialization, food and agriculture, and the restructuring of the economic and social sectors of the United Nations system.

[The Economic and Social Council, in its resolution 1980 (LIX), decided that the Preparatory Committee should hold a third session, with a view to finalizing the process of preparations for the special session, in particular by submitting to the General Assembly at its special session proposals that would serve as a basis for negotiations and decisions at that session.

In the same resolution, the Council recommended that the Assembly at its special session should:

- (a) Adopt, on a priority basis, concrete and positive decisions on all issues under the present agenda item which would make a decisive impact on further negotiations within the United Nations, as well as in other international fora, for the establishment of a new international economic order;
- (b) Initiate the process for the restructuring of the United Nations system in the economic and social fields and establish an intergovernmental committee to deal with such issues.]

3. Any other business

[Under this item, the Preparatory Committee may wish to consider and formulate recommendations concerning organizational arrangements for the special session, including recommendations relating to the number and the mandate of the sessional bodies to be set up at that session.]

Adoption of the report of the Preparatory Committee on its third session.

1962 (LIX). Proposal for an international year of the child

The Economic and Social Council,

Taking note of the views concerning an international year of the child contained in chapter VII of the report of the Executive Board of the United Nations Children's Fund 79 and the documents mentioned therein, 80

Recognizing that, in addition to various types of emergency assistance, there is need for a rapid enlargement and permanent improvement of basic services for children

to help to alleviate the chronic conditions of poverty and need which afflict children in many developing countries,

Concerned about the well-being of the child in all its aspects, as well as his human rights and his legal and cultural identity,

Believing that a greatly enhanced awareness in the international community of the situation of children would significantly assist endeavours to meet their needs,

Believing further that an international year of the child, if adequately prepared, supported and financed by Governments and the general public through voluntary contributions, could contribute to strengthening such awareness and lead to appropriate action,

Requests the Secretary-General, in co-operation with the organizations concerned in the United Nations system

and with interested non-governmental organizations, to submit to the General Assembly at its thirty-first session, through the Economic and Social Council at its sixty-first session, bearing in mind the need for government support if such a year is to be productive, a report on measures and modalities for ensuring the adequate preparation, support and financing of an international year of the child, to be preferably the year 1979, to coincide with the twentieth anniversary of the Declaration of the Rights of the Child. 81

1963 (LIX). Technical co-operation among developing countries

The Economic and Social Council,

Recalling the Consensus of 1970'82 and the decision taken by the Governing Council of the United Nations Development Programme at its twentieth session concerning new dimensions in multilateral technical co-operation, 83

Recalling further that by resolution 3251 (XXIX) of 4 December 1974 the General Assembly invited the regional commissions and the participating and executing agencies of the United Nations system to implement the recommendations addressed to them in the report of the Working Group on Technical Co-operation among Developing Countries on its third session, 84

Noting with satisfaction the decision taken at the twentieth session of the Governing Council of the United Nations Development Programme concerning technical co-operation among developing countries, 85

- 1. Requests the Administrator of the United Nations Development Programme, in view of the importance which developing countries attach to technical co-operation activities among developing countries, to integrate these activities in the regular framework of the United Nations Development Programme, and to give them due priority;
- 2. Requests the Administrator of the Programme to carry out further studies, with a view to identifying specific projects of technical co-operation among developing countries at the subregional, regional and interregional levels, through the special unit for co-ordination referred to in paragraph 2 of Assembly resolution 3251 (XXIX), with the object of establishing programmes of technical co-operation among developing countries;
- 3. Further requests that the Administrator of the Programme, for the purpose of achieving a practical applica-

tion of technical co-operation among developing countries, should give special consideration to the recruitment of experts, consultants and contractors from developing countries on a preferential basis in accordance with United Nations practice, and, also on a preferential basis, should purchase necessary suitable and competitive equipment and materials that can be supplied by developing countries;

- 4. Stresses the desirability of the regional intergovernmental meetings on technical co-operation among developing countries, referred to in paragraph 4 of Assembly resolution 3251 (XXIX), being held as soon as possible, and therefore not later than December 1976;
- 5. Looks forward to the further report of the Administrator of the Programme on the question of centralized purchasing and to a subsequent decision by the Governing Council of the United Nations Development Programme thereon, in view of the importance of this question with respect to project implementation;
- 6. Stresses the importance of the recommendations contained in paragraphs 43 to 49 of the final report of the Working Group on Technical Co-operation among Developing Countries, contained in the report of the Working Group on its third session;
- 7. Recommends that the General Assembly should appropriate funds under the regular budget of the United Nations to cover the cost of providing conference servicing facilities for the regional meetings and the intergovernmental regional and global symposia on technical cooperation among developing countries;
- 8. Endorses the decision of the Governing Council that, for the 1977-1981 period, the Programme Reserve shall be used to promote, inter alia, technical co-operation among developing countries, if resources are not available elsewhere. 86

The Economic and Social Council,

Having considered the report of the Executive Board of the United Nations Children's Fund on its session held at United Nations Headquarters from 14 to 30 May 1975. 87

Noting with approval the information provided therein by the Executive Board concerning the activities of the Fund,

Deeply concerned about the serious deterioration in the conditions of life for children and in services on their behalf in many developing countries,

Aware that this deterioration is a matter of grave concern to the conscience of mankind and a serious obstacle to development,

Convinced that a rapid enlargement of basic services for children is feasible and a most effective means for coping with the problem,

- 1. Approves the efforts of the United Nations Children's Fund to draw attention to the situation of children in need for the purpose of enlarging assistance to them through the Fund and through all other organizations in a position to do so;
- 2. Takes note of the resolution of the Executive Board of the United Nations Children's Fund 88 appealing to the General Assembly to give consideration to the situation of children and to the necessary measures for meeting their needs, and requests the Preparatory Committee for the Special Session of the General Assembly Devoted to Development and International Economic Co-operation to recommend such measures as it may deem appropriate;
- 3. Appeals, with a sense of urgency, to all Governments, especially those of the industrialized countries, and other potential contributors to increase their contributions to the Fund, so that it may rapidly augment its assistance to basic services for children.

1965 (LIX). United Nations Revolving Fund for Natural Resources Exploration

The Economic and Social Council,

Considering its resolution 1762 (LIV) of 18 May 1973, the report of the Committee on Natural Resources on its fourth session, 89 in particular chapter III thereof, and the report of the Governing Council of the United Nations Development Programme on its twentieth session, 90 in particular chapter XI thereof,

Reaffirming that the aim of the United Nations Revolving Fund for Natural Resources Exploration is to help the developing countries in their affirmation of their permanent sovereignty over their natural resources,

Taking note of the discussions on this item at its fiftyninth session,

- 1. Reaffirms its resolution 1762 (LIV), particularly paragraph 1 (k) (ii) and (iii), which provides that the United Nations Revolving Fund for Natural Resources Exploration may assist exploration up to and including the stage of feasibility studies;
- 2. Requests the Governing Council of the United Nations Development Programme to reconsider at its twenty-first session the level of contributions to the Fund, in order to allow the Fund to assist exploration up to and including the stage of feasibility studies, in accordance

1966 (LIX). Youth policies and programmes

The Economic and Social Council,

Recalling General Assembly resolutions 3125 (XXVIII) of 13 December 1973 and 3140 (XXVIII) of 14 December 1973,

Taking note with appreciation of the note by the Secretary-General on the feasibility of voluntary contributions in support of United Nations youth programmes, 91

Aware of the increasing difficulties with which millions of young people in many parts of the world are faced as they seek to take constructive roles in the development of their societies,

Believing that the United Nations must intensify its efforts to implement practical programmes to assist young people to take such roles, including the means of financing such programmes,

Acknowledging the role in the achievement of national and international development goals that has been entrusted to the United Nations Volunteers programme, and the potential of that programme for the advancement of youth's role in development,

- 1. Recommends that the General Assembly at its thirtieth session approve the recommendation of the Secretary-General 92 that the United Nations Volunteers programme be designated as the principal operational unit of the United Nations for the execution of youth programmes, especially of pilot projects and training programmes for youth workers, such projects and programmes to be undertaken only after consultation with the Governments of the countries concerned;
- 2. Recommends further that the General Assembly at its thirtieth session approve the expansion of the terms of reference of the Special Voluntary Fund for the United Nations Volunteers to include the receipt of additional contributions for the purposes described in paragraph 1 above;
- 3. Appeals to Governments and other potential sources for contributions to the Special Voluntary Fund, to be used to help to finance United Nations youth programmes sponsored by the United Nations Volunteers programme;
- 4. Requests the Secretary-General and the Administrator of the United Nations Development Programme to hold joint intersecretariat consultations at least once every year to discuss the implementation of programmes to be undertaken as described in paragraphs 1 to 3 above,

- 6. Requests the Secretary-General to submit to the Commission for Social Development at its twenty-fifth session, in 1977, a report on the implementation of the present resolution.

The Economic and Social Council,

Noting the decision in principle taken by the Council of the Food and Agriculture Organization of the United Nations at its sixty-sixth session with a view to holding in 1978 a World Conference on Agrarian Reform and Rural Development 93 and to seeking the association, in this undertaking, of the United Nations and the specialized agencies concerned,

Considering that it would be valuable for the United Nations to be associated with that Conference, if it takes place,

Recalling the resolution on priorities for agricultural and rural development adopted by the World Food Conference,⁹⁴

Considering the resolution on rural development adopted by the International Labour Conference at its sixtieth session, 95

Noting the arrangements made by the Administrative Committee on Co-ordination for carrying out a joint inter-agency planning exercise in rural development, 96

- 1. Requests the Secretary-General of the United Nations, subject to a final decision on convening the planned World Conference on Agrarian Reform and Rural Development, to be ready to co-operate actively with the Director-General of the Food and Agriculture Organization of the United Nations in the preparations for the Conference, and at the same time invites other interested specialized agencies to take part actively in the Conference;
- 2. Invites the Administrative Committee on Coordination to continue joint inter-agency planning relating to rural development aimed at the creation of a joint inter-agency programme, and to include a progress report

in its next annual report to the Economic and Social Council;

3. Requests the Administrative Committee on Coordination to include also in its next annual report to the Council an account of such preparations as may be in progress for the World Conference on Agrarian Reform and Rural Development and of the contribution of the United Nations system to the Conference.

1968 (LIX). Tripartite World Conference on Employment, Income Distribution, Social Progress and the International Division of Labour

The Economic and Social Council,

Considering that article 23 of the Universal Declaration of Human Rights states that everyone has the right to work, to free choice of employment, to just and favourable conditions of work and to protection against unemployment

Taking into account, in accordance with the principles of equity, equality, sovereignty and interdependence, the relationship of the relevant portions of General Assembly resolutions 3201 (S-VI) and 3202 (S-VI) of 1 May 1974 concerning the Declaration and the Programme of Action on the Establishment of a New International Economic Order and of Assembly resolution 3281 (XXIX) of 12 December 1974 containing the Charter of Economic Rights and Duties of States to the serious economic problems afflicting the international community,

Recalling that one of the fundamental aims of international economic and social co-operation is to promote higher standards of living, full employment, and conditions of economic and social progress and development, as stated in Article 55 a of the Charter of the United Nations,

Further recalling that the fight against unemployment is regarded as an urgent task in the Declaration of Philadelphia,⁹⁷

Bearing in mind that the Governing Body of the International Labour Office agreed at its 196th session to convene a Tripartite World Conference on Employment, Income Distribution, Social Progress and the International Division of Labour, which is to meet at Geneva in June 1976.

Stressing that one of the fundamental objectives of United Nations economic and social policy should be to secure full employment in all countries,

Conscious of the need to promote an integral relationship between the social policies of the specialized agencies and a new international economic order,

Recalling that the International Labour Conference adopted at its sixtieth session a declaration on equality of opportunity and treatment for women workers, in which it considered that the establishment of a new international economic and social order in keeping with United Nations resolutions would help to secure better employment opportunities, working conditions and living conditions for women, particularly in the developing countries.

Emphasizing that the items on the agenda of the Tripartite World Conference on Employment, Income Distribution, Social Progress and the International Division of Labour are closely related to the basic topics considered by the Economic and Social Council at its fifty-ninth session,

Realizing the extreme desirability of strengthening cooperation between the various international bodies, with a view to achieving greater efficiency in solving political, economic and social problems, which cannot be dealt with separately but only within a general frame of reference,

- 1. Requests the regional commissions to give the fullest possible co-operation to the International Labour Organisation in the preparations for the Tripartite World Conference on Employment, Income Distribution, Social Progress and the International Division of Labour;
- 2. Further requests the competent bodies of the United Nations Conference on Trade and Development, the United Nations Industrial Development Organization and the specialized agencies, especially the Food and Agriculture Organization of the United Nations, the United Nations Educational, Scientific and Cultural Organization and the World Health Organization, to collaborate with the International Labour Organisation in readiness for their participation in the Tripartite World Conference on Employment, Income Distribution, Social Progress and the International Division of Labour.

1969 (LIX). Food problems

The Economic and Social Council,

Recalling General Assembly resolution 3348 (XXIX) of 17 December 1974, in which the Assembly established the World Food Council,

Bearing in mind the report of the World Food Conference, 98 and the recommendations contained therein,

Expressing concern at the fact that the target of 10 million tons of food grains accepted as the minimum target by the World Food Conference in its resolution XVIII has not so far been attained,

Reaffirming the urgent need to increase the flow of financial and technical assistance for agricultural development and food production in developing countries,

- 1. Takes note of the report of the World Food Council on its first session 99 and transmits it to the General Assembly at is thirtieth session, in accordance with paragraph 7 of General Assembly resolution 3348 (XXIX);
- 2. Appeals to all countries to contribute to the attainment of the target of 10 million tons of food grains set for 1975/76 and to the provision of adequate quantities of other food commodities;
- 3. Urges all donor countries to give high priority to meeting the requirements of the most seriously affected countries in 1975/76;
- 4. Urges also that donor countries should, to the fullest extent possible, accept the concept of the forward planning of "food aid", as recommended in resolution XVIII of the World Food Conference;
- 5. Further urges the early establishment of the International Fund for Agricultural Development, in pursuance of resolution XIII of the World Food Conference;
- 6. Recommends that the Ad Hoc Working Group set up to work out the details of the establishment and operation of the Fund 100 should take into account the special agricultural and food production problems and the particular situation of all the developing countries, and particularly of the least developed among them, in framing the criteria for the utilization of the Fund;
- 7. Further recommends, bearing in mind the need for a small secretariat of high professional competence with an equitable geographical balance, that the General Assembly provide all necessary administrative and budgetary resources required to enable the World Food Council secretariat to discharge effectively the duties which have been entrusted to it.

1970 (LIX). Uses of the sea and coastal area development

The Economic and Social Council,

Recalling its resolution 1537 (XLIX) of 27 July 1970, and its resolution 1802 (LV) of 7 August 1973, in which the Secretary-General was requested to report regularly on developments in the uses of the sea, to undertake a comprehensive interdisciplinary study on the problems of coastal area development and to submit, inter alia, proposals for possible appropriate action at the regional and subregional levels.

Recognizing the increasing importance of marine resources and uses of the sea for the development and wellbeing of nations and the need for regular information about major trends and advances in this field,

Bearing in mind that activities relating to the uses of the sea and the development of coastal areas should not prejudge the outcome of the United Nations Conference on the Law of the Sea,

Mindful of the close interrelationship among the activities taking place in coastal areas and of the need for a comprehensive integrated approach designed to maximize the benefits to be derived from the resources and the uses of these areas, while preserving the coastal environment, in particular the maintenance of the ecological balance,

Noting with approval the results of the first meeting of the Group of Experts on coastal area development, as summarized in the annex to the report of the Secretary-General on coastal area management and development, ¹⁰¹ convened at United Nations Headquarters in November 1974, to assist in the preparation of outline programmes for the integrated development of coastal areas in selected regions,

- 1. Notes with satisfaction the study prepared by the Secretary-General on the uses of the sea ¹⁰² and the report of the Secretary-General on coastal area management and development, ¹⁰³ which were prepared in co-operation with the competent organizations of the United Nations system;
- 2. Endorses the Secretary-General's programme of activities in the field of coastal area development, as outlined in paragraph 56 of his report on coastal area management and development;
- 3. Requests the Secretary-General to submit to the Council, on a regular and continuing basis, pertinent information on the uses of the sea;
- 4. Requests the specialized agencies, the International Atomic Energy Agency and the other United Nations institutions concerned with marine affairs to contribute to the elaboration of further studies by the Secretary-General on marine questions;
- 5. Requests the Secretary-General, in co-operation with the competent organizations of the United Nations system, particularly with the United Nations Environment Programme and the regional commissions, to continue the process of identifying various regions or subregions specially amenable to coastal area management and development, paying attention to the fact that some regions have not been the subject of in-depth study to date, and in this connexion, at the request of Governments concerned, to assist in the elaboration of comprehensive plans of action for such an approach, drawing for this purpose upon the expertise of appropriate organizations within the United Nations system and taking into account the need to avoid duplication of activities;
- 6. Further requests the Secretary-General to take effective measures for the promotion of a better and wider application of marine technology suitable for

developing countries in their endeavours relating to coastal areas, including the provision of assistance in the matter of training, institution-building and the acquisition and implantation of appropriate technology;

- 7. Requests the organizations of the United Nations system concerned and also the regional commissions to give full support to the Secretary-General in implementing programmes for coastal area development as a joint endeavour and to develop further their existing close collaboration, using whenever appropriate established mechanisms of co-ordination;
- 8. Requests the Secretary-General to report to the Council at its sixty-third session on the progress made in implementing the present resolution.

1971 (LIX). Assistance to the drought-stricken areas of Ethiopia

The Economic and Social Council,

Noting with deep concern the persistence of the drought in 11 out of the 14 provinces of Ethiopia,

Further noting the extremely adverse impact of the drought on the growth of the Ethiopian economy in general and on agricultural output in particular,

Appreciating the recent austerity measures introduced by the Ethiopian Government to combat drought,

Recalling General Assembly resolution 3202 (S-VI) of 1 May 1974 on the Programme of Action on the Establishment of a New International Economic Order, particularly section X thereof containing the Special Programme of emergency measures to mitigate the hardships of the developing countries most seriously affected by the economic crisis,

Further recalling resolution 1833 (LVI) of 8 May 1974, by which the Council called upon the Secretary-General to take the necessary action to respond to the request of the Ethiopian Government with regard to the immediate, medium-term and long-term needs of the drought-stricken regions, and resolution 1876 (LVII) of 25 July 1974, by which the Council invited all Member States, international organizations and voluntary agencies to continue to give their fullest support and assistance to the endeavours of the Secretary-General and the United Nations Disaster Relief Co-ordinator in mobilizing emergency relief assistance,

Appreciative of the assistance given to the droughtstricken regions of Ethiopia by Governments, intergovernmental organizations and voluntary agencies,

Noting the efforts made by the United Nations system towards the implementation of the provisions of Council resolutions 1833 (LVI) and 1876 (LVII),

1. Urges the United Nations and its specialized agencies to implement vigorously the provisions of Council resolutions 1833 (LVI) and 1876 (LVII);

- 2. Appeals to the Governments of all Member States and to intergovernmental and non-governmental organizations and voluntary agencies to intensify their assistance to the drought-stricken regions of Ethiopia, in view of the increasing severity of the drought;
 - 3. Decides to keep this matter under review.

1978th plenary meeting 30 July 1975

1972 (LIX). Assistance in cases of natural disaster and other disaster situations

The Economic and Social Council,

Recalling General Assembly resolution 2816 (XXVI) of 14 December 1971 concerning the creation of the Office of the United Nations Disaster Relief Co-ordinator and General Assembly resolution 3243 (XXIX) of 29 November 1974 on the strengthening of the Office of the United Nations Disaster Relief Co-ordinator,

Recalling also Council resolution 1891 (LVIII) of 31 July 1974 on assistance in cases of natural disaster and other disaster situations,

Recalling in particular paragraph 10 of General Assembly resolution 2816 (XXVI) of 14 December 1971, under which limited funds at present included in the regular budget are available to the Co-ordinator for emergency assistance, and General Assembly resolution 3152 (XXVIII) of 14 December 1973 authorizing the Secretary-General, as an interim measure, to draw on the Working Capital Fund up to 1975 for technical assistance to Governments in preparing to meet natural disasters,

Noting with concern paragraphs 12 and 13 of the report of the Secretary-General concerning the Office of the United Nations Disaster Relief Co-ordinator, ¹⁰⁴ in which he refers to the need for taking a decision on funds available to the Co-ordinator's Office from 1976 onwards for emergency assistance to countries stricken by natural disasters and for technical co-operation to prevent and prepare for disasters,

Aware that the Office of the Co-ordinator, in addition to being strengthened as provided for in General Assembly resolution 3243 (XXIX), should be given the requisite means to discharge more effectively its tasks of emergency assistance and technical co-operation,

Recalling once again the adverse effects of disasters on the development process in the countries affected, especially in developing countries,

- 1. Takes note with satisfaction of the report of the Secretary-General concerning the Office of the United Nations Disaster Relief Co-ordinator, and of the activities of the Co-ordinator with respect to natural disasters and other disaster situations;
- 2. Requests that qualitative data necessary for the formulation of an international strategy for the prevention

of disasters should be provided to the international community by bodies competent in this subject;

- 3. Recommends that the General Assembly, at its thirtieth session, consider increasing, within revised limits, the resources available to the Co-ordinator for emergency assistance to countries stricken by natural disasters and for technical co-operation to prevent and prepare for disasters:
- 4. Recommends also that, at its thirtieth session, the General Assembly give urgent consideration to determining the proper source or sources for funding these activities, and suggests, as a possibility, that the existing voluntary trust fund as established under General Assembly resolution 3243 (XXIX) for the strengthening of the Office of the Co-ordinator could also serve as a framework for voluntary contributions from Governments for these purposes;
- 5. Invites Governments of States Members of the United Nations and/or members of the specialized agencies to make contributions to the voluntary trust fund mentioned in paragraph 4 above, in order to permit effective, significant and continuing action by the Co-ordinator to help countries stricken by natural disasters.

1978 (LIX). Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples by the specialized agencies and the international institutions associated with the United Nations

The Economic and Social Council,

Having examined the report of the Secretary-General, ¹⁰⁵ the report of the President of the Economic and Social Council, ¹⁰⁶ and the annual report of the Administrative Committee on Co-ordination for 1974/75 ¹⁰⁷ concerning the item entitled "Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples by the specialized agencies and the international institutions associated with the United Nations",

Recalling General Assembly resolution 1514 (XV) of 14 December 1960 containing the Declaration on the Granting of Independence to Colonial Countries and Peoples, and all other resolutions adopted by United Nations bodies on this subject, including in particular General Assembly resolution 3300 (XXIX) of 13 December 1974 and Council resolution 1892 (LVII) of 1 August 1974,

Taking into account the statements made by the Chairman of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples at the fifty-ninth session of the Council, ¹⁰⁸

Gravely concerned that millions of people are still living under oppressive colonial and alien domination and conscious of the critical need of these peoples and their national liberation movements for concrete assistance from the specialized agencies and the international institutions associated with the United Nations in their struggle for liberation from colonial rule and in their efforts to consolidate their national independence,

Reaffirming the responsibility of the specialized agencies and other organizations within the United Nations system to take all effective measures, within their respective spheres of competence, to ensure the full and speedy implementation of the Declaration and other relevant resolutions of United Nations bodies, particularly in the provision of moral and material assistance, on a priority basis, to the peoples of the colonial territories and their national liberation movements.

Aware that, although considerable progress has been made in the extension of assistance to refugees from the colonial territories in Africa, mainly through the efforts of the United Nations High Commissioner for Refugees, the action taken hitherto by the organizations concerned in the provision of assistance to the peoples of the territories through their national liberation movements continues to remain inadequate to meet the urgent needs of those peoples,

Noting with satisfaction the measures initiated by some of the specialized agencies and other organizations within the United Nations system, in particular the World Food Programme and the United Nations Development Programme, to provide assistance on a priority basis to the peoples of the territories formerly administered by Portugal, and expressing its appreciation to the Secretary-General for the initiative he has taken in that regard,

Expressing its appreciation to the General Secretariat of the Organization of African Unity for the continued co-operation and assistance extended by it to the organizations within the United Nations system in connexion with the implementation of the relevant resolutions of the United Nations,

- 1. Takes note of the report of the President of the Economic and Social Council and endorses the observations and suggestions contained therein;
- 2. Reaffirms that the recognition by the General Assembly, the Security Council and other United Nations organs of the legitimacy of the struggle of colonial peoples to achieve freedom and independence entails, as a corollary, the extension by the United Nations system of organizations of all the necessary moral and material assistance to the peoples of the colonial territories and their national liberation movements;
- 3. Expresses its appreciation to those specialized agencies and organizations within the United Nations system which have continued to co-operate in varying degrees with the United Nations in the implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples and other relevant resolutions of the United Nations, and urges all the specialized agencies and other organizations within the United Na-

tions system to accelerate the full and speedy implementation of the relevant provisions of those resolutions;

- 4. Requests the specialized agencies and other organizations within the United Nations system to render or continue to render, as a matter of urgency, all possible moral and material assistance to the colonial peoples in Africa struggling for their liberation from colonial rule and, in particular, recommends that the organizations concerned should initiate or broaden contacts and cooperation with these peoples, in consultation with the Organization of African Unity, and should work out and implement concrete programmes for such assistance with the active collaboration of the national liberation movements concerned:
- 5. Urges the specialized agencies and other organizations within the United Nations system to extend all moral and material assistance to the newly independent and emerging States:
- 6. Requests the specialized agencies and other organizations within the United Nations system, in accordance with the relevant resolutions of the General Assembly and the Security Council, to continue to take all necessary measures to withhold any financial, economic, technical or other assistance from the Government of South Africa and the illegal régime in Southern Rhodesia, to discontinue all support to them until they restore to the peoples of Namibia and Zimbabwe their inalienable right to self-determination and independence, and to refrain from taking any action which might imply recognition of the legitimacy of the domination of the territories by those régimes;
- 7. Notes with satisfaction the arrangements made by several specialized agencies and organizations enabling representatives of the national liberation movements recognized by the Organization of African Unity to participate fully as observers in their proceedings relating to the countries concerned, and calls upon those organizations which have not yet done so to make such arrangements without delay, including provision for the payment of travel and other related expenses incurred in connexion with the participation of representatives of the national liberation movements in such proceedings;
- 8. Invites all Governments to intensify their efforts in the specialized agencies and other organizations within the United Nations system of which they are members to ensure the full and effective implementation of the Declaration and other relevant resolutions of the United Nations and, in that connexion, to accord priority to the provision of adequate resources for the desired programmes of assistance to the peoples in the colonial territories and to their national liberation movements;
- 9. Urges the executive heads of the specialized agencies and other organizations within the United Nations system, with a view to facilitating the implementation of the provisions of paragraph 8 above, to formulate and submit to their respective governing bodies or legislative organs, as a matter of priority and with the active cooperation of the Organization of African Unity, concrete proposals for the full implementation of the relevant

United Nations decisions, in particular specific programmes of all possible assistance to the peoples in the colonial territories and their national liberation movements.

- 10. Draws the attention of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples to the present resolution and to the discussions on the subject at the fifty-ninth session of the Council;
- 11. Requests the President of the Economic and Social Council to continue consultations on this matter with the Chairman of the Special Committee and to report thereon to the Council;
- 12. Decides to keep this question under continuous review.

1979 (LIX). Preparatory work for the United Nations Water Conference

The Economic and Social Council,

Recalling its resolution 1761 C (LIV) of 18 May 1973,

Taking note of chapter IV of the report of the Committee on Natural Resources on its fourth session, which contains the comments made by members of the Committee at that session,

- 1. Decides to authorize the Committee on Natural Resources to act as the preparatory committee to assist the Secretary-General in the preparation and organization of the United Nations Water Conference;
- 2. Approves the revised provisional agenda for the United Nations Water Conference contained in the annex to the progress report of the Secretary-General, 110

based on the agenda proposed in the report of the Intergovernmental Panel of Specialists,¹¹¹ on the understanding that the provisional agenda should be finalized by the Committee on Natural Resources, acting as the preparatory committee for the Conference;

- 3. Emphasizes the importance of regional meetings as part of the preparatory process for the United Nations Water Conference, as outlined in the progress report of the Secretary-General and, to this end, requests the regional commissions to hold the regional meetings before the end of 1976;
- 4. Decides to convene the United Nations Water Conference in Argentina from 7 to 18 March 1977;
- 5. Requests the Secretary-General to ensure, throughout the process of the preparatory work for the United Nations Water Conference, full co-ordination with the preparatory work for the United Nations Conference on Desertification, in order to ensure the appropriate contributions by the Water Conference to the Conference on Desertification;
- 6. Recommends that the Governments which have not yet done so should start the preparation of their contribution to the United Nations Water Conference, which could include, if they deem it necessary, the establishment of national water conference committees;
- 7. Requests the Secretary-General to continue with the preparation for the United Nations Water Conference as suggested in his progress report, in close co-operation with the specialized agencies concerned, the regional commissions and organs of the United Nations, together with intergovernmental and international non-governmental institutions in a position to contribute to the preparations for that Conference, and to submit a report on the progress accomplished to the Committee on Natural Resources, acting as the preparatory committee for the Conference.

(c) Recommend that the General Assembly should authorize the United Nations Fund for Population Activities to convene a pledging conference in 1976, in conformity with the decision taken by the Governing Council of the United Nations Development Programme, acting as the governing body of the Fund, at its 482nd meeting in the course of its twentieth session.¹¹⁷

118 (LIX). Reconstitution of the United Nations/FAO Intergovernmental Committee of the World Food Programme as a Committee on Food Aid Policies and Programmes

At its 1978th meeting, on 30 July 1975, the Council took note of, and decided to recommend to the General Assembly the adoption of, the following draft resolution:

"The General Assembly,

"Recalling its resolution 3348 (XXIX) endorsing the resolutions of the World Food Conference,

"Considering that paragraph 6 of resolution XXII of the World Food Conference recommended that the United Nations/FAO Intergovernmental Committee of the World Food Programme be reconstituted, so as to enable it to help to evolve and co-ordinate short-term and longer-term aid policies recommended by the World Food Conference,¹¹⁹

"Recalling the resolutions 120 setting up the World Food Programme as a programme undertaken jointly by the United Nations and the Food and Agriculture Organization of the United Nations and establishing, for the purpose of providing guidance on policy, administration and operations, an Intergovernmental Committee of twenty-four members elected half by the Council of the Food and Agriculture Organization of the United Nations and half by the Economic and Social Council,

"Concurring with the proposals made, on the recommendation of the Intergovernmental Committee, by the Council of the Food and Agriculture Organization of the United Nations at its sixty-sixth session and the Economic and Social Council at its fifty-ninth session, to reconstitute the Intergovernmental Committee so as to ensure the effective evolution and co-ordination of multilateral, bilateral and non-governmental food aid programmes, in the light of the recommendations set forth in resolution XVIII of the World Food Conference,

"Desirous at the same time of maintaining as much as possible the established rules and procedures relating to the operation of the World Food Programme,

- "1. Decides that the United Nations/FAO Intergovernmental Committee of the World Food Programme shall be reconstituted as the Committee on Food Aid Policies and Programmes (hereinafter referred to as 'the Committee'), which shall comprise 30 States members of the Food and Agriculture Organization of the United Nations or States Members of the United Nations, 15 of these members to be elected be the Economic and Social Council and 15 by the Council of the Food and Agriculture Organization of the United Nations, it being understood that outgoing members shall be eligible for re-election;
- "2. Resolves that States already elected as members of the United Nations/FAO Intergovernmental Committee of the World Food Programme, pursuant to the provisions of previous resolutions, shall continue as members of the Committee for the remainder of their respective terms, and requests the Economic and Social Council and the Council of the Food and Agriculture Organization of the United Nations to elect three additional members each, one member each for a term of one year, one member each for a term of two years and one member each for a term of three years; 121
- "3. Decides that thereafter all members of the Committee shall be elected for a term of three years, and requests the Economic and Social Council and the Council of the Food and Agriculture Organization of the United Nations to make such provisions as will ensure that the terms of office of five members elected by each of the two Councils shall expire in each calendar year;
- "4. Requests the Economic and Social Council and the Council of the Food and Agriculture Organization of the United Nations, when they elect members of the Committee, to take into account the need for the balanced representation of economically developed and developing countries and other relevant factors, such as the representation of potential participating countries, both contributing and recipient, equitable geographical distribution, and the representation of both developed and developing countries having commercial interests in international trade in foodstuffs, especially those highly dependent on such trade;

- "5. Further decides that, in addition to discharging the functions hitherto exercised by the Intergovernmental Committee, the Committee shall help to evolve and coordinate short-term and longer-term food aid policies recommended by the World Food Conference, and shall, in particular:
- "(a) Provide general guidance on the policy, administration and operation of the World Food Programme;
- "(b) Provide a forum for intergovernmental consultations on national and international food aid programmes and policies;
- "(c) Review periodically general trends in food aid requirements and food aid availabilities;
- "(d) Recommend to Governments, through the World Food Council, improvements in food aid policies and programmes on such matters as programme priorities, commodity composition of food aid and other related subjects;
- "(e) Formulate proposals for the more effective coordination of multilateral, bilateral and non-governmental food aid programmes, including emergency food aid;
- "(f) Review periodically the implementation of the recommendations made by the World Food Conference on food aid policies;
- "6. Decides also that the Committee shall report annually to the Economic and Social Council and the Council of the Food and Agriculture Organization of the United Nations, which, in considering the reports of the Committee, shall take into account the responsibilities of World Food Council, and that the Committee shall submit periodic and special reports to the World Food Council;
- "7. Resolves that the Committee should normally hold regular sessions twice a year and such special sessions as it considers necessary or as called for by the Secretary-General of the United Nations and the Director-General of the Food and Agriculture Organization of the United Nations, in consultation with the Executive Director of the World Food Programme, or on request submitted in writing by at least one third of the members of the Committee;
- "8. Resolves further that the Committee shall be serviced by the Executive Director of the World Food Programme, acting in consultation with the Secretary-General of the United Nations and the Director-General of the Food and Agriculture Organization of the United Nations, and that in this respect the Executive Director shall be guided by the relevant provisions of the General Regulations of the World Food Programme, and in particular shall continue to rely to the maximum extent possible on the technical services of the United Nations and its subsidiary bodies, the Food and Agriculture Organization of the United Nations and other organizations of the United Nations system, without any duplication of such services:
- "9. Calls upon the Committee to adopt its own rules of procedure, which shall be based on the rules of procedure hitherto applicable to the Intergovernmental

- Committee, and to make provision for inviting States Members of the United Nations or members of the Food and Agriculture Organization of the United Nations that are not members of the Committee to participate in its deliberations;
- "10. Authorizes the Committee to establish such subsidiary bodies as may be necessary to enable it to discharge its functions;
- "11. Resolves that the appointment of the Executive Director and the administration, procedures, financing and other working arrangements of the World Food Programme should continue to be governed, mutatis mutandis, by the 'World Food Programme Basic Documents'."

119 (LIX). Amendement to General Regulation No. 6 of the General Regulations of the World Food Programme

- At its 1978th meeting, on 30 July 1975, the Council decided to amend General Regulation No. 6 of the General Regulations of the World Food Programme, the revised text 122 to read as follows:
- "6. A portion of the resources of the Programme will be reserved each year for use by the Director-General of the Food and Agriculture Organization of the United Nations for emergency food needs. The amounts to be reserved will be determined by the Intergovernmental Committee from time to time, in accordance with changing circumstances. In cases of special need, the Intergovernmental Committee may, at the request of the Executive Director, in consultation with the Director-General of the Food and Agriculture Organization of the United Nations, allocate further amounts for use by the Director-General to meet emergency food requirements. Any unused balance of the emergency allocation will return to the general resources of the Programme at the end of each year."

120 (LIX). Harmonization of programme budget presentation and co-ordination within the United Nations system

At its 1978th meeting, on 30 July 1975, the Council:

- (a) Decided to request the Administrative Committee on Co-ordination to report on the progress made by the inter-agency task force working towards the harmonization of the programme budget presentation;
- (b) Decided to endorse the initiative of that Committee in regard to the harmonization of the budget presentation and to urge the organizations and programmes concerned in the United Nations system to seek every feasible means of harmonizing programme budgets and medium-term plans, giving special attention to the comparability of programme narratives;
- (c) Decided to review at its sixty-first session the comments of other interested bodies on the recommenda-

- (e) Took note with appreciation of the annual report of the Administrative Committee on Co-ordination for 1974/75 ¹²⁵ and the reports of the specialized agencies ¹²⁶ and the International Atomic Energy Agency, ¹²⁷ submitted to the Council at its fifty-ninth session.

Third session of the Preparatory Committee for the Special Session of the General Assembly Devoted to Development and International Economic Co-operation, and meetings of Working Group II of the Committee for Development Planning, and of the Working Group on Oceanography and Data Exchange of the Intergovernmental Oceanographic Commission

At its 1979th meeting, on 31 July 1975, the Council decided:
